Learning objectives

At the end of the course, the student must have acquired:

- Knowledge and understanding of the relationship between legal norms, social norms and context, with particular reference to fundamental rights.
- Ability to apply the notions learned to the analysis of concrete situations, with particular reference to the possible conflict between legal norms and social norms.
- Autonomy of judgment in the interpretation of the norms and in the identification of the most appropriate legal solutions.
- Communication skills in the presentation and discussion of socio-legal topics, both in written and oral form.
- Ability to learn independently, with particular reference to the identification of the most appropriate legal sources and documentary sources for the analysis of concrete situations that highlight a conflict between the formal level and the substantial level of the affirmation of fundamental rights.

The course aims to offer, on the one hand, the basic theoretical notions for a critical and analytical approach to the study of law and, on the other hand, a deeper evaluation of some special topics, with particular regard to the social aspects of fundamental rights.

Prerequisites

Recommended to students in their third, fourth and fifth year of studies.

Teaching methods

The lessons will be held in person, in a delivery and interactive mode, in Italian.

In particular, the following are planned:

8 two-hour lessons in delivery mode, in presence, in Italian

16 two-hour lessons in interactive mode, in presence, in Italian.

Assessment methods

Final oral exam on the topics covered in class, subject of the reference texts. There are no intermediate tests and written tests.

In the evaluation of the candidates, the ability to present, the understanding and application of the notions learned during the course and/or in the reference texts, the autonomy of judgment and critical skills, the propriety of language will be considered.
