## SYLLABUS DEL CORSO

### Elementi di Diritto Processuale Civile

#### Learning objectives

a) Knowledge and understanding

The student will acquire a solid knowledge of the fundamentals of civil procedural law, including its basic principles, prerequisites, methods, and limits of exercising judicial protection.

b) Applying knowledge and understanding

The student will be able to apply the acquired knowledge to analyze and solve procedural problems posed by concrete cases.

c) Making judgements

The student will develop the ability to critically interpret and evaluate the implications of procedural choices, formulating independent judgments on the effectiveness of various strategic options.

d) Communication skills

The student will be able to communicate their knowledge of civil procedural law clearly and precisely, using appropriate technical-legal language.

e) Learning skills

The student will develop the learning skills necessary to meet the demands of the work context and/or to undertake advanced studies.

#### Contents

Elements of Civil Procedural Law: study of the basic principles of civil procedure.

#### Detailed program

Civil procedure is a set of rules that govern the litigation (and the way to dispose of) a civil case. This course

introduces students to the language and to the most important issues related to conflict resolution, including, inter alia, actions that may be taken, jurisdiction over the parties, discovery, and jurisdictional remedies. It provides students with an opportunity to first look at the whole Italian procedural system, as well as to examine the relationship between procedural and substantive law, developing problem-solving capabilities.

## **Prerequisites**

Basic knowledge of the Italian Constitution and the Italian private law, in compliance with the prerequisites provided (prerequisite exams).

## **Teaching methods**

Each lesson consists of a first part in the form of traditional lectures, followed by a second, interactive part with discussion of legal problems and exercises on practical cases.

Three or four sessions will be dedicated to written exercises; the relevant dates will be published on the e-learning platform.

Students will have the opportunity to take a partial written exam, which will be held in November. The exact date will be set at the beginning of the course and announced on the e-learning platform. Those who successfully pass this exam will be allowed to take the final exam, bringing only the materials specified by the professor.

## **Assessment methods**

Oral exam to evaluate:

- a) the acquired skills;
- b) the ability to present concepts and rules using correct technical terminology;
- c) the effective understanding of procedural legal concepts and the ability to reason about problems, including through case-based questions;
- d) the ability to place procedural legal concepts in the context of the system

Written exam: scheduled around mid-November, containing open-ended questions. Those who pass the written exercise will be able to take the oral exam on the remaining part of the study program only.

The oral exam may be preceded, for students who wish to do so, by a group project work, or the analysis of a case or decision, which will be assigned by the professor and evaluated for the purposes of the exam.
