## SYLLABUS DEL CORSO

### Diritto degli Scambi Internazionali - 1

#### Learning objectives

The course aims at providing students with a basic knowledge of the legal structure of the multilateral trading system, of the main principles governing the International markets of goods and services and of international investment law.

#### Contents

The course provides students with an introduction to the multilateral trading system. Study will focus on trade agreements administered by the World Trade Organization. Its evolution will be exposed, together with its basic principles and rules relating to the markets of goods, services and intellectual property rights. Particular attention will be placed in dealing with the relationship between the liberalization of trade and services' flows and the policy space maintained by WTO's Member States to pursue non trade values such as human rights, social rights, the environment, public health and development. An overview of the WTO's dispute settlement mechanism will allow students to assess how effective the system can be deemed. A discussion on the impact of the 2007-2008 financial crisis, COVID-19 and war in Ukraine on trade and on the capacity of the WTO system to restrain the raise of protectionism will introduce a final reflection on the future of the Organization, which appears challenged by the ever more frequent turn of its Members towards the conclusion of regional and preferential agreements and by the hostility of the United States towards multilateralism during the Trump Administration.

Basic rules on international investment law.

#### Detailed program

- Introduction to the liberalization of international trade and the actors of economic globalization.

- The multilateral trading system: origin and institutional structure of the WTO.
- Trade liberalization in the goods' market and "new generation" trade treaties.
- Recently liberalized areas: a) the Agreement on services; b) the TRIPs' regime for intellectual property rights.
- Multilateral agreements on dumping and subsidies.
- WTO's disputes resolution system and the effects of WTO's rules in the EU
- International trade, business and human rights.
- Basic rules on international investment law

## **Prerequisites**

## **Teaching methods**

Lectures/case law analysis

Frontal teaching (DE): frontal lesson/seminar. Some topical issues may be discussed in seminars held by experts in the sector.

Self-learning methods: during the lessons, tools that allow the student to continuously update the knowledge learned will be presented (course on legal research held by the university library, digital platforms, podcasts, specialized journals, European institutional pages). Occasionally, students will be required to read scientific/divulgative articles on topics related to the programme and discuss them during the lesson.

## **Assessment methods**

No ongoing assessment is foreseen during the course.

The exam is oral and consists of open questions on the topics covered in class aimed at checking the knowledge of the program and the ability to critically examine the topics covered.

All students will be admitted to an optional final written exam (open questions) based on open questions and case resolution on the basis of the principles studied during the course.

The commission will evaluate the degree of knowledge of the program, according to criteria of completeness of knowledge, appropriate use of legal language, critical thinking skills in the exposition of issues.
