# **Diritto del Turismo**

## Learning objectives

The course aims to explore the private law aspects of tourism law and the relationships between travelers and tourism operators, integrating theoretical knowledge with practical skills from an interdisciplinary perspective. Through the study of legal sources and the analysis of practical cases, the course seeks to develop the critical and interpretative abilities needed to address the legal issues of the tourism sector in both national and international contexts.

Specific Objectives:

Acquisition of fundamental knowledge of tourism law: Understand the main legal sources governing the tourism sector (national, European, and international).

Analyze the general principles of law as applied to tourism: legal definitions of tourist, tourism operator, and tourism activity.

Understanding typical contracts in the tourism sector: Study in depth the regulation of tourism-related contracts (package travel, travel, transport, and accommodation contracts).

Examine civil liability and legal protections in cases of non-performance or service disruptions.

Development of interpretation and application skills in legal norms: Practice analyzing real cases and drafting legal opinions in the tourism field.

Enhance the ability to identify regulatory issues and propose legally sound solutions.

In-depth study of consumer-tourist protection: Understand the legal protection mechanisms available to tourists as consumers (information rights, withdrawal, compensation, alternative dispute resolution).

Analyze relevant case law and the main tools for out-of-court protection.

#### **Contents**

Through the analysis of the most significant National and European decisions, the aim of the module shall be the study of the sources of tourism law; of the entities and operators involved in the touristic activities; of the touristic contracts; entities which offer accommodation services; mooring and pleasure yachting contracts; air and maritime carriage; contractual liability and dispute resolution methods.

# **Detailed program**

- 1. The sources- European law of tourism International conventions on tourism
- 2. The players of the touristic activity The traveller; the Tour Operator; Travel Agencies; Touristic Organizations
- 3. Touristic Contracts Contracts of carriage; Denied boarding, Cancellation and delay; Cruise contracts; Voyage Contract; Packages; Booking; Accommodation; Bailment and deposit in Hotel.
- 4. Pleasure yachting contracts
- 5. Civil Liability and touristic activity Contractual liability;
- 6. Tort liability;
- 7. Ruined vacation damage

#### **Prerequisites**

Knowledge of the concepts of contract and liability

## **Teaching methods**

Classic lessons in presence. The course will also feature the participation of tourism industry professionals who will hold seminars during the lessons.

#### **Assessment methods**

Students attending the course: oral exam based on the issues taught in classroom

Students not attending: oral exam based on the materials indicated below

Each question (3) is evaluated in thirtieths. The average of the votes between the two modules constitutes the final grade of the teaching.
