Course title

Origins of human rights and the idea of public happiness in early modern times

Topics and course structure

The course is in Italian. It is focused on social, political and cultural history in early modern times (late 15th century to early 19th century). The course offers both a detailed introduction to the course of events in this period (in Europe and the world) and an in-depth analysis of a monographic subject, always selected among those which are more generally relevant to modernity, that is, to present day concerns. The purpose is to promote the knowledge and understanding of this historical period. A further general purpose is to develop intellectual and cultural tools for a better understanding of past and present society.

Objectives

Students will familiarize with 1) the basic chronologies and historical facts of early modern times; 2) historiographical terms; 3) methods of critical analysis of historiography.

Core skills (according to Dublin Descriptors):

Developing historical awareness and knowledge, as a means of knowing and measuring social and political reality (Knowledge and Understanding);

Developing independent judgement, through critical analysis and the integration of sources and information (Making Judgements);

Developing the ability to identify and communicate problems and ideas (Communication Skills).

Methodologies

Lectures (in Italian) plus collective discussion on sources or documents and presentations (20% max). In person.

Online and offline teaching materials

Presentations, documents and recordings of the lectures will be uploaded (after each lecture) during the course.

Programme and references

Students will be conversant with the subjects treated in the lectures and read two books. Required reading:

Assessment methods

No tests during the course. An optional written test will be available at the end of the course and can be taken instead of the ordinary written exam. The exam includes 1) a written test, an examination mode that was chosen because it ensures an objective assessment of the knowledge the student has attained (knowledge of facts and methodologies); 2) an optional oral test.

a) The written test (100 minutes) includes 15 multiple-choice questions on the Early modern History textbook (one correct answer= 1 point) and three open-ended questions, two on subjects treated in the lectures and one on one of the short texts read together in workshops (each answer, a brief essay, is rated from 0 to 5 points). Recordings of the lectures and slides will be available in the website of the course.

b) The optional oral test is on a book chosen from the monographs listed above in the Syllabus (interview rated 0 to 5 points, to be added to the written paper grade). This conversation allows students who are particularly interested

in the subject to exercise critical analysis and communication skills.
