Learning objectives

Knowledge and understanding

Provide a good knowledge of the institutions of public law most directly related to economic dynamics, with a careful look also at European and supranational dynamics

Applying knowledge and understanding

Develop the approaches and methodologies of legal analysis of public economic law

Making judgements

During the lessons, students will be gathered in groups to discuss cases. This will allow to develop the critical and judgment skills of the students, called to verify the concrete application of the theoretical institutions

Communication skills

The stimulus to comparison and the organization in groups to examine the cases will facilitate the ability to communicate what has been learned

Learning skills

During the lessons, students will be called to study some cases discussed in class, in order to enhance their learning ability and to continue studying independently

Contents

The course will be structured in three main parts. The first part includes the reconstruction of the Italian constitutional order, starting from the system of sources of law and analyzing the form of government and the guarantee institutions. The second part is dedicated to the "economic constitution", ie the principles and rules that the Constitution, within the framework of the European Treaties, dedicates to the economic factor understood in its complexity. Finally, the third part focuses on administrative action, with particular reference to the various dimensions in which the State interacts with the economic sphere: producer of services or economic activities; financier; regulator of private economic activity.

Teaching methods

The course consists of 72 hours, of which:

- DE: 51 hours consisting of face-to-face lessons and 9 hours remote
- DI: 12 hours of case discussions, in person, through the formation of student groups, and in-depth seminars

Assessment methods

The exam is oral, on the topics covered in class and in the textbook.

Attending students will be offered the opportunity to participate in two written tests (one intermediate, the other at the end of the course).

The commission will evaluate the degree of knowledge, appropriate use of legal language, critical capacity in the exposition of issues.
