# **Media Law and Computer Law**

### Learning objectives

Students will acquire:

- Knowledge of media law, internet law and computer crime law
- Ability to apply the notions learnt to the analysis of concrete cases and in the resolution of legal problems related to media activity
- Autonomy of judgement in the interpretation of rules and in the identification of the most appropriate legal solutions
- · Communication skills in the presentation and discussion of legal arguments, both in written and oral form
- Ability to learn independently, also by consulting normative, doctrinal and jurisprudential sources

#### **Contents**

The course is divided in two parts: the first part is focused on the relevant principles of constitutional and public law (division of powers, law's sources, judiciary and protection of rights), freedom of speech, media law, internet law, privacy, copyright and advertising. In the second part, the basics of criminal laws are explained, and the laws regarding computer crimes in the Italian criminal law are analysed.

### **Detailed program**

Part One

1. Introduction to public and constitutional law: the Constitution, the division of the powers, the judiciary, the Constitutional Court, national and international protection of human rights.

- 2. The freedom of speech (art. 21 Const.): constitutional and supranational regulation; restrictions; right to inform, right of criticize, freedom of satire.
  - 3 The right to privacy.
- 3. The regulation of the media: the press.
  - 5 The regulation of the media: the Internet.
- 4. Hate speech.
- 5. Advertising law.
- 6. Copyright law.

#### Part Two

- Introduction to Italian Criminal Law.
- Definition of computer crime.
- Computer frauds.
- Computer damage.
- Trafficking of computer viruses.
- Unauthorized access to a computer system.
- Trafficking of access codes.

# **Prerequisites**

Basic knowledge of Italian legal language.

## **Teaching methods**

In-person lectures with interactive discussion of practical cases

#### **Assessment methods**

The exam consists of two written tests, one for each part.

Each test consists in open questions on the subjects illustrated during the course and on reference text. It is evaluated in thirtieths.

The final grade is the average of the grades in each test. In each test students must get at least the grade if 18/30.
