# Learning objectives

Learning Objectives of the Course in Constitutional Law

#### 1. Knowledge and understanding

By the end of the course, students will have acquired a solid knowledge of the Italian constitutional system, with particular reference to the structure of the Constitution, the form of government, the protection of fundamental rights, and the organization of public powers. They will also be able to critically understand the historical and jurisprudential development of the subject, including in light of European Union law and its interaction with the national legal order.

## 2. Applying knowledge and understanding

Students will be able to analyze and resolve both simple and complex legal cases related to constitutional law, including through the interpretation of legal texts and decisions of the Constitutional Court. They will be able to apply theoretical knowledge to assess the constitutional legitimacy of legal acts and to construct coherent legal reasoning.

## 3. Making judgements

Students will develop the ability to formulate autonomous and well-reasoned judgments on constitutional issues, critically assessing the adequacy of legislative and jurisprudential solutions. They will be able to distinguish between alternative interpretations, arguing their preference based on constitutional principles, and understand the ethical and institutional implications of normative choices.

#### 4. Communication skills

Students will be able to clearly and accurately express the fundamental concepts of constitutional law, using appropriate legal terminology. They will be able to present complex legal arguments both orally and in writing, adapting their communication style to different audiences (academic, professional, institutional).

#### 5. Learning skills

Students will develop the methodological tools necessary to independently study and deepen their

understanding of constitutional sources, case law, and legal scholarship. They will gain awareness of the need for continuous updating and will be able to pursue further study of the subject independently, including in advanced academic or professional contexts.

#### **Contents**

The knowledge of Constitutional Law is essential to understanding the foundations of the Italian Law and it is the introduction to the are juridical subjects.

The course has the main purpose the study the constitutional system, through the examination of the Italian Constitution in its wording and interpretations developed by the case law and practice.

Particular attention will be paid to the historical evolution, in comparison with other democratic systems, the fundamental principles, freedoms of individuals, the sources of law, the Government, the role of the Judiciary and of the Constitutional Court and the relations between the Italian legal system and the European legal system.

# **Teaching methods**

Lectures. The course will be delivered in 36 lectures of 2 hours each delivered in face-to-face delivery mode. If necessary, 2 lectures of 2 hours each may be delivered in asynchronous remote delivery mode (recorded lectures), at the discretion of the lecturer, to cope with exceptional situations and in order to ensure the continuity of teaching activities. More details will be provided during the semester.

#### Assessment methods

The exam is oral

Before the oral exam, a test of thirty multiple choice questions will be held. For each question, only one answer will be correct, while the other two will be incorrect.
