## SYLLABUS DEL CORSO

#### Learning area

Models and techniques for treatment and rehabilitation

#### Learning objectives

##### *Knowledge and understanding*

- Acquisition of the historical bases on the establishment of the profession of psychologist and the approval of the deontological code of Italian psychologists
- Basic legal and theoretical notions of deontology and civil and penal legislation concerning the profession of psychologist.

##### *Applying knowledge and understanding*

- Methods for the correct drafting of reports requested by customers and/or customer consultants

##### *Making Judgements*

During class hours, students will be involved in the analysis of real cases, carried out in small groups, in order to develop critical thinking skills on possible operational choices and, in particular, on the implications and consequences of decisions made in the professional sphere.

##### *Communication skills*

Communication skills will be developed through 1. writing essay based on scientific papers and 2. oral discussions about group work assigned during class time. The essay allows students to improve the use of a register, that must be technical and at the same time clear and usable also to non-expert users. Class time discussions instead promote peer exchange and the internalization of the language shared between colleagues.

### *Learning skills*

Will be presented tools and resources, including those of an institutional nature, that are fundamental and indispensable elements to ensure ethically and scientifically grounded professional practice: peer-to-peer discussion, continuing education and clinical supervision.

## **Contents**

The course will illustrate the meaning and function of the code of ethics by analyzing the main legal and ethical rules that guide the psychologist in managing the relationship with the client, the non-compliance of which can be a source of professional liability in the disciplinary, civil and criminal fields.

The laboratory mainly focuses on the discipline of the "care contract", informed consent, professional secrecy and cases of lawful disclosure, with particular attention to the hypotheses of intervention on a minor patient. The question of the assumptions and limits within which the psychologist can possibly be called to answer for self- or hetero-harmful gestures perpetrated by the patient will also be examined.

The topic of social communication of professionals, its impact on society and the potential risks and benefits will also be explored.

Students will be asked to analyze problems that arise in their professional activity, and to propose solutions that are both deontologically and/or legally based and capable of satisfying the clinical needs of the patient.

Lectures, study of scientific articles, presentation of papers to the class, group work, simulations.

## **Assessment methods**

Attendance is mandatory for at least 70% of the lessons.

Students will also be required to produce written assignments or present scientific articles, as well as actively participate in group work and in-class simulations, according to the modalities specified by the professor throughout the course.
