Psichiatria e Psicologia Clinica

Aims

The course must contribute to the achievement of the following objectives:

- a) identify and diagnose specific mental disorders starting from the biopsychosocial etiopathogenetic theory
- b) identify the most useful therapies for the treatment of patients suffering from mental disorders starting from the guidelines on

psychiatric treatment resulting from evidence-based medicine

- c) identify the complexity of the relationship with the patient suffering from mental disorder
- d) understand the importance and use information relating to the psychosocial context in the context of care and rehabilitation of patients suffering from mental disorders
- e) select some fundamental elements aimed at information and psychoeducation of the affected patient from Mental Disorder and its family on central themes such as: the current pathology; the establishment of a valid one

therapeutic relationship; the constant improvement of therapeutic adherence and compliance

Regarding clinical psychology: Know and distinguish the areas of application and effectiveness of different psychological interventions (counseling/psychotherapy); recognize the appropriateness of psychological intervention

in situations of organic pathology and activate hospital and local psychological resources; competence of self-assessment of the development of one's professional competence and psychological attitudinal changes

Contents

The course provides the student with essential theoretical knowledge relating to behavioral sciences perspective of their subsequent professional application in the clinical field. It allows the acquisition and the deepening of the interrelationships between the contents of neuroscience, psychology and psychopathology, of clinical psychiatric and psychopharmacology in the dimension of complexity and integration of functions of the CNS. This cognitive path is aimed at understanding the most important and most diverse ones

psychopathological manifestations present in the psychiatric clinic, both regarding the states of health and frankness

disease, with particular attention to the interdisciplinarity of Medicine and Behavioral Sciences, to findings of evidence-based medicine and gender medicine.

Regarding Clinical Psychology: Clinical psychology in the healthcare system; clinical psychological interventions Evidence Based; counseling and psychotherapy; the different psychotherapeutic approaches
