Prerequisites

Teaching form

36 hours of lectures, including some co-taught with faculty from other UniMIB courses and professionals from external institutions (UniMI, ASST, OMCeO, INAIL, etc).

Assessment method

There are no ongoing tests.

Written exam consisting of 33 multiple-choice, single-answer questions: 30 questions count towards the final grade; 33 correct answers are required for honors.

The questions cover the following topic areas:

- Legal system and legal proceedings
 - Causality and etiological criteria
 - Forensic semiotics
 - Healthcare professions. Professional boards. Medical ethics
 - Professional liability in healthcare
 - Compensation for damages
 - Personal data protection and professional secrecy. Medical records. Mandatory health reporting
 - Informed consent, advance treatment directives, advance care planning, compulsory health assessment, mandatory medical treatment.
 - Social insurance. Invalidity, disability, handicap
 - Private insurance
 - Crimes against life and physical safety. Sexual offenses. Child abuse
 - Criminal responsibility, legal incapacitation, guardianship, legal support
 - Injuries. Thanatology. Identification. Forensic genetics
 - Medically assisted procreation. Voluntary termination of pregnancy
 - Organ transplants. Body donation. Clinical trials. Off-label drug use
- Oral exam on the written test errors, upon student request.

Examinations are conducted in Italian.

For non-native Italian-speaking students: they may choose between the multiple-choice written exam (in Italian, English or Spanish) or the oral exam.
