## SYLLABUS DEL CORSO

### Introduzione alla Deontologia Professionale

#### Aims

The course introduces the student to an understanding of the ethical and deontological principles and concepts to be followed in caring for the patient and focuses on the development of an ethical and deontological knowledge base to guide his/her actions as a "moral agent".

At the end of the course the student will have developed:

#### 1. Knowledge and ability to understand

To describe:

1. the concepts of morality, ethics and deontology, arguing the differences and relationships between them;
2. the main ethical theories and the role of the nurse as a moral agent;
3. the ethical concepts for nursing practice: advocacy, accountability, cooperation and caring according to Fry & Johnstone's model as a basis for ethical analysis and decision-making in nursing practice;
4. the origins, structure and principles of the Code of Ethics for Nursing Professions.

#### 2. Ability to apply knowledge and understanding

To analyse some simulated clinical scenarios identifying emerging principles, ethical concepts and values.

To apply the Code of Ethics of the Nursing Professions, integrating it into nursing practice in order to orientate responsible care choices respecting the patient, his/her wishes and the care setting.

#### 3. Autonomy of judgement

Critically evaluate the ethical, deontological, relational and caring implications of nursing decisions, justifying them in the light of values, ethical and deontological principles, legal norms and related responsibilities, while respecting the dignity, will and values of the patient.

#### 4. Communication skills

To express one's own judgement on ethical and value issues in a clear, empathetic and respectful manner, with the assisted person, family members and in the professional team, promoting a climate of trust and mutual respect.

## 5. Ability to learn

To develop an ongoing reflective and critical approach towards one's professional practice in relation to ethical and deontological implications, through active participation in case analysis, peer and teacher discussion.

## Contents

The meaning of morality, ethics and deontology.

Ethical principles according to principlism.

Ethical concepts for nursing practice according to Fry & Johnstone.

The Code of Ethics for the Nursing Professions (structure, principles and underlying ethical concepts); deontological and legal implications in professional practice in relation to some issues of professional relevance, also with reference to recent regulatory indications.

## Detailed program

**General principles and introduction to ethics:** the formation of values, the nature of values (personal, moral, cultural, religious, professional), the conflict of values, the concepts of morality, ethics and bioethics, the nurse as a moral agent, ethical responsibility, moral development according to Kohlberg, HINTS on the main ethical orientations (principlism, personalism, utilitarianism, etc.), ethical principles (autonomy, beneficence, non-maleficence, justice, truthfulness and fidelity), ethics and human rights, Health as a right.

**Ethical concepts for nursing practice:** the concepts of advocacy, accountability, cooperation and caring according to Fry & Johnstone's ethical decision-making model as a basis for ethical analysis and decision-making in nursing practice.

**Professional deontology:** Deontology and the development of codes of ethics in the nursing profession; structure, functions and general characteristics of the Code of Ethics of the International Council of Nurses (ICN, 2021); structure, functions and general characteristics of the Code of Ethics of the Nursing Professions (FNOPI, 2025) and its analysis according to ethical principles and concepts. Analysis and discussion of the ethical and deontological implications of some topics of professional relevance (e.g. informed consent and advance treatment provisions, protection of individuals with regard to the processing of personal data, safety of care and the assisted person, professional liability of health professionals).

## Prerequisites

This course builds on the knowledge of Fundamentals of Nursing and Midwifery Science.

## Teaching form

All lectures (n. 6 lessons of 2 hours each) are conducted in a delivery mode (deductive lecture) in the initial part, which is aimed at involving the students interactively in the subsequent part (inductive lecture, with the possibility of guided discussion, in plenary and in small groups, of simulated clinical cases with ethical implications and video film sequences). All activities are carried out in presence.
