#### Aims

The elective course "Complementary Care and the Nurse" aims to provide students with a comprehensive and up-to-date overview of complementary care, exploring its potential and implications for nursing practice. The aim is to stimulate professional interest in these methodologies and to provide the tools for a conscious and responsible approach to them.

The specific objectives, formulated according to the Dublin Descriptors, are as follows:

1. Knowledge and understanding:  
Understand the role of complementary care in nursing practice and know its framework.
2. Application of knowledge:  
Identify complementary approaches relevant to the profession and integrate them into patient care in a safe and conscious manner.
3. Autonomy of judgement:  
Critically evaluate the effectiveness, limitations and risks of complementary therapies, distinguishing between valid and non-evidence supported practices.
4. Communication skills:  
Dialogue with patients and colleagues about complementary therapies in a clear, ethical and collaborative manner.
5. Learning skills:  
Cultivate continuous and critical learning on the subject, constantly updating one's skills.

#### Contents

The course aims to introduce some of the complementary treatments that can allow to provide increasingly qualified and complete nursing services in the interest of the person, understood in his deepest essence of being human. The event also aims to reflect on the evolution of nursing skills through an example of role expansion.
