Emergency and Urgent Care System in Lombardy: Organization and Nursing Role

Aims

The elective course: "the Territorial Emergency-Urgency system in Lombardy: organizational context and the role of the nurse" provides students in the Bachelor of Science in Nursing degree program with a thorough knowledge of the organization and main constituent elements of the Territorial Emergency-Urgency system in Lombardy, enabling them to understand the different nursing roles and to apply these skills in guided simulations of critical life management in the out-of-hospital setting.

The specific objectives, formulated in accordance with the Dublin Descriptors, are as follows:

1. Knowledge and Understanding
Know and understand the organization and the main constituent elements of the territorial emergency-urgency system in the Lombardy Region, including AREU and its AATs.
2. Ability to Apply Knowledge and Understanding
Recognize and apply the different nursing models in the simulated management of critical life situations in the out-of-hospital setting.
3. Autonomy of Judgment
Critically evaluate the organizational context and to make judgments about nursing intervention priorities in territorial emergencies-urgencies.
4. Communication Skills
Communicate effectively and professionally with the emergency-urgency team and involved figures during critical care management.
5. Learning Skills
Demonstrate autonomy in reflecting on one's own performance and continually updating on regulations and best practices in the territorial emergency-urgency system
