Medicina Legale - 1

Aims

The course provides students with the concepts relating to the health legislation of interest to the midwifery profession, professional liability, bioethical issues in health care and the medico-legal methodology.

Contents

The student will be able to know the notions related to the midwife's medical-legal activities, the protection of health, professional secrecy, criminal and civil law, the definition and detection of death also in the field of autopsy, health care responsibility and the protection of maternal and child health, also considered in preventive terms.

Detailed program

The forensic medicine discipline: tasks and functions.

The medico-legal methodology: causality and study of causation and medico-legal criteriology, applied to medical malpractice cases.

Information activities: mandatory complaints and crime-related reports.

Medical documentation: certificates, medical records, obstetric records and mandatory reports, health records collection and health data protection law (GDPR 679/2016).

Midwifery relationship with the patient/couple: informed consent (jurisprudence and doctrine, Law 219/2017 Rules on informed consent and advance provisions on treatment, professional secrecy), consent in minors and disabled patient.

Health professional responsibility in civil and criminal matters (Law 24/2017 Provisions on the security of care and the assisted person, and professional responsibility of health professionals).

Criminal law: personal injury; homicide, infanticide; female genital mutilation (Law 7/2006).

Special Italian laws: voluntary termination of pregnancy (Law 194/1978); medically assisted procreation (Law 40/2004), conscientious objection in health care (Law 772/1972), sexual violence (Law 66/1996); domestic violence (Law 119/2013), gender violence (Law 69/2019 red code law).

Civil law: tort law and forensic evaluation of malpractice cases, compensation and assessment of damages.

Definition, detection and declaration of death (abortion; stillbirth; natural, sudden, iatrogenic and violent death).

Overview of autopsy: judicial and health autopsy.

The autopsy in newborns and in pediatric patients.

Prerequisites

None.

Teaching form

Face-to-face teaching-classroom: all Lectures in delivering type in Italian language; the teacher will also promote in class moments of discussion among students on problems related to midwife's malpractice and to modern practice in midwifery, with the use of interactive teaching material (video lessons and slides; articles, videos, podcasts, case studies (sentences), peer-to-peer learning (student's presentations) on obstetrical and medico-legal topics), provided by the teacher on the moodle e-learning platform (Virtual learning environment).

In case of emergency situations (natural disasters, weather warnings (deluge, floods), uprisings, pandemics, etc.) online teaching-classroom with synchronous lectures on the Webex platform.

Assessment method

There are no ongoing tests.

Final exam in presence consisting in two mandatory parts written and oral:

a) written part with individual preparation at home of a report on a medical-legal topic chosen by the student with an obstetric case invented or real (min 2000 - max 3000 words) and oral presentation with slide in the classroom (20 minutes), to evaluate the ability of reasoning with the forensic methodology, the ability to rework regulatory and interpretative aspects of the presented case, the ability to synthesize with extraction of the relevant points of the topic and the case presented and the ability to use technical language and arguments both in written and oral form.

b) oral exam part with a draw of 2 questions (program topics) to be answered in 7 min + 7 min to assess the knowledge of the module program.
