Aims

Knowledge and understanding

The student will acquire a thorough knowledge of the different types of violence, including the ecological model, definitions and the problem dimension. He/she will be able to understand the legal framework of reference and the theoretical basis of the medico-legal approach in cases of suspected ill-treatment and abuse, as well as the associated psychological and clinical signs, such as shaken baby syndrome, battered baby syndrome and female genital mutilations.

Applied knowledge and understanding

The student will be able to apply the acquired knowledge in the analysis of clinical cases, correctly interpreting the signs of ill-treatment and abuse, and to use the medico-legal approach for the management and assessment of suspected child abuse.

Autonomy of judgement

The student will develop the ability to critically evaluate situations of suspected maltreatment and abuse, distinguishing between different types of violence and interpreting clinical and psychological signs independently, also in the light of legal regulations.

Communicative skills

The student will be able to effectively communicate information about the signs of maltreatment and abuse, medical-legal procedures and psychological implications, adapting the language to different interlocutors, including health, legal and family professionals.

Learning skills

The student will develop the necessary skills to independently explore issues related to child abuse, keeping up to date with legislation, intervention methodologies and the latest scientific evidence in the field of prevention and management of child maltreatment and abuse.

Medico-legal and criminologic aspects of abuse and neglect.

Violence is a complex problem and it is increasing above all on women and girls and it is necessary to see it in order to protect the weakest subjects. From a judicial fact, today it has become a health and more generally a social problem, thus determining the need to train health workers to the awareness of violence in society, acquiring knowledge for the identification of abuse in its various forms, recognizing the early signs and events, mainly to prepare the appropriate and necessary therapeutic measures, to activate a social intervention and to possibly activate the judicial agencies.
