Obstetric Sciences - Gynecological and Neonatal care procedures relatives to health components in ICF:

BODY FUNCTION AND STRUCTURES: Immunological System; Genitourinary System; Integumental System

ACTIVITIES AND PARTICIPATION: concepts of Therapeutic Prescription and therapeutic administration; assessment and administration of prescriptions according to "7 G" rule; scientific, methodological and caring diagnostic principles for newborn and adult.

ENVIRONMENTAL FACTORS: Related Infections in care procedures ICPA: Washing hands. Maintenance of surgical asepsis; Concept of insulation, cleansing, disinfection and sterilisation. Personal protective equipment and individual security (DPI). Waste management. Prevention of infections. Products and technology: devices and principals for the administration of injectable and intravenous therapy
