#### **Aims**

The aim of the module:

- a) To acquire an in-depth understanding of the main clinical, physical, and psychosocial conditions that characterize patients with special needs;
- b) To familiarize with the guidelines and operational protocols for managing patients with special needs;
- c) To develop the ability to assess global risk, oral risk, to plan targeted preventive interventions, and adapt both home and professional oral hygiene protocols for patients with special needs;
- d) To enhance communication and operational skills in order to effectively interact with patients with special needs, caregivers, families, and other healthcare professionals, within the framework of multidisciplinary, integrated, and coordinated management.

### **Module 1 – Introduction to Patients with Special Needs**

### **Module 2 – Patient Assessment and Clinical Management**

- Impact of oral health within the context of patients with special needs;
- Pediatric age and related considerations;
- The concept of frailty: epidemiology, definition, multimorbidity, and polypharmacy;
- The concept of oral frailty and inflammaging;
- Systemic and oral characteristics of patients with special needs and risk assessment methodologies;
- Clinical philosophy and approach of the Dental Clinic at IRCCS San Gerardo dei Tintori.

### **Module 3 – Management Protocols for Patients with Special Needs and Frailty: Part I**

- The patient with disability: motor, sensory, and cognitive impairments;
- The diabetic patient: clinical and therapeutic considerations;
- The cardiopathic patient: integrated management and clinical monitoring.

### **Module 4 – Management Protocols for Patients with Special Needs and Frailty: Part II**

- The oncologic patient: diagnostic framework, oral implications of disease and pharmacotherapy; chemotherapy, radiotherapy, and MRONJ (Medication-Related Osteonecrosis of the Jaw);
- The immunocompromised patient: hemato-oncologic diseases, platelet deficiency, pre-transplant and post-transplant management;
- Communication strategies and anxiety management for patients, families, and caregivers;
- Anxiolysis and conscious sedation in Dentistry: protocols and clinical applications.
