#### Learning area

Models and techniques for assessing psychological functioning

#### Learning objectives

##### *Knowledge and understanding*

- Personality Disorders according to the Diagnostic and Statistical Manual of Mental Disorders (DSM).
- Personality pathology according to Otto Kernberg's theory of Structural Diagnosis.

##### *Applying knowledge and understanding*

- Administering and scoring the Structured Clinical Interview-5-DP (SCID-5-DP)
- Administering and scoring the Structured Interview of Personality Organization (STIPO-R)

##### *Making judgements*

- Ability to think critically about the conceptualization of clinical cases and the formulation of diagnostic hypotheses, obtained through group work on clinical cases
- Awareness of the limitations and possibilities of the diagnostic systems covered during classes

##### *Communication skills*

- Ability to communicate clearly and knowledgeably with teachers and colleagues about topics covered in class

- Development of diagnostic communication skills in clinical and scientific settings, encouraged through practical exercises and mock interviews

#### *Learning skills*

- Ability to use the sources indicated by teachers to explore course topics in greater depth and clarify doubts and uncertainties

## **Contents**

The conceptualization of personality pathology will be discussed according to both the psychiatric approach (DSM-5) and Otto Kernberg's psychodynamic theory. Basic techniques for the administration of diagnostic tools to assess these aspects will also be presented.

- Definitions of personality pathology
- Personality disorders in the DSM-5
- Assessment of personality disorders through the SCID-5-DP: administration and scoring
- Otto Kernberg's model of personality pathology
- Assessment of personality organization through the STIPO-R: administration and scoring

## **Prerequisites**

*General knowledge related to:*

- Diagnostic assessment: categorical approaches and structural diagnosis
- General descriptive features of personality disorders (DSM-5)

## **Teaching methods**

- Presentation of the theoretical models
- Presentation and discussion of clinical material
- Role playing
- Scoring of the presented assessment tools

Teaching: 8 hours

Interactive teaching: 20 hours

Type of activity: Laboratory

All teaching delivered in person.

## Assessment methods

Students will be asked to produce a written composition in which they analyze a clinical case presented during the lessons (psychodiagnostic report).

Although this course is held in Italian, for Erasmus students, course material can also be available in English, and students can take the exam in English if they wish to do so.
