#### Module description

The module “Climate Crisis and Social Justice” analyses the interconnections between global environmental transformations, social inequalities, and contemporary political-economic dynamics. The course is situated at the intersection of Anthropocene studies, critical social sciences, and interdisciplinary approaches to sustainability, with particular attention to issues of power, responsibility, and vulnerability that characterise the climate crisis.

The module provides conceptual and analytical tools to understand the climate crisis as a complex socio-political phenomenon, deeply intertwined with questions of social justice, global inequalities, conflicts, migration, development, and multi-level governance.

#### Learning goals

The aim of the module is to provide students with appropriate theoretical knowledge and analytical skills to interpret the climate crisis as a complex socio-political phenomenon, with particular attention to its implications in terms of social justice.

*1. Knowledge and understanding*

Acquisition of the main theories and concepts related to the climate crisis, the Anthropocene, climate justice, and environmental governance.

*2. Applying knowledge and understanding*

Ability to analyse case studies, climate policies, and environmental conflicts using appropriate theoretical and methodological tools.

*3. Making judgements*

Development of a critical reading of dominant narratives and of the ethical and political implications of environmental policies.

*4. Communication skills*

Ability to articulate complex arguments, both orally and in writing, using the appropriate language of the social sciences.

*5. Learning skills*

Development of an autonomous, reflective, and interdisciplinary approach to the study of socio-ecological transformations.

## **General goal**

To provide a critical and integrated understanding of the climate crisis as a matter of social justice.

## **Specific skills and competences**

Critical analytical skills, ability to interpret climate policies and politics, and capacity to link theoretical frameworks with empirical case studies.
