Learning objectives

In relation to the objective of knowledge and understanding:

- To acquire an in-depth understanding of restorative justice programs and their practical implementation
- To gain in-depth knowledge of mediation as a practice used in managing conflicts in criminal, social, educational, and family settings
- To thoroughly understand the role of the mediator, their position of neutrality and impartiality, with a focus on the concept of equidistance (equiprossimità), highlighting the distinctions and interactions between this role and other social professions

In relation to the objective of applying knowledge and understanding:

- To experiment with tools used by expert mediators in restorative justice programs, approaching the practical skills required in this professional role
- To identify useful techniques for listening and conflict management
- To be able to act in conflict situations with enhanced analytical capacity
- To be able to use specific tools for empathic listening
- To be able to describe the process of a mediation program in all its phases
- To be able to take on a role in promoting restorative justice programs within professional contexts where there is a legal duty to inform beneficiaries

The Mediator's Listening

Prerequisites

No prior knowledge required

Teaching methods

In relation to critical thinking and judgment skills, the following activities are planned:

- Exercises focused on listening and communication
- Group discussions
- Role-playing and simulations

Trainers will provide appropriate support to participants in exploring conflict dynamics and the meaning of dialogic mediation. Dedicated time will be ensured for reflection and evaluation of the outcomes of these exercises.

In each session, starting from a theoretical prompt, trainers will guide participants in developing skills by linking theoretical reflections with practical actions.

Learning through experience will be the core methodology.

In relation to communication skills, the following are planned:

- Group work analyzing conflict situations
- Use of diverse forms of language (legal texts, literary works, audiovisual materials)

In relation to learning skills:

- Each participant will have the opportunity to take on different roles during the workshop sessions (e.g., mediation participant, mediator, observer), thus developing a broad and multi-perspective view.
- Furthermore, the practical exercises will promote teamwork, allowing participants to practice collaboration and cooperative work, essential skills in professional settings.

Assessment methods

The course is structured as an experiential workshop.

The trainers, who are expert mediators in restorative justice programs, will provide each participant with appropriate support in understanding and analyzing their individual skills in conflict management. They will highlight areas of learning and improvement based on the outcomes of the exercises, and identify aspects that may require further development.
