Learning objectives

1. Knowledge and understanding
Demonstrate an in-depth knowledge of the functioning of the European administration and the implementation mechanisms of EU policies within the Italian national context
Understand cutting-edge topics and current debates in European administrative law, with a specific focus on the theoretical and regulatory foundations of the Green Deal
2. Applying knowledge and understanding
Be able to apply European administrative models to the Italian institutional reality, demonstrating a professional approach in solving problems related to the implementation of EU policies
Use the acquired knowledge to operate in interdisciplinary contexts related to the ecological transition and new challenges in administrative law.
3. Making judgements
Develop the ability to gather and interpret regulatory and jurisprudential data to formulate autonomous reflections on ongoing debates in European administrative law
Integrate knowledge to manage the complexity of EU policies, including reflection on the social and ethical responsibilities related to the implementation of the Green Deal
4. Communication skills
Be able to communicate clearly to both specialist (jurists, officials) and non-specialist audiences regarding the dynamics of the European administration and the solutions identified for the implementation of EU policies
Present with logical rigor the rationale and underlying principles of European administrative reforms and sustainability strategies
5. Learning skills
Have developed learning skills that allow for continued autonomous study and updates on the evolutions of administrative law and future European directives
Be able to independently explore new research areas or emerging professional fields related to the management of European public policies

Contents

Lessons and workshop in class will focus on EU administrative law, which includes analysis of the main forms of administration through which policy is delivered .

Detailed program

Particular attention will be devoted to:

-the principles of European administration;

- the administrative organization of the European Union;
 - European administrative procedures;
 - sector-specific topics, including Environment and the Energy Transition, Food Safety and Public Health, Transport, the Internal Market, Migration and Border Management, and Digital and Algorithmic Regulation.
- Detailed program will be discussed in class during the first lesson and will be then shared on line on the e-learning.

Lessons will be held in class.

Attending students will be asked for active participation presenting materials during the lessons.

Teaching methods

Lesson, exposition of cases by students, debate on the issues arising from the analysis of the cases.

Assessment methods

Oral examination: The oral examination consists of an interview covering the topics included in the course syllabus and the recommended reading materials. Its purpose is to assess the student's ability to understand and present, in a clear and independent manner, the main topics and fundamental aspects of the subject.

During the examination, the following will be assessed:

- (a) knowledge and understanding of the fundamental contents of the subject;
- (b) the ability to present and discuss legal issues using appropriate legal terminology;
- (c) the ability to apply the knowledge acquired through independent analysis and personal critical reflection;
- (d) the ability to develop well-reasoned arguments, demonstrate critical thinking, and place legal institutions within the broader framework of the legal system.

In addition to the oral exam, those who wish may take an in-class written exam (upon prior registration via e-learning) and present materials distributed through the platform in class.
