La Catena Contro la Violenza

Aims

To continuously raise the awareness of future health professionals, in order to maintain a high level of alert that allows to intercept and identify all cases of violence in various dimensions, including the legislative and regulatory framework of reference. Develop a critical, integrated and multidisciplinary care approach to support victims both within and outside the hospital, actively collaborating with the various social and health resources to ensure full coverage from reception to follow-up.

The specific objectives of the course, defined according to the Dublin Descriptors, are as follows:

1. To know and understand the phenomenon of violence in its different forms and dimensions, knowing the normative and legislative framework of reference.
2. Apply knowledge to detect early signs of violence in various care settings and activate the planned management routes.
3. Develop autonomy of judgment in the critical analysis of intra- and extra-hospital paths, evaluating the care needs of the person and the available resources.
4. Communicate effectively with the victim of violence, the health team and the territorial network using professional, respectful and protection-oriented language.
5. Strengthen the capacity to learn, maintaining a sensitive attitude, updated and aware of the evolution of social reality and integrated care responses.

Contents

Violence, mistreatment and sexual abuse against women are unfortunately present in daily social life and often go unpunished as they are committed within a relationship. Every type of violence leaves the victim with pain that lasts over time, in addition to the risk of never seeing a true and full punishment for the serious crime committed by the aggressor, it also causes numerous failures to report and report for fear of retaliation: the result is that the woman is unable to start a path to escape from the circle of violence.

The phenomenon is terrible: in Italy in 2023, a woman was killed approximately every three days. Added to this are

numerous other types of violence, often undetected, which can lead to many other victims over time. In 2023, 120 women were killed. In 64 cases the murder occurred at the hands of partners or ex-partners. These are the numbers that emerge from the "8 March. International Women's Rights Day. Women victims of violence", of the Criminal Analysis Service of the Central Criminal Police Directorate, the joint office of the Department of Public Security. According to Istat data, approximately 7 million women have suffered some form of abuse during their lives. Nurses and all healthcare professionals are called to play a very important role aimed at identifying and managing these situations, but first and foremost at preventing and safeguarding the health of the victims and the family context, especially in the presence of minors. The elective course aims to raise awareness among students of the Degree Course in Nursing (future healthcare professionals) of the importance of correct recognition of the problem of abuse/maltreatment and of a qualitatively advanced healthcare approach, which cannot ignore the integration of different skills, resources and professional figures, essential for building a synergistic path of reception and care.
