Contents

The main regulations relating to the midwifery profession and the midwife's own field of activity and responsibility.

The ethical, bioethical and deontological issues arising within the midwifery profession, the rights of the assisted person.

Assessment method

The final exam aims to assess the acquisition of knowledge and understanding of the program content.

It consists of a written exam followed by an interview.

The written exam consists of closed-ended (true/false, matching, multiple-choice quizzes) and short open-ended questions on the content covered in the following Didactic Units:

- Applied Economics
- Health care legislation and organization
- Labor Law

The oral examination involves the discussion of the written test and an interview on the topics covered in class in the following Didactic Units:

- Forensic Medicine
- Labor Law

For the Didactic Unit Legal Medicine, individual preparation of a technical paper on a medico-legal topic with an obstetrical case is required, which will be presented and discussed during the interview (see specifications on the relevant Syllabus)
