Learning objectives

The course will cover corporate finance basics .

Beyond the more theoretical aspects the course will focus particularly on the financial management and policy of a typical industrial and service firm.

Contents

The course aims to develop basic knowledge and skills necessary to operate as a financial manager in the corporate sector.

The course will focus on classic principles of the theory of corporate finance from corporate cost of capital to Modigliani & Miller theorems and optimal capital structure.

Detailed program

The course develops the following program:

Accounting financial analysis.

Cash flows analysis.

Financial planning.

Risk and return trade-off of financial assets

Corporate cost of capital.

Optimal corporate financial structure,

Basic knowledge of accounting.

Basic knowledge of statistics and financial mathematics

Teaching methods

Teaching method are the following:

Face-to-face lectures (12 hours)

On-line activities (30 hours)

Case studies are discussed in order to apply theoretical concepts of the course programme

Assessment methods

The assessment method is a written exam with the following structure:

1. a set of closed end questions (multiple choice)
2. two open questions
3. one numerical exercise in which students apply and solve a given corporate finance problem.
