Sustainable Development and Public Law

Learning objectives

1. Knowledge and understanding

Provide basic knowledge of Environmental Law.

2. Applying knowledge and understanding

Develop juridical approaches and methodologies for the analysis of environmental issues, even through cases.

****3. Autonomy of judgment**

Learn to critically evaluate the legal effects of environmental policies and decisions, even in contentious contexts or in the presence of conflicting interests (environment vs. economic development).

4. Communication skills

Report clearly on environmental legal issues.

5. Learning skills

Develop the skills necessary to continue independently to keep abreast of environmental law and to be prepared for research, specialization or professional career paths in legal fields related to sustainability and environmental protection.

Contents

The course is concerned with the study of the principle of sustainable development and its application in the legal system, even focusing on the analysis of problems related to the implementation of decarbonization goals.

Detailed program

Sustainable development: from principle to economic model

Sustainable development and the circular economy, including the waste discipline

Sustainable development and decarbonization policies, including the discipline of renewable energy and climate litigation

Sustainable development and the marketplace, including the government's sustainable procurement plan

Sustainable development, DNHS and green claims.

Prerequisites

No prerequisites are required.

Teaching methods

Lectures will be held, as a rule, in presence, in delivery mode especially in the initial part, and then encourage critical learning, including in interactive mode, in the later part of the course.

Some lectures will be streamed, even considering strikes or possible overlaps with other conferences or events of interest.

The detailed schedule of lectures will be posted on the platform.

Pwp presentations will be used in class along with other jurisprudential, doctrinal and regulatory materials. All the materials will be uploaded on the platform.

Assessment methods

Oral test: interview on the topics covered in the program, aimed at assessing students' knowledge and their ability to discuss and critically argue the topics covered during the course.
