Learning objectives

The course is primarily aimed at developing a solid command of the principles and institutions of the legal system.

Knowledge and Understanding

The main objective is to provide specific training on the organization and institutions of the Italian Republic and the European Union. Special focus will be placed on the relationship between authority and freedom, with reference to both individuals and social groups; the study of normative sources and the mechanisms of their creation; and ongoing constitutional transformations.

Applying Knowledge and Understanding

The course aims to equip students with the tools to understand the legal framework and its role in civil and social coexistence. These tools include national primary and secondary legislation, as well as European law. Foundational constitutional theories will also be addressed, to enable a reasoned reading of institutional life and the dynamics between private individuals and public power. Students will be guided to critically engage with practical issues, with particular attention to the application of legal categories to economic phenomena.

Making Judgments

The course intends to foster the ability to frame the legal aspects of real-life situations and to develop reasoned judgments regarding applicable legislation and appropriate legal solutions.

Communication Skills

The goal is to help students acquire a technical vocabulary and appropriate terminology to competently describe legal phenomena and processes.

Learning Skills

The course aims to provide the framework for analyzing legal phenomena in order to ensure the acquisition of reasoning methods typical of the legal discipline.

Contents

The course's contents are the organization and the activities of the State and further public bodies. It will be also examined the legal-political framework of the contemporary society and State, with particular reference to the problems of individual's and social groups' freedoms.

Detailed program

The basics of general public law: the legal system, States and governments.
Sources of public law.
Outline of Italian constitutional history.
Constitutional organization of the Italian Republic.
Regions and local governments.
Rights and duties of the citizens
International relationships of the Italian Republic.
Public economics law: regulation of the market and public intervention in economy

Prerequisites

No prerequisites are requested.

Teaching methods

Teaching with different methodologies:
52 hours of traditional face-to-face lessons;
20 hours of lessons in e-learning mode.
Interactive lessons (both in person and remotely) may be offered, consisting of book presentations, in-depth discussions, or participation in conferences on topics relevant to teaching.

Assessment methods

The exams consist of an oral test.
Written tests with open-ended questions may be scheduled during and/or at the end of the course.
For both oral and written tests, the objective is to evaluate the students' learning of the course topics and their ability to independently reflect
