The course is structured as an introduction to Italian Private Law and to the fundamental principles of the Italian Civil Code.

Teaching methods

Class lectures in Italian language of Explanation Teaching (72 academic hours, including 24 lectures given by Prof. Emilio Tosi and 48 given by Dr. Giorgia Tassoni).
During the Course, Dr. Giorgia Tassoni is in the classroom as an assistant professor for the Lectures given by Prof. Emilio Tosi.
Prof. Emilio Tosi will teach in particular key issues of digital private law; is available for Student reception at the end of the Lecture or by appointment.

Assessment methods

The final exam is oral at the end of the course, without any mid-term exam during the course.
The candidate must demonstrate a good knowledge of the key private law institutes and the Civil Code. A preliminary mnemonic study of the basic notions and definitions is also required. Institutions of private law must be presented with accurate terminology. The student must be able to explain the rules and problems that pertain to the main institutes of private law.
Prof. Emilio Tosi and Dr. Giorgia Tassoni are component of the same examination board, so that each Student is called for a unique test on Private Law without any subdivision into modules
