Globalizzazione e Sviluppo Locale

Learning objectives

The course aims at providing theoretical and methodological tools to critically analyze specific conceptual categories such as “globalization”, “development”, “humanitarian intervention”, “aid”.

Knowledge and understanding (D1)

Students will acquire theoretical and analytical tools to critically understand humanitarian, economic, and personal aid systems from a socio-anthropological perspective. Key concepts such as need, development, participation, and empowerment in relation to various forms of aid projects will be critically discussed.

Applied knowledge and understanding (D2)

Students will be able to apply these key concepts to highlight critical issues in aid interventions, in particular their ethnocentric character, and then suggest corrective measures.

Autonomy of judgment (D3)

The course develops the ability to formulate independent critical assessments of various forms of aid and their impact on the reproduction of social inequalities and asymmetries between countries in the North and South of the world.

Communication skills (D4)

Students will be involved in group discussions. Argumentation skills will be enhanced through written exercises.

Learning skills (D5)

The course provides the basis for enhancing the ability to interpret local issues in relation to global dynamics and to critically navigate international scientific literature.

Contents

Critical anthropological approach to development, globalization, development aid, NGOs and humanitarian intervention

Detailed program

Globalization and local development will be discussed through the critical analysis of NGO's activities, International organizations dealing with economic development, and humanitarian intervention. The emergence of new professionals and new technocrats engaged on development, and their influential role on policy making will be discussed as well.

- The anthropological gaze will be used

a) to deconstruct development as a hegemonic expression of capitalism;

b) to look at the outcomes of development and humanitarian projects;

c) to look at their (un)intended consequences

- Presentation of the main theories of development and their respective criticisms
 - Viewing of several documentaries on development and its consequences on people's lives
 - The role of NGOs
 - Changes in aid in recent years and criticism of development
 - Presentation of case studies
 - Humanitarian aid

Prerequisites

Mastery of theoretical knowledge and methodological basis regarding anthropology and good skills in learning, writing and oral communication. English language required.

Teaching methods

Number of lectures:13.

Length: 4 hours each and one of 3 hours

Lectures will be given in classroom with the instructor. Visual material will be used and be discussed in class, but can also be accessed on line through the elearning platform. Assignments must be handed-in by uploading them on the same platform.

Instructions will be available on the e-learning platform.

Assessment methods

Written Exam:

Evaluation of students will comprise two online assignments
(instructions will be posted on the elearning platform at the beginning of the course);

- 2 written practical exercises assigned during course:

1. Description of a situation where reconciling human rights and cultural traditions proves to be problematic.
2. Viewing of one documentary (from a list) and writing a critical reflection on the case study presented. This must include the analysis of the interconnections between the different elements in light of one or more theoretical paradigms, and an intervention project proposal.

The skills that will be assessed:- Understanding of content- Ability to think independently - Written communication skills- Ability to link theory and real-life examples.
