## Chapter 1

## Introduction

### 1.1 Concepts of equilibrium in game theory

Game theory deals with situations in which a finite number of players do maximize their own payoff, deciding a strategy among all the available options. Generally each player establishes his own strategy at the same time, taking into account that the game's result depends also on the choice taken by others. Without loss of generality, let's consider the case with two players; both of them have to solve the following problem:

$$
\begin{equation*}
\max _{\mathbf{x}_{i} \in X_{i}} J_{i}\left(\mathbf{x}_{1}, \mathbf{x}_{2}\right) \tag{1.1}
\end{equation*}
$$

where $\mathbf{x}_{i} \in X_{i}$, which is the set of all possible options for Player $i=1,2$. This is a "one shot game" meaning the payoff is entirely determined by the particular selected strategy.
In general it is not possible to find a solution $\left(\mathbf{x}_{1}^{*}, \mathbf{x}_{2}^{*}\right) \in X_{1} \times X_{2}$ which leads both Player 1 and Player 2 to get the maximum payoff; indeed, the outcome could be favourable only for one of them. This is the reason why there exist different concepts of equilibrium that differ from each other in some features, such as the type of available information, games' mechanism in terms of choices' sequence or, as an alternative, the faculty to cooperate. Hereafter there are the main concepts of solution: Nash equilibrium, Stackelberg equilibrium and Pareto optimality, but first it is necessary to introduce some notations.
In the simplest case of two players, say "Player A" and "Player B" the required ingredients are given by:

- The two (finite/infinite) sets of strategy $A$ and $B$ : the players choose their particular strategy, respectively $a \in A$ and $b \in B$, so that the payoffs achieved are $J_{A}(a, b)$ and $J_{B}(a, b)$.
- The two payoff functions: $J^{A}: A \times B \rightarrow \mathbb{R}$ and $J^{B}: A \times B \rightarrow \mathbb{R}$ which are continuous and known by both players.

Definition 1.1 (Nash equilibrium). The pair of strategies $\left(a^{*}, b^{*}\right)$ is a Nash equilibrium of the game if, for every $a \in A$ and $b \in B$, one has

$$
J_{A}\left(a, b^{*}\right) \leq J_{A}\left(a^{*}, b^{*}\right) \quad J_{B}\left(a^{*}, b\right) \leq J_{B}\left(a^{*}, b^{*}\right)
$$

In this situation none of the players may increase his payoff changing his own strategy if the other do not deviate from his one. This is a solution concept of non-cooperative game.

Definition 1.2 (Stackelberg equilibrium). A pair of strategies $\left(a^{*}, b^{*}\right) \in A \times B$ is called a Stackelberg equilibrium if $b^{*} \in R^{B}\left(a^{*}\right)$ and moreover

$$
J_{A}(a, b) \leq J_{A}\left(a^{*}, b^{*}\right) \quad \forall(a, b), b \in R^{B}(a), a \in A,
$$

where $R^{B}(a)$ is the set of Best Replies of Player B (the follower), since Player A (the leader) has already announced the strategy $a$, i.e.

$$
R^{B}(a)=\left\{b^{\prime} \in B: J_{B}(a, b) \leq J_{B}\left(a, b^{\prime}\right), \forall b \in B\right\} .
$$

Note that $b^{*}$ stands for the best reply of Player B, which can choose his strategy only after Player A (the leader) has announced his own one. In other words, first Player A establishes his strategy optimizing his utility function, then Player B defines his strategy taking into account what the first player has decided (asymmetry of information).

### 1.2 Differential games

Let $\mathbf{x} \in \mathbb{R}^{n}$ describe the state of the system, evolving in time according to the ODE (called dyinamics)

$$
\begin{equation*}
\dot{\mathbf{x}}(t)=g\left(t, \mathbf{x}, \mathbf{u}_{1}, \mathbf{u}_{2} \ldots \mathbf{u}_{N}\right), \quad \text { a.e. } t \in[0, T] \tag{1.2}
\end{equation*}
$$

with an initial data

$$
\begin{equation*}
\mathbf{x}(0)=\mathbf{x}_{0} \in \mathbb{R}^{n} \tag{1.3}
\end{equation*}
$$

and with final condition

$$
\begin{equation*}
(T, \mathbf{x}(T)) \in \mathcal{T} \tag{1.4}
\end{equation*}
$$

where $\mathcal{T} \subset \mathbb{R}^{+} \times \mathbb{R}^{n}$ is the target set; in this note we will consider closed target sets. Let us list some particular case of target set, depending on the final condition on the trajectory:

- (fixed time and fixed value of the trajectory): for $\mathbf{x}(T)=\boldsymbol{\beta}$, with $T$ and $\boldsymbol{\beta}$ fixed, we have $\mathcal{T}=\{(T, \boldsymbol{\beta})\}$;
- (fixed time and free value of the trajectory): we have $\mathcal{T}=\{T\} \times \mathbb{R}^{n}$;
- (free time and fixed value of the trajectory): we have $\mathcal{T}=\mathbb{R}^{+} \times\{\boldsymbol{\beta}\}$, with $\boldsymbol{\beta} \in \mathbb{R}^{n}$ fixed.

Here $\mathbf{u}_{1}, \mathbf{u}_{2}, \ldots, \mathbf{u}_{N}$ are the controls of the $N$ players (clearly we suppose $N \geq 2$ ). We assume that they satisfy the pointwise constraints

$$
\mathbf{u}_{i}(t) \in U_{i}, \quad i=1, \ldots N
$$

where $U_{i} \subset \mathbb{R}^{k_{i}}$ are the control sets for the $i$-Player.
It is clear that the possibility to solve the Cauchy problem $1.2-1.3$ is not clear: however, we usually assume that the function $g$ is continuous, differentiable w.r.t. $\mathbf{x}$ and with the derivatives $\frac{\partial g}{\partial x_{j}}\left(t, \mathbf{x}, \mathbf{u}_{1}, \mathbf{u}_{2} \ldots \mathbf{u}_{N}\right)$ continuous.

The aim of the $i$-player is to maximize

$$
J_{i}\left(\mathbf{u}_{1}, \ldots \mathbf{u}_{N}\right)=\int_{0}^{T} f_{i}\left(t, \mathbf{x}, \mathbf{u}_{1}, \ldots \mathbf{u}_{N}\right) \mathrm{d} t+\psi_{i}(T, \mathbf{x}(T))
$$

where, as usual in the control theory, $f_{i}$ are the running cost and $\psi_{i}$ are the payoff. Clearly the $i$-player controls only the choice of $\mathbf{u}_{i}$.

In all that follows we suppose that there are only two players $(N=2)$, but it is easy to generalize.
The information available to players, such as the current state of the system and the strategy adopted by the competitor, determine the kind of game that has to be undertaken by them. Let's first give some assumptions upon which the following analysis will be established and then let's expose some of the most well-known differential games. Each player has perfect knowledge of:

- the evolution of the system (identified by the function $g$ ), and the control sets $U_{1}, U_{2}$.
- the two payoff functions $J_{1}, J_{2}$.
- the instantaneous time $t \in[0, T]$
- the initial condition for the system $x_{0}$


### 1.2.1 Some particular two-persons games

Let us introduce some particular situation for the two-persons games. We say that the game is symmetric if

$$
\begin{aligned}
& f_{1}\left(t, \mathbf{x}, \mathbf{u}_{1}, \mathbf{u}_{2}\right)=f_{2}\left(t, \mathbf{x}, \mathbf{u}_{2}, \mathbf{u}_{1}\right) \\
& \psi_{1}=\psi_{2}, \quad g\left(t, \mathbf{x}, \mathbf{u}_{1}, \mathbf{u}_{2}\right)=g\left(t, \mathbf{x}, \mathbf{u}_{2}, \mathbf{u}_{1}\right), \quad U_{1}=U_{2} .
\end{aligned}
$$

A game is completely cooperative if

$$
f_{1}=f_{2}, \quad \psi_{1}=\psi_{2}, \quad U_{1}=U_{2} .
$$

A game is zero-sum if

$$
f_{1}=-f_{2}, \quad \psi_{1}=-\psi_{2} ;
$$

in this case, setting $f=f_{1}$ and $\psi=\psi_{1}$, the strike of the first player is to find a strategy $\mathbf{u}_{1}$ in order to

$$
\max _{\mathbf{u}_{1}} J\left(\mathbf{u}_{1}, \mathbf{u}_{2}\right),
$$

where

$$
J\left(\mathbf{u}_{1}, \mathbf{u}_{2}\right)=\int_{0}^{T} f\left(t, \mathbf{x}, \mathbf{u}_{1}, \mathbf{u}_{2}\right) \mathrm{d} t+\psi(T, \mathbf{x}(T)) ;
$$

while the strike of second player is to minimize the same functional, controlling $\mathbf{u}_{2}$, since

$$
\max _{\mathbf{u}_{2}} \int_{0}^{T}-f\left(t, \mathbf{x}, \mathbf{u}_{1}, \mathbf{u}_{2}\right) \mathrm{d} t-\psi(\mathbf{x}(T))=-\min _{\mathbf{u}_{2}} J\left(\mathbf{u}_{1}, \mathbf{u}_{2}\right) .
$$

### 1.2.2 Information structure: open-loop and feedback in two-persons game

In this context are just discussed two differential games: Open-loop strategies and Feedback (or Markovian) strategies. Essentially, open-loop means that the players base their decision only on time and an initial condition; whereas, the players use the position/state of the game as information basis in a feedback context. A feature that is common to those two information structure is that the players do not need to remember the whole history of the game when making a decision: only running time and the initial position $\mathbf{x}_{0}$ are relevant for the open-loop information structure, while for the feedback structure, only information on the current position is relevant.

We focus our attention on two-persons game:
Definition 1.3. Open-loop strategies. The set $S_{i}$ of strategies available to the $i$-th Player, with $i=1,2$, will consist of the functions $\mathbf{u}_{i}:[0, T] \rightarrow U_{i}$ such that

$$
\mathbf{u}_{i}(t)=\boldsymbol{\nu}_{i}\left(t, \mathbf{x}_{0}\right),
$$

where $\mathbf{x}_{0}$ is the initial data and $\boldsymbol{\nu}_{i}$ is a decision rule, i.e. a measurable function $\boldsymbol{\nu}_{i}:[0, T] \times \mathbb{R}^{n} \rightarrow U_{i}$.

Definition 1.4. Feedback strategies (or Markovian strategies). Here, the control implemented by Player $i$, for $i=1,2$, is $\mathbf{u}_{i}$, depending on both time $t$ and system's state $\mathbf{x}$. The set $S_{i}$ of strategies available to the $i$-th Player will consist of the functions $\mathbf{u}_{i}:[0, T] \rightarrow U_{i}$ such that

$$
\mathbf{u}_{i}(t)=\boldsymbol{\nu}_{i}(t, \mathbf{x}(t)),
$$

where $\boldsymbol{\nu}_{i}$ is a decision rule, i.e. a measurable function $\boldsymbol{\nu}_{i}:[0, T] \times \mathbb{R}^{n} \rightarrow U_{i}$; the Player $i$ observes the system's position $(t, \mathbf{x}(t))$ and chooses his action as described decision rule $\boldsymbol{\nu}_{i}$.

Other concepts of strategies can be given (see for example [2]).
Clearly, as we will see in the next lines, we require that the previous controls are admissible too. To be more precise, let us consider the problem

$$
\left\{\begin{array}{c}
\text { Player I: } \max _{\mathbf{u}_{1}} J_{1}\left(\mathbf{u}_{1}, \mathbf{u}_{2}\right) \quad \text { Player II: } \max _{\mathbf{u}_{2}} J_{2}\left(\mathbf{u}_{1}, \mathbf{u}_{2}\right)  \tag{1.5}\\
J_{i}\left(\mathbf{u}_{1}, \mathbf{u}_{2}\right)=\int_{0}^{T} f_{i}\left(t, \mathbf{x}, \mathbf{u}_{1}, \mathbf{u}_{2}\right) \mathrm{d} t+\psi_{i}(T, \mathbf{x}(T)), \quad i=1,2 \\
\dot{\mathbf{x}}=g\left(t, \mathbf{x}, \mathbf{u}_{1}, \mathbf{u}_{2}\right) \\
\mathbf{x}(0)=\mathbf{x}_{0} \\
(T, \mathbf{x}(T)) \in \mathcal{T}
\end{array}\right.
$$

We have the following definition:
Definition 1.5. The class $\mathcal{A}_{O L}$ and the class $\mathcal{A}_{F B}$. We say that $\left(\mathbf{u}_{1}, \mathbf{u}_{2}\right)$, with $\mathbf{u}_{i}(t)=\boldsymbol{\nu}_{i}\left(t, \mathbf{x}_{0}\right)$, is an admissible control (or strategy) in the class $\mathcal{A}_{O L}$ of open loop strategies for the game (1.5) if $t \mapsto$ $\left(\boldsymbol{\nu}_{1}\left(t, \mathbf{x}_{0}\right), \boldsymbol{\nu}_{2}\left(t, \mathbf{x}_{0}\right)\right) \in U_{1} \times U_{2}$ is a measurable function such that there exists a unique solution $\mathbf{x}$ (called trajectory) of the ODE

$$
\left\{\begin{array}{l}
\dot{\mathbf{x}}(t)=g\left(t, \mathbf{x}(t), \boldsymbol{\nu}_{1}\left(t, \mathbf{x}_{0}\right), \boldsymbol{\nu}_{2}\left(t, \mathbf{x}_{0}\right)\right) \quad \text { a.e. } t \in[0, T] \\
\mathbf{x}(0)=\mathbf{x}_{0} \\
(T, \mathbf{x}(T)) \in \mathcal{T}
\end{array}\right.
$$

We say that $\left(\mathbf{u}_{1}, \mathbf{u}_{2}\right)$, with $\mathbf{u}_{i}(t)=\boldsymbol{\nu}_{i}(t, \mathbf{x}(t))$, is an admissible control (or strategy) in the class $\mathcal{A}_{F B}$ of feedback strategies for the game 1.5) if $(t, \mathbf{x}) \mapsto\left(\boldsymbol{\nu}_{1}(t, \mathbf{x}), \boldsymbol{\nu}_{2}(t, \mathbf{x})\right) \in U_{1} \times U_{2}$ is a measurable function such that there exists a unique solution $\mathbf{x}$ (called trajectory) of the ODE

$$
\left\{\begin{array}{l}
\dot{\mathbf{x}}(t)=g\left(t, \mathbf{x}(t), \boldsymbol{\nu}_{1}(t, \mathbf{x}(t)), \boldsymbol{\nu}_{2}(t, \mathbf{x}(t))\right) \quad \text { a.e. } t \in[0, T] \\
\mathbf{x}(0)=\mathbf{x}_{0} \\
(T, \mathbf{x}(T)) \in \mathcal{T}
\end{array}\right.
$$

### 1.2.3 The game set

We define the game set $\mathcal{G} \subset \mathbb{R}^{+} \times \mathbb{R}^{n}$ for the game 1.5) as the points $(\tau, \boldsymbol{\xi}) \in[0, \infty) \times \mathbb{R}^{n}$ such that there exists at least a trajectory $\mathbf{x}:[\tau, T] \times \mathbb{R}^{n}$ such that

$$
\mathbf{x}(\tau)=\boldsymbol{\xi} \quad \text { and } \quad(T, \mathbf{x}(T)) \in \mathcal{T}
$$

usually we say that $\mathbf{x}$ transfers $(\tau, \boldsymbol{\xi}) \in \mathcal{G}$ in $\mathcal{T}$. Clearly

$$
\mathcal{T} \subset \mathcal{G} .
$$

As usual we define the exit time $T_{\mathbf{x}}$ for the trajectory $\mathbf{x}$ by (since $\mathcal{T}$ is closed)

$$
\begin{equation*}
T_{\mathbf{x}}=\inf \{t \geq 0:(t, \mathbf{x}(t)) \in \mathcal{T}\} . \tag{1.6}
\end{equation*}
$$

## Chapter 2

## Nash equilibria for two-persons game

In all this chapter we are considering a two-person game (the general case of a $N$-person game is similar)

$$
\left\{\begin{array}{c}
\text { Player I: } \max _{\mathbf{u}_{1}} J_{1}\left(\mathbf{u}_{1}, \mathbf{u}_{2}\right) \quad \text { Player II: } \max _{\mathbf{u}_{2}} J_{2}\left(\mathbf{u}_{1}, \mathbf{u}_{2}\right)  \tag{2.1}\\
J_{i}\left(\mathbf{u}_{1}, \mathbf{u}_{2}\right)=\int_{0}^{T} f_{i}\left(t, \mathbf{x}, \mathbf{u}_{1}, \mathbf{u}_{2}\right) \mathrm{d} t+\psi_{i}(\mathbf{x}(T)), \quad i=1,2 \\
\dot{\mathbf{x}}=g\left(t, \mathbf{x}, \mathbf{u}_{1}, \mathbf{u}_{2}\right) \\
\mathbf{x}(0)=\mathbf{x}_{0}
\end{array}\right.
$$

where $U_{1}$ and $U_{2}$ are closed control sets for the players and $\left(\mathbf{u}_{1}, \mathbf{u}_{2}\right)$ is an admissible control, i.e. depending on the information structure. In this chapter we restrict our attention on problems with the final time $T$ fixed and the final value of the trajectory $\mathbf{x}(T)$ free.

A Nash equilibrium $\left(\mathbf{u}_{1}^{*}, \mathbf{u}_{2}^{*}\right)$ is such that

$$
\begin{array}{cc}
J_{1}\left(\mathbf{u}_{1}^{*}, \mathbf{u}_{2}^{*}\right) \geq J_{1}\left(\mathbf{u}_{1}, \mathbf{u}_{2}^{*}\right), & \forall \mathbf{u}_{1} \\
J_{2}\left(\mathbf{u}_{1}^{*}, \mathbf{u}_{2}^{*}\right) \geq J_{2}\left(\mathbf{u}_{1}^{*}, \mathbf{u}_{2}\right), & \forall \mathbf{u}_{2},
\end{array}
$$

taking into account the information structure and the admissibility of the controls, as we will study in the next sections.

### 2.1 Open-loop Nash equilibria

Definition 2.1. A pair of control functions $\left(\mathbf{u}_{1}^{*}, \mathbf{u}_{2}^{*}\right) \in \mathcal{A}_{O L}$, with decision rule $\mathbf{u}_{i}^{*}(t)=\boldsymbol{\nu}_{i}^{*}\left(t, \mathbf{x}_{0}\right)$ and trajectory $\mathbf{x}^{*}$ such that

$$
\left\{\begin{array}{l}
\dot{\mathbf{x}^{*}}(t)=g\left(t, \mathbf{x}^{*}(t), \boldsymbol{\nu}_{1}^{*}\left(t, \mathbf{x}_{0}\right), \boldsymbol{\nu}_{2}^{*}\left(t, \mathbf{x}_{0}\right)\right) \quad \text { a.e. } t \in[0, T] \\
\mathbf{x}^{*}(0)=\mathbf{x}_{0}
\end{array}\right.
$$

is a Nash equilibrium within the class of open-loop strategies $\mathcal{A}_{O L}$ for the game (2.1) if the following holds:

I the control $\mathbf{u}_{1}^{*}$ provides a solution to the optimal control problem for the Player I, i.e. for

$$
\left\{\begin{array}{l}
\max _{\left(\mathbf{u}_{1}, \mathbf{u}_{2}^{*}\right) \in \mathcal{A}_{O L}} \int_{0}^{T} f_{1}\left(t, \mathbf{x}(t), \boldsymbol{\nu}_{1}\left(t, \mathbf{x}_{0}\right), \boldsymbol{\nu}_{2}^{*}\left(t, \mathbf{x}_{0}\right)\right) \mathrm{d} t+\psi_{1}(\mathbf{x}(T)) \\
\dot{\mathbf{x}}(t)=g\left(t, \mathbf{x}(t), \boldsymbol{\nu}_{1}\left(t, \mathbf{x}_{0}\right), \boldsymbol{\nu}_{2}^{*}\left(t, \mathbf{x}_{0}\right)\right) \\
\mathbf{x}(0)=\mathbf{x}_{0}
\end{array}\right.
$$

with $\mathbf{u}_{1}(t)=\boldsymbol{\nu}_{1}(t, \mathbf{x}(t)) ;$

II the control $\mathbf{u}_{2}^{*}$ provides an optimal open-loop control for the problem for the Player II, i.e. for

$$
\left\{\begin{array}{l}
\max _{\left(\mathbf{u}_{1}^{*}, \mathbf{u}_{2}\right) \in \mathcal{A}_{O L}} \int_{0}^{T} f_{2}\left(t, \mathbf{x}(t), \boldsymbol{\nu}_{1}^{*}\left(t, \mathbf{x}_{0}\right), \boldsymbol{\nu}_{2}\left(t, \mathbf{x}_{0}\right)\right) \mathrm{d} t+\psi_{2}(\mathbf{x}(T)) \\
\dot{\mathbf{x}}(t)=g\left(t, \mathbf{x}(t), \boldsymbol{\nu}_{1}^{*}\left(t, \mathbf{x}_{0}\right), \boldsymbol{\nu}_{2}\left(t, \mathbf{x}_{0}\right)\right) \\
\mathbf{x}(0)=\mathbf{x}_{0}
\end{array}\right.
$$

$$
\text { with } \mathbf{u}_{2}(t)=\boldsymbol{\nu}_{2}\left(t, \mathbf{x}_{0}\right)
$$

In order to find a pair of open-loop strategies $\left(\mathbf{u}_{1}^{*}, \mathbf{u}_{2}^{*}\right)$ yielding a Nash equilibrium, it is reasonable to introduce

$$
\begin{align*}
& H_{1}\left(t, \mathbf{x}, \mathbf{u}_{1}, \mathbf{u}_{2}, \boldsymbol{\lambda}_{1}\right)=f_{1}\left(t, \mathbf{x}, \mathbf{u}_{1}, \mathbf{u}_{2}\right)+\boldsymbol{\lambda}_{1} \cdot g\left(t, \mathbf{x}, \mathbf{u}_{1}, \mathbf{u}_{2}\right)  \tag{2.2}\\

A necessary condition for optimality is given by Theorem A.1, taking into account that since $T$ is fixed and the final value of the trajectory is free we can assume that the control is normal (see Theorem 6.13 in [2]):

Theorem 2.1. Let us consider the problem 2.1) with $f_{i}, \psi_{i}$ and $g$ in $C^{1}$. Let $\left(\mathbf{u}_{1}^{*}, \mathbf{u}_{2}^{*}\right)$, with $\mathbf{u}_{i}(t)=\boldsymbol{\nu}_{i}\left(t, \mathbf{x}_{0}\right)$, be a Nash equilibrium in the class of open-loop strategies. Let $\mathbf{x}^{*}$ be the associated trajectory.
Then there exists a continuous multiplier $\boldsymbol{\lambda}_{i}^{*}:[0, T] \rightarrow \mathbb{R}^{n}$, with $i=1,2$, such that
i) for all $t \in[0, T]$ we have

ii) in $[0, T]$ we have $\dot{\boldsymbol{\lambda}}_{1}^{*}=-\nabla_{\mathbf{x}} H_{1}\left(t, \mathbf{x}^{*}, \mathbf{u}_{1}^{*}, \mathbf{u}_{2}^{*}, \boldsymbol{\lambda}_{1}^{*}\right), \quad \dot{\boldsymbol{\lambda}_{2}^{*}}=-\nabla_{\mathbf{x}} H_{2}\left(t, \mathbf{x}^{*}, \mathbf{u}_{1}^{*}, \mathbf{u}_{2}^{*}, \boldsymbol{\lambda}_{2}^{*}\right)$;
iii) we have $\boldsymbol{\lambda}_{1}^{*}(T)=\nabla_{\mathbf{x}} \psi_{1}\left(\mathbf{x}^{*}(T)\right), \quad \boldsymbol{\lambda}_{2}^{*}(T)=\nabla_{\mathbf{x}} \psi_{2}\left(\mathbf{x}^{*}(T)\right)$.

Since Theorem A. 1 gives only a necessary condition for optimality, we have to consider sufficient results such as Mangasarian's sufficient conditions (see TheoremA.2) or Arrow's sufficient conditions (see Theorem A.3), in order to be sure the couple of controls $\left(\mathbf{u}_{1}^{*}, \mathbf{u}_{2}^{*}\right)$ stands for an open-loop Nash equilibrium.

### 2.1.1 Workers versus capitalists

This model is due to Lancaster (see [15]). Let us denote by $k=k(t)$ the capital stock of the economy, and the rate of production is proportional to $k$, i.e. the production at time $t$ is $\alpha k(t)$, with $\alpha>0$ fixed. Within the limits $a$ and $b$, workers decide their share $u=u(t)$ of production; the remaining production $(1-u) \alpha k$ is controlled by the capitalists, who invest a fraction $v=v(t)$ and consume the other portion, i.e. $(1-v)(1-u) \alpha k$. Both workers and capitalists want to maximize their own total consumption.

Although workers usually do gain future benefits from investments, their willingness to sacrifice consumption can be exploited to the capitalists. On the other hand, a willingness to invest will be less effective if the workers too soon press their share towards the limit $b$. The final time $T$ is fixed. We choose the time unit such that the constant of proportionality $\alpha$ is 1 .

We have the Hamiltonians

where in order to obtain 2.3 and 2.4 we use that $k(t) \geq k_{0}>0$ since $\dot{k} \geq 0$. We note that $u$ and $v$ in (2.3) and (2.4) do not depend on the trajectory $k$ : hence we are in the position to looking for a open-loop solution.
It is easy to see that (2.4) implies that

This gives that $\lambda_{1}(t)>1$ for $t \in[\tau-\varepsilon, \tau)$ for some positive $\varepsilon$ : now, replacing the same arguments we obtain that $\lambda_{1}(t)>1$ in $[0, \tau]$. Hence, this inequality and 2.13 give by 2.3 that $u(t)=a$ in $[0, \tau]$. We obtain that the candidate to be a Nash equilibrium is $\left(u^{*}, v^{*}\right)$ with

In order to prove that $\left(u^{*}, v^{*}\right)$ is really a Nash equilibrium, we remark that $(k, u) \mapsto H_{1}\left(t, k, u, v^{*}, \lambda_{1}^{*}\right)$ and $(k, v) \mapsto H_{2}\left(t, k, u^{*}, v, \lambda_{2}^{*}\right)$ are not concave functions (for fixed $t$ ) and hence we are not in the position to apply Theorem A.2; however, if we construct the maximized Hamiltonian functions $H_{1}^{0}$ and $H_{2}^{0}$ for $H_{1}$ and $H_{2}$ respectively, we obtain

it is easy to verify that such two functions are concave in $k$, for fixed $t$, and hence Theorem A. 3 guarantees that $\left(u^{*}, v^{*}\right)$ is a Nash equilibrium.

- $b<\frac{1}{2}$ : Note that $\lambda_{1}(\tau)=\frac{b}{1-b}<1$; then there exists $\tau^{\prime} \in[0, \tau)$ such that

Definition 2.2. A pair of control functions $\left(\mathbf{u}_{1}^{*}, \mathbf{u}_{2}^{*}\right) \in \mathcal{A}_{F B}$, with decision rule $\mathbf{u}_{i}^{*}(t)=\boldsymbol{\nu}_{i}^{*}\left(t, \mathbf{x}^{*}(t)\right)$ and trajectory $\mathbf{x}^{*}$ such that

is a Nash equilibrium within the class of feedback strategies $\mathcal{A}_{F B}$ for the game (2.1) if the following holds:

I the control $\mathbf{u}_{1}^{*}$ provides an optimal feedback control to the problem for the first Player, i.e. for

## Variational approach is not useful

Let us suppose that we are interesting on finding a feedback solution using the variational method: we will show that the Pontryagin necessary condition is much more complicated and it is not useful. In order to do that, let us suppose that $\left(\mathbf{u}_{1}^{*}, \mathbf{u}_{2}^{*}\right) \in \mathcal{A}_{F B}$, where $\mathbf{u}_{i}^{*}(t)=\boldsymbol{\nu}_{i}^{*}\left(t, \mathbf{x}^{*}(t)\right)$, is a Nash equilibrium within the class of feedback strategies, with $\mathbf{x}^{*}$ its trajectory. Without lost of generality, we assume that $n=k_{1}=k_{2}=1$; moreover, we assume $U_{1}=U_{2}=\mathbb{R}$ and $f_{i}, g$ and $\psi_{i} C^{1}$ functions. Hence we have $(t, x) \mapsto\left(\nu_{1}^{*}(t, x), \nu_{2}^{*}(t, x)\right) \in \mathbb{R}^{2}$ measurable function such that $x^{*}$ is the solution of the ODE

Let us put our attention on the first Player and we fix a continuous function $h:[0, T] \rightarrow \mathbb{R}$ and for every constant $\epsilon \in \mathbb{R}$ we define the new decision rule $\nu_{1, \epsilon}$ for the first Player by

Since $\left(u_{1}^{*}, u_{2}^{*}\right)$ is a Nash equilibrium, for the first Player we have that optimal $\mathcal{J}_{h}(0) \geq \mathcal{J}_{h}(\epsilon)$, for every $\epsilon$, and hence $\frac{\mathrm{d} \mathcal{J}_{h}}{\mathrm{~d} \epsilon}(0)=0$. Classical calculation gives

We note that the bad new is the term $\frac{\partial H_{1}}{\partial u_{2}}\left(t, x^{*}, u_{1}^{*}, u_{2}^{*}, \lambda_{1}\right) \frac{\partial \nu_{2}^{*}}{\partial x}\left(t, x^{*}\right)$ that arrives from the fact that we are working with feedback controls, i.e. $\nu_{2}^{*}(t, x)$. In [10] (see Theorem 7.1) and in [12] (see Theorem 2.2) appear sufficient conditions for a particular type of games in order to obtain a feedback Nash equilibrium using the variational approach: such conditions are not really useful.

## With the Dynamic Programming approach

Let us start with the definition of the value function that, with respect to the situation of optimal control problems, it must be specialized:

Definition 2.3. Let's suppose that a pair of control functions $\left(\mathbf{u}_{1}^{*}, \mathbf{u}_{2}^{*}\right) \in \mathcal{A}_{F B}$, where $\mathbf{u}_{i}^{*}(t)=\boldsymbol{\nu}_{i}^{*}\left(t, \mathbf{x}^{*}(t)\right)$, is a Nash equilibrium within the class of feedback strategies $\mathcal{A}_{F B}$ for the game 2.1). Then we define the value functions $V_{i}:[0, T] \times \mathbb{R}^{n} \rightarrow[-\infty,+\infty]$, for Player $i$, by

where $\mathbf{u}_{1}(t)=\boldsymbol{\nu}_{1}(t, \mathbf{x}(t))$. Similarly, we define

Some comments: first we remark that such definition is on a Nash equilibrium. Second, to be clear, in the definition of $V_{1}$ we consider the sup on all the feedback controls $\mathbf{u}_{1}$, with $\mathbf{u}_{1}(t)=\boldsymbol{\nu}_{1}(t, \mathbf{x}(t)$ ), where (for the fixed feedback decision rule $\mathbf{u}_{2}^{*}$ ) $\mathbf{x}$ is the unique solution of

The existence of such solution is not guarantee and hence $V_{1}(\tau, \boldsymbol{\xi})$ can be $-\infty$. Similar situation appears in definition of $V_{2}$.

Now, we are in the position to apply the Dynamic Programming results. Let us suppose that the value functions $V_{i}$, defined on a feedback Nash equilibrium ( $\mathbf{u}_{1}^{*}, \mathbf{u}_{2}^{*}$ ) with trajectory $\mathbf{x}^{*}$, are continuously differentiable. The idea is to write the Bellman-Hamilton-Jacobi system for the first player with its value function $V_{1}$ and the Bellman-Hamilton-Jacobi system for the second player with its value function $V_{2}$, i.e.

Then $\mathbf{x}^{*}$ is the optimal trajectory and $\left(\mathbf{u}_{1}^{*}, \mathbf{u}_{2}^{*}\right)$ is a Nash equilibrium in the class $\mathcal{A}_{F B}$.
A similar sufficient conditions appears in [10] (see Theorem 7.2) and in [12] (see Theorem 2.1).

Now let us consider a particular type of games: we say that a two person differential games is LinearQuadratic if

where $\mathbf{v}^{\prime}$ is the transpose of the matrix $\mathbf{v}$; we denote the trajectory $\mathbf{x}$ and the control $\mathbf{u}$ such that $\mathbf{x}=$ $\left(x_{1}, x_{2}, \ldots, x_{n}\right)^{\prime}$ and $\mathbf{u}_{i}=\left(u_{i, 1}, u_{i, 2}, \ldots, u_{i, k_{i}}\right)^{\prime}$ respectively; with $Q_{i}=Q_{i}(t)$ and $P_{i}=P_{i}(t)$ symmetric matrices, and $R_{i, j}=R_{i, j}(t), A=A(t), B_{i}=B_{i}(t)$ and $C=C(t)$ matrices. We have the following result (see [2]):

More precisely, since $f$ and $g$ do not depend on $t$, it is possible to prove (as in a optimal control problem) that the existence of the value function ( $V_{1}, V_{2}$ ) that satisfies the BHJ system is equivalent to the existence of the current value function $\left(V_{1}^{c}, V_{2}^{c}\right)$ that satisfies a current BHJ system: moreover

### 2.2.3 Two firms in competition

Suppose two firms produce an identical product. The cost of producing is governed by the total cost function

The relationship between the total amount of production $u_{1}+u_{2}$ supplied and the change in price is described by

with the rate of discount $r$ that is a positive constant. Note that it is a symmetric game. We are interested on a non zero Nash equilibrium in the family of feedback strategies, i.e. strategies for the two firms that depend, at every time, on the price $p(t)$.

With a infinite and discounted problems, it is convenient to introduce the current value functions $V_{1}^{c}=$ $V_{1}^{c}(p)$ and $V_{2}^{c}=V_{2}^{c}(p)$ and their Bellman-Hamilton-Jacobi equations: for every $p$ we have

& s^{2} \gamma_{2}^{2}+\left(-r-6 s+2 s^{2} \gamma_{1}\right) \gamma_{2}+1=0
\end{align*}
$$

- Let us prove that $\gamma_{1}=\gamma_{2}$ : in order to do that, let us subtract the previous two equation obtaining

If $A=0$, then $p(t)=p_{0}$ is constant; relation 2.21) give $u_{i}^{*}(t)=\nu_{i}^{*}\left(p_{0}\right)$ and this is not a feedback strategy. Hence $\gamma_{1} \neq \gamma_{2}$ is impossible.

From now on, let us simplify the notations setting $\gamma=\gamma_{1}=\gamma_{2}$. The price, by 2.28), now is

Let us set $\widetilde{k}=\frac{a+2 c+2 s \beta}{3-2 s \gamma_{-}}$. It is easy to see, using $\beta>0$, that $\widetilde{k}>0$ and hence the shape of the trajectoryprice function in 2.36 implies that

Clearly $R$ depends on the constants involved in the model. More precisely, our trajectory $p^{*}$ lies is this region $R$ if and only if, again by the shape of $p^{*}$ in 2.36 , the following

However, if (2.37) is satisfied, then Remark 2.2 guarantees that $\left(u_{1}^{*}, u_{2}^{*}\right)$ in 2.35) is a Nash equilibrium in the family of feedback strategies.

### 2.3 Further examples and models

### 2.3.1 Two fishermen at the lake

In the present model (see [13], page 285) we will see that the open-loop Nash equilibrium and the feedback Nash equilibrium coincide.
The model. Suppose that the evolution of the stock of fish $x=x(t)$ in a lake is governed by

$$
\dot{x}=\alpha x-\beta x \ln x
$$

for $t \geq 0$ and where $\alpha$ and $\beta$ are positive constants. We assume that $x(t) \geq 2$, one of each gender, for the fish population to survive and $x(0)=x_{0} \geq 2$. At every time, the stock $x$ generates $\alpha x$ births and it has $\beta x \ln x$ deaths.

Two fishermen harvest fish from the lake and each fisherman's catch $c_{i}$ is directly related to the level of effort $w_{i}=w_{i}(t)$ he devotes to this activity and the stock of fish: thus

$$
c_{i}=x_{i} w_{i} .
$$

Clearly, the fisherman's activity reduced the fish stock in the lake and with respect the equation of the evolution of the fish we have

$$
\dot{x}=\alpha x-\beta x \ln x-w_{1} x-w_{2} x .
$$

Each fisherman derives satisfaction from his catch according to a log utility function $U_{i}$ as

$$
U_{i}=a_{i} \ln \left(w_{i} x\right),
$$

where $a_{i}$ are positive constants, in an infinite period. Hence we will introduce a discount factor $e^{-r t}$, with $r>0$, for such utility.

It is convenient for computations to set $y(t)=\ln x(t)$ : hence $\dot{y}=\frac{\dot{x}}{x}$. the target of very player-fisherman is to realize

since $a_{i}>0$. Hence we have the following symmetric game ${ }^{2}$

Let us assume for simplicity

We are interested on non zero Nash equilibria in the class of open-loop strategies and in the class of feedback strategies.
Open-loop Nash equilibrium. $\sqrt[3]{ }$ Let us introduce the two current Hamiltonians:

We claim that the case $A=B=0$ is the unique candidate to a be a Nash equilibrium. In order to prove that, first we put $A<0$ and, for $t$ sufficiently large, we obtain $w_{1}^{A}<0$ which is impossible. The case $B<0$ is similar. Now, let us suppose that $A$ and $B$ are non negative; note in this case 2.43) hold: we want to prove that

We recall that in order to guarantee some sufficient condition of optimality in a infinite horizon problem (see subsection A.1.1), we require that $\lim _{t \rightarrow \infty} \boldsymbol{\lambda}^{*}(t) \cdot\left(\mathrm{x}(t)-\mathrm{x}^{*}(t)\right) \geq 0$ where $\boldsymbol{\lambda}^{*}$ is the multiplier, x a generic trajectory and $\mathbf{x}^{*}$ the trajectory candidate to the optimal. Since $\lambda_{i}^{*}(t)=e^{-r t} \lambda_{i c}^{*}(t)=e^{-r t} /(\beta+r)$, this sufficient condition for the $i$-problem is

Feedback Nash equilibrium. Let us introduce the two current value functions $V_{1}^{c}=V_{1}^{c}(y)$ and $V_{2}^{c}=$ $V_{2}^{c}(y)$ : the BHJ equations are

We obtain that we realize the previous two max for

### 2.3.2 On international pollution

We denote by $u_{i}=u_{i}(t)$, for $i=1,2$, the level of emissions of two economies and let $x=x(t)$ be the stock of pollution at time $t$. The system has a (little) capacity to self-cleaning; let us fix $\alpha \in(0,1)$ such that $\dot{x}=-\alpha x$ describes this capacity of the system.
The damage of the emission is quadratic with respect to $x$ with coefficients $\frac{1}{2} \phi_{i}$, for every $i$-player, and we suppose that the utility for the $i$-economy related to its emission $u_{i}$ is given by the concave function $u_{i}\left(k_{i}-\frac{1}{2} u_{i}\right)$, with $k_{i}$ positive constants. Hence we have

with the rate of discount $r$ that is a positive constant. This model is proposed in [6].
Open loop Nash equilibrium, in the general case. Let us introduce the two current Hamiltonians:

## Chapter 3

## Stackelberg equilibria

In 1934, von Stackelberg introduced a concept of a hierarchical solution for markets where some firms have power of domination over others. This solution concept is now known as the Stackelberg equilibrium or the Stackelberg solution which, in the context of two-persons nonzero-sum games, involves players with asymmetric roles, one leading (accordingly called the Leader) and the other one following (called the Follower). Some references are chapter 5 in [5] and section 2.6 in [12].

In all this chapter we are considering the following hierarchy two-person game

where $T$ is fixed and $\left(\mathbf{u}_{L}, \mathbf{u}_{F}\right)$ is an admissible control, i.e. depending on the information structure. We assume that the control sets for the Leader and for the Follower are $U_{L}$ and $U_{F}$ respectively, closed. In this chapter we restrict our attention on problems with the final time $T$ fixed and the final value of the trajectory $\mathbf{x}(T)$ free.

### 3.1 Open-loop Stackelberg equilibria

Let us consider a open-loop strategy $\mathbf{u}_{L}$, with $\mathbf{u}_{L}(t)=\boldsymbol{\nu}_{L}\left(t, \mathbf{x}_{0}\right)$, for the Leader. We define the set of best possible replies of the Follower $\mathcal{R}^{F}\left(\mathbf{u}_{L}\right)$ in the family of the open-loop strategies, where the Leader has already announced the strategy $\mathbf{u}_{L}$, as

Definition 3.1. A pair of control functions $\left(\mathbf{u}_{L}^{*}, \mathbf{u}_{F}^{*}\right) \in \mathcal{A}_{O L}$, with $\mathbf{u}_{L}^{*}(t)=\boldsymbol{\nu}_{L}^{*}\left(t, \mathbf{x}_{0}\right)$ and $\mathbf{u}_{F}^{*}(t)=\boldsymbol{\nu}_{F}^{*}\left(t, \mathbf{x}_{0}\right)$, is a Stackelberg equilibrium within the class of open-loop strategies $\mathcal{A}_{O L}$ if
i. $\mathbf{u}_{F}^{*} \in \mathcal{R}^{F}\left(\mathbf{u}_{L}^{*}\right)$, with associated trajectory $\mathbf{x}^{*}$;
ii. given any open-loop strategy $\mathbf{u}_{L}$ for the Leader and every best reply $\mathbf{u}_{F} \in \mathcal{R}^{F}\left(\mathbf{u}_{L}\right)$ for the Follower, the following holds

Now, let us consider the point of view of the Leader. Clear, up to now we are discussing only of sufficient conditions of optimality for the two problems (3.2) and (3.7): in order to find a Stackelberg equilibrium for (3.1) we have to guarantee some sufficient conditions for the two mentioned previous problems.

### 3.1.1 On international pollution with hierarchical relations

Let us denote by $u_{L}=u_{L}(t)$ and $u_{F}=u_{F}(t)$ the level of emissions of two economies, where the first (the Leader) has a sort of domination with respect to the second economy (the Follower); for example, this is the situation that occurs when the Follower has a big debit with the Leader. Now, as in subsection 2.3.2, let $x=x(t)$ be the stock of pollution at time $t, \alpha \in(0,1)$ is the coefficient of capacity to self-cleaning of the

[^4]system. The damage of the emission is quadratic with respect to $x$ with coefficients $\frac{1}{2} \phi_{L}$ and $\frac{1}{2} \phi_{F}$, and we suppose that the utility for the the two economies related to its emission are quadratic. As in subsection 2.3 .2 , we have

Note that (3.41) and (3.42) imply $\lambda_{2 L c}(t)=0$. Moreover the two conditions (3.39)-(3.40) are exactly the same of the two conditions (3.29)-(3.30): all the same arguments of before used to obtain the strategy for the follower in 3.38 can be used to show that the candidate to be the optimal strategy for the Leader, the associated trajectory and multiplier are

we know that $\left(w_{L}^{*}, w_{F}^{*}\right) \in \mathcal{A}_{O L}$; in order to conclude our problem, we have to prove that $\mathcal{R}^{F}\left(w_{L}^{*}\right)=\left\{w_{F}^{*}\right\}$ and that $w_{L}$ is optimal for the point of view of the Leader. In order to do that, note that

## Chapter 4

## Two-persons zero-sum games

We are interested in the game

where $T$ is fixed and $U_{1}$ and $U_{2}$ are the two closed control sets for the players.
Note that Player I, whose control is $\mathbf{u}_{1}$, wants to maximize the functional $J$; Player II has the control $\mathbf{u}_{2}$ and wants to minimize $J$. This is a two-persons zero-sum differential game. In this context

Definition 4.1. A pair of control functions $\left(\mathbf{u}_{1}^{*}, \mathbf{u}_{2}^{*}\right) \in \mathcal{A}_{O L}$, with $\mathbf{u}_{i}^{*}(t)=\boldsymbol{\nu}_{i}^{*}\left(t, \mathbf{x}_{0}\right)$, is a Nash equilibrium within the class of open-loop strategies $\mathcal{A}_{O L}$ for (4.1) if

A pair of control functions $\left(\mathbf{u}_{1}^{*}, \mathbf{u}_{2}^{*}\right) \in \mathcal{A}_{F B}$, where $\mathbf{u}_{i}^{*}(t)=\boldsymbol{\nu}_{i}^{*}\left(t, \mathbf{x}^{*}(t)\right)$, is a Nash equilibrium within the class of feedback strategies $\mathcal{A}_{F B}$ for (4.1) if (4.2) holds for every $\left(\mathbf{u}_{1}, \mathbf{u}_{2}^{*}\right) \in \mathcal{A}_{F B}$ and for every $\left(\mathbf{u}_{1}^{*}, \mathbf{u}_{2}\right) \in \mathcal{A}_{F B}$.

Relation (4.2) implies that $\left(\mathbf{u}_{1}^{*}, \mathbf{u}_{2}^{*}\right)$ is a saddle-point for $J$.

### 4.1 Open-loop Nash equilibria with the variational approach

In this case, the variational approach is useful and the Pontryagin necessary condition is as follows (see Theorem 6.13 in [2]):

Theorem 4.1. Let us consider the problem (4.1) with $f, g$ and $\psi$ in $C^{1}$. Let $\left(\mathbf{u}_{1}^{*}, \mathbf{u}_{2}^{*}\right) \in \mathcal{A}_{O L}$ be a Nash equilibrium with $\mathbf{x}^{*}$ associated trajectory.

where $H$ is the Hamiltonian function $H$ defined $b y^{1}$

Now, in order to give sufficient conditions to obtain a Nash equilibrium in the class $\mathcal{A}_{O L}$, we apply Theorem A. 2 and A.3 to the two players, taking into account that the first one maximizes, while the second minimizes.

In some situation, there exists a Nash equilibrium with the class of feedback strategies for the problem (4.1), while the Nash equilibrium in the class of the open-loop strategies does not exists (see for example "the lady in the lake" in subsection 4.4.1). In this situation the previous Theorem 4.1 and the variational approach is not useful for the reasons explained in subsection 2.2. Even if an open-loop Nash equilibrium does not exists, a version of the previous theorem can still be utilized to obtain the feedback Nash equilibrium: let us give the details since this approach is largely adopted in the literature for solving pursuit-evasion games. Let $\left(\mathbf{u}_{1}^{*}, \mathbf{u}_{2}^{*}\right) \in \mathcal{A}_{F B}$, where

We assume that there exists a Nash equilibrum within the class of feedback strategies $\left(\mathbf{u}_{1}^{*}, \mathbf{u}_{2}^{*}\right) \in \mathcal{A}_{F B}$, with $\mathbf{u}_{i}^{*}(t)=$ $\boldsymbol{\nu}_{i}^{*}\left(t, \mathbf{x}^{*}(t)\right)$, with $\mathbf{x}^{*}$ associated trajectory. Let us consider its open-loop representation in 4.4). Then there exists a continuous multiplier $\boldsymbol{\lambda}^{*}:[0, T] \rightarrow \mathbb{R}^{n}$ such that i.-iii. in Theorem 4.1 are satisfied.

This result will play a fundamental role in "the lady in the lake" in subsection 4.4.1.

### 4.1.1 War of attrition and attack

This model is due to Isaacs (see section 5.4 in [11] and page 91 in [7]). We assume that two opponents $A$ and $B$ are at war with each other, for a very long time. Let us define $x_{1}=x_{1}(t)$ and $x_{2}=x_{2}(t)$ the supply of resources for $A$ and $B$ respectively, at time $t$. Each player at each time can devote some fraction of the efforts, $(\alpha=\alpha(t)$ for Player $A, \beta=\beta(t)$ Player for $B)$ to attrition ( $=$ guerrilla warfare, for example to destroy the production of resources of the competitor) and the remaining fraction ( $1-\alpha$ and $1-\beta$ respectively) to direct attack. Clearly $\alpha$ and $\beta$ have values in $[0,1]$.

Let us introduce $m_{i}$ the constant rate of production of war material for the two players, $c_{1}$ the effectiveness of $B$ 's weapons against $A$ 's production and $c_{2}$ the effectiveness of $A$ 's weapons against $B$ 's production. We will assume $c_{2}>c_{1}$, a hypothesis that introduces an asymmetry into the problem. The dynamics are governed by the system of ODE

The final time $T$ is very large and fixed. Note that it is reasonable to require that $x_{i}(t)>0$ but, since it is strictly related to the constants involved in the game, we remove it.

Let us looking for some Nash equilibrium in the family of open-loop strategies. Using the variational approach, the Hamiltonian $H=H\left(t, x_{1}, x_{2}, \alpha, \beta, \lambda_{1}, \lambda_{2}\right)$ is

Since $\left(\alpha^{*}, \beta^{*}\right)$ is constant, except two points, and consequently the dynamics is linear in $\left(x_{1}, x_{2}\right)$ with constant coefficients, except such two points, then there exists a unique solution $\left(x_{1}^{*}, x_{2}^{*}\right)$ of such ODE with initial data $x_{i}(0)=x_{i 0}$ and the strategy ( $\alpha^{*}, \beta^{*}$ ) is admissible. Let $\boldsymbol{\lambda}^{*}=\left(\lambda_{1}^{*}, \lambda_{2}^{*}\right)$ be the multiplier obtained by the previous calculations.

Let us note that the function $\left(t, x_{1}, x_{2}, \alpha, \beta\right) \mapsto H\left(t, x_{1}, x_{2}, \alpha, \beta, \lambda_{1}^{*}(t), \lambda_{2}^{*}(t)\right)$, for a fixed $t$, is not concave in ( $x_{1}, x_{2}, \alpha$ ) variable and convex in ( $x_{1}, x_{2}, \beta$ ) variable: let us use Theorem A.3 in order to guarantee some sufficient condition of optimality. First we consider the maximed Hamiltonian for the Player A:

\begin{aligned}
H_{A}^{0}\left(t, x_{1}, x_{2}, \lambda_{1}^{*}(t), \lambda_{2}^{*}(t)\right) & =\max _{a \in[0,1]} H\left(t, x_{1}, x_{2}, a, \beta^{*}(t), \lambda_{1}^{*}(t), \lambda_{2}^{*}(t)\right) \\
& =x_{2} \beta^{*}(t)\left(1-c_{1} \lambda_{1}^{*}(t)\right)+x_{1}-x_{2}+m_{1} \lambda_{1}^{*}(t)+m_{2} \lambda_{2}^{*}(t)+x_{1}\left[\max _{a \in[0,1]} a\left(-1-c_{2} \lambda_{2}^{*}(t)\right)\right]
\end{aligned}
$$

It is easy to see that, for every fixed $t$, the function $\left(x_{1}, x_{2}\right) \mapsto H_{A}^{0}\left(t, x_{1}, x_{2}, \lambda_{1}^{*}(t), \lambda_{2}^{*}(t)\right)$ is linear and hence concave in $\left(x_{1}, x_{2}\right)$ : hence $\alpha^{*}$ is really a optimal solution for the max problem of the First Player, with $\beta^{*}$ fixed. A similar argument holds for the minimized Hamiltonian

$$
H_{B}^{0}\left(t, x_{1}, x_{2}, \lambda_{1}^{*}(t), \lambda_{2}^{*}(t)\right)=\min _{b \in[0,1]} H\left(t, x_{1}, x_{2}, \alpha^{*}(t), b, \lambda_{1}^{*}(t), \lambda_{2}^{*}(t)\right),
$$

showing that, for every fixed $t$, the function $\left(x_{1}, x_{2}\right) \mapsto H_{B}^{0}\left(t, x_{1}, x_{2}, \lambda_{1}^{*}(t), \lambda_{2}^{*}(t)\right)$ is linear and hence convex in $\left(x_{1}, x_{2}\right)$. Hence $\beta^{*}$ is a optimal solution for the min problem of the Player B, with $\alpha^{*}$ fixed. We obtain that $\left(\alpha^{*}, \beta^{*}\right)$ is a Nash equilibrium in the class of open-loop strategies.

### 4.2 An introduction to upper and lower value functions with the DP

We intend now to study Nash equilibria in the class of feedback strategies; in this context we know that the variational approach is not useful (see subsection 2.2). The idea is to use the Dynamic Programming (DP) and to study the value functions. However, the general theory about the value functions with respect to the feedback strategies is very complicated and long: since our aim is to give only an idea of the problems and the tools, in this section we concentrate our attention only on open-loop strategies with Dynamic Programming approach. The definitions and the proofs of the main results are mostly based on the Belmann-Hamilton-Jacobi equations and such results can be generalized in the class $\mathcal{A}_{F B}$ (see for example chapter 8 in [1]). In the next sections we will consider the class $\mathcal{A}_{F B}$, using the idea and generalizations of this section.

### 4.2.1 Upper and lower value functions for open-loop strategies

Let us consider the problem (4.1) and the following two assumptions:

1. $f:[0, T] \times \mathbb{R}^{n} \times U_{1} \times U_{2} \rightarrow \mathbb{R}$ and $g:[0, T] \times \mathbb{R}^{n} \times U_{1} \times U_{2} \rightarrow \mathbb{R}^{n}$ and $\psi: \mathbb{R}^{n} \rightarrow \mathbb{R}$ are bounded and uniformly continuous with

$$
\begin{aligned}
& \left|f\left(t, \mathbf{x}, \mathbf{u}_{1}, \mathbf{u}_{2}\right)\right| \leq C_{1} \quad\left|f\left(t, \mathbf{x}, \mathbf{u}_{1}, \mathbf{u}_{2}\right)-f\left(t, \mathbf{x}^{\prime}, \mathbf{u}_{1}, \mathbf{u}_{2}\right)\right| \leq C_{1}\left\|\mathbf{x}-\mathbf{x}^{\prime}\right\|, \\
& \left\|g\left(t, \mathbf{x}, \mathbf{u}_{1}, \mathbf{u}_{2}\right)\right\| \leq C_{1} \quad\left\|g\left(t, \mathbf{x}, \mathbf{u}_{1}, \mathbf{u}_{2}\right)-g\left(t, \mathbf{x}^{\prime}, \mathbf{u}_{1}, \mathbf{u}_{2}\right)\right\| \leq C_{1}\left\|\mathbf{x}-\mathbf{x}^{\prime}\right\|, \\
& |\psi(\mathbf{x})| \leq C, \quad\left|\psi(\mathbf{x})-\psi\left(\mathbf{x}^{\prime}\right)\right| \leq C\left\|\mathbf{x}-\mathbf{x}^{\prime}\right\|,
\end{aligned}
$$

for some constant $C$ and for every $\mathbf{x}, \mathbf{x}^{\prime} \in \mathbb{R}^{n}, \mathbf{u}_{1} \in U_{1}, \mathbf{u}_{2} \in U_{2}$;
2. the control sets $U_{i}$ are compacts; more precisely we assume $U_{i} \subset B_{\mathbb{R}^{k_{i}}}\left(0, R_{i}\right)$ for some fixed and positive $R_{i}$.

For the Player I, let us introduce the set of controls at time $\tau$, with $\tau \in[0, T]$ fixed, as

$$
\mathcal{U}_{1}(\tau)=\left\{\mathbf{u}_{1}:[\tau, T] \rightarrow U_{1}, \text { measurable }\right\} .
$$

In a similar way, we define $\mathcal{U}_{2}(\tau)=\left\{\mathbf{u}_{2}:[\tau, T] \rightarrow U_{2}\right.$, measurable $\}$.
Remark 4.1. By the previous assumptions 1. on $g$ and 2., for every $(\tau, \boldsymbol{\xi})$ and $\left(\mathbf{u}_{1}, \mathbf{u}_{2}\right) \in \mathcal{U}_{1}(\tau) \times \mathcal{U}_{2}(\tau)$, then $\left(\mathbf{u}_{1}, \mathbf{u}_{2}\right)$ is admissible, i.e. there exists a unique solution $\mathbf{x}$ of

$$
\left\{\begin{array}{l}
\dot{\mathbf{x}}=g\left(t, \mathbf{x}, \mathbf{u}_{1}, \mathbf{u}_{2}\right) \quad \text { for a.e. } t \in[\tau, T] \\
\mathbf{x}(\tau)=\boldsymbol{\xi}
\end{array}\right.
$$

Let us introduce a new notion of strategies that is useful in the zero-sum games, in the particular case of decision rules $\nu_{i}$ for the two players such that they depend only on the time $t$, i.e. $\boldsymbol{\nu}_{i}=\boldsymbol{\nu}_{i}(t)$ :

Definition 4.2. Let us fix $\tau \in[0, T]$. A map

$$
\Phi_{1}: \mathcal{U}_{2}(\tau) \rightarrow \mathcal{U}_{1}(\tau)
$$

is a nonanticipative strategy for the Player I at time $\tau$ if, for any time $t \in[\tau, T]$ and any controls $\mathbf{u}_{2}, \mathbf{u}_{2}^{\prime} \in \mathcal{U}_{2}(\tau)$ such that $\mathbf{u}_{2}=\mathbf{u}_{2}^{\prime}$ almost everywhere in $[\tau, t]$, then we have $\Phi_{1}\left[\mathbf{u}_{2}\right]=\Phi_{1}\left[\mathbf{u}_{2}^{\prime}\right]$ almost everywhere in $[\tau, t]$. We denote by $\mathcal{S}_{1}(\tau)$ the set of such nonanticipative strategies at time $\tau$ for the Player I.

In a symmetric way we denote by $\mathcal{S}_{2}(\tau)$ the set of Player II nonanticipative strategies, which are the nonanticipative maps

$$
\Phi_{2}: \mathcal{U}_{1}(\tau) \rightarrow \mathcal{U}_{2}(\tau)
$$

It is clear that for every $\mathbf{u}_{1} \in \mathcal{U}_{1}(0)$ and $\Phi_{2} \in \mathcal{S}_{2}(0)$ we have that $\left(\mathbf{u}_{1}, \Phi_{1}\left[\mathbf{u}_{1}\right]\right)$ is a open-loop strategy in the class $\mathcal{A}_{O L}$ as in Definition 1.5 for the problem 4.1); similar property holds for $\left(\Phi_{1}\left[\mathbf{u}_{2}\right], \mathbf{u}_{2}\right) \in \mathcal{A}_{O L}$. The simplest example of nonanticipative strategy $\Phi_{1}$ for the Player I at time $\tau$ is the constant one: more precisely, let us fix $\widetilde{\mathbf{u}}_{1} \in \mathcal{U}_{1}(\tau)$ and let us define the constant strategy $\Phi_{1}^{\widetilde{\mathbf{u}}_{1}}$ by

\Phi_{1}^{\widetilde{\mathbf{u}}_{1}}\left[\mathbf{u}_{2}\right]=\widetilde{\mathbf{u}}_{1}, \quad \forall \mathbf{u}_{2} \in \mathcal{U}_{2}(\tau)
$$

For the problem (4.1), in the assumptions 1. and 2., let us define the two value functions as follows (see for example Definition 1.6 of Chapter VIII in [1]):

Definition 4.3. Let us consider the problem (4.1) with the assumptions 1. and 2. The lower value function $V^{-}:[0, T] \times \mathbb{R}^{n} \rightarrow \mathbb{R}$ is defined by

V^{-}(\tau, \boldsymbol{\xi})=\inf _{\Phi_{2} \in \mathcal{S}_{2}(\tau)} \sup _{\mathbf{u}_{1} \in \mathcal{U}_{1}(\tau)} \int_{\tau}^{T} f\left(t, \mathbf{x}, \mathbf{u}_{1}, \Phi_{2}\left[\mathbf{u}_{1}\right]\right) \mathrm{d} t+\psi(\mathbf{x}(T)),
$$

where $\mathbf{x}$ is the trajectory associated to the control $\left(\mathbf{u}_{1}, \Phi_{2}\left[\mathbf{u}_{1}\right]\right) \in \mathcal{U}_{1}(\tau) \times \mathcal{U}_{2}(\tau)$ with initial data $\mathbf{x}(\tau)=\boldsymbol{\xi}$.
The upper value function $V^{+}:[0, T] \times \mathbb{R}^{n} \rightarrow \mathbb{R}$ is defined as

$$
V^{+}(\tau, \boldsymbol{\xi})=\sup _{\Phi_{1} \in \mathcal{S}_{1}(\tau)} \inf _{\mathbf{u}_{2} \in \mathcal{U}_{2}(\tau)} \int_{\tau}^{T} f\left(t, \mathbf{x}, \Phi_{1}\left[\mathbf{u}_{2}\right], \mathbf{u}_{2}\right) \mathrm{d} t+\psi(\mathbf{x}(T))
$$

where $\mathbf{x}$ is the trajectory associated to the control $\left(\Phi_{1}\left[\mathbf{u}_{2}\right], \mathbf{u}_{2}\right) \in \mathcal{U}_{1}(\tau) \times \mathcal{U}_{2}(\tau)$ with initial data $\mathbf{x}(\tau)=\boldsymbol{\xi}$.
Note that assumptions 1. on $g$ and 2., with Remark 4.1, imply that every pair ( $\left.\Phi_{1}\left[\mathbf{u}_{2}\right], \mathbf{u}_{2}\right)$ and $\left(\mathbf{u}_{1}, \Phi_{2}\left[\mathbf{u}_{1}\right]\right)$ is admissible and hence we are considering sup and inf on a nonempty sets; moreover, assumption 1 . on $f$ and $\psi$ implies that $V^{+}$and $V^{-}$are bounded.

One of the two players announces his strategy in response to the other's choice of control, the other player chooses the control. The player who "plays second", i.e., who chooses the strategy, has an advantage. In the definition of $V^{+}$, the Player II choices its nonanticipative strategies $\Phi_{2}$ and "after" the Player I choices its optimal $\mathbf{u}_{1}$. Hence we have that

Remark 4.2. For every $(\tau, \boldsymbol{\xi})$ we have

$$
\begin{equation*}
V^{-}(\tau, \boldsymbol{\xi}) \leq V^{+}(\tau, \boldsymbol{\xi}) \tag{4.16}
\end{equation*}
$$

In general $V^{+}$and $V^{-}$are different functions (as we will see in Example 4.2.1). The next example is in [1]: Example 4.2.1. Let us consider the problem

By definition we have

\begin{aligned}
V^{-}(0, \xi) & =\inf _{\Phi_{2} \in \mathcal{S}_{2}(0)} \sup _{u_{1} \in \mathcal{U}_{1}(0)} \int_{0}^{\infty} \varphi(t, x) \mathrm{d} t \\
V^{+}(0, \xi) & =\sup _{\Phi_{1} \in \mathcal{S}_{1}(0)} \inf _{u_{2} \in \mathcal{U}_{2}(0)} \int_{0}^{\infty} \varphi(t, x) \mathrm{d} t
\end{aligned}
$$

where $f\left(t, x, u_{1}, u_{2}\right)=\varphi(t, x)=\operatorname{sgn}(x)\left(1-e^{-|x|}\right) e^{-t}$ and $x$ is the trajectory associated to $\left(u_{1}, u_{2}\right)$ with $x(0)=\xi$. We show that, for every $\xi \geq 0$, we have

$$
\begin{equation*}
V^{-}(0, \xi)<V^{+}(0, \xi) \tag{4.17}
\end{equation*}
$$

Let us fix $\xi \geq 0$. First we note that the dynamics gives $x(t) \geq \xi$, for every ( $u_{1}, u_{2}$ ). Moreover, it is easy to see that the function $x \mapsto \varphi(t, x)$ is increasing, for every $x \geq 0$ and $t$.

For every $u_{1} \in \mathcal{U}_{1}(0)$, where $\mathcal{U}_{i}(0)=\{u:[0, \infty) \rightarrow[-1,1]$, measurable $\}$, let us consider the nonanticipative strategy $\widetilde{\Phi}_{2}: \mathcal{U}_{1}(0) \rightarrow \mathcal{U}_{2}(0)$ defined by $\widetilde{\Phi}_{2}\left[u_{1}\right]=u_{1}$. Hence the trajectory $x$ associated to such pair $\left(u_{1}, \widetilde{\Phi}_{2}\left[u_{1}\right]\right)$ is the solution of

$$
\left\{\begin{array}{l}
\dot{x}=\left(u_{1}-\widetilde{\Phi}_{2}\left[u_{1}\right]\right)^{2}=0  \tag{4.18}\\
x(0)=\xi
\end{array}\right.
$$

hence $x(t)=\xi$. Clearly, since $x \mapsto \varphi(t, x)$ is increasing and $x(t) \geq \xi$, such particular strategy $\widetilde{\Phi}_{2}$ for the second Player is the best possible (remember that the second Player want to minimize). Hence we obtain

$$
\begin{align*}
V^{-}(0, \xi) & \leq \sup _{u_{1} \in \mathcal{U}_{1}(0)} \int_{0}^{\infty} f\left(t, x, u_{1}, \widetilde{\Phi}_{2}\left[u_{1}\right]\right) \mathrm{d} t \quad \text { (we choose } \Phi_{2}=\widetilde{\Phi}_{2} \text { and, for every } u_{1}, x \text { solves } 4.18 \text { ) } \\
& =\int_{0}^{\infty}\left(1-e^{-\xi}\right) e^{-t} \mathrm{~d} t \\
& =1-e^{-\xi} \tag{4.19}
\end{align*}
$$

Now for every $u_{2} \in \mathcal{U}_{2}(0)$ let us consider the nonanticipative strategy $\widetilde{\Phi}_{1}: \mathcal{U}_{2}(0) \rightarrow \mathcal{U}_{1}(0)$ defined by

$$
\widetilde{\Phi}_{1}\left[u_{2}\right](t)= \begin{cases}+1 & \text { if } u_{2}(t) \leq 0 \\ -1 & \text { if } u_{2}(t)>0\end{cases}
$$

Hence the trajectory $x$ associated to such pair $\left(\widetilde{\Phi}_{1}\left[u_{2}\right], u_{2}\right)$ is the solution of

$$
\left\{\begin{array}{l}
\dot{x}=\left(\widetilde{\Phi}_{1}\left[u_{2}\right]-u_{2}\right)^{2}=\left(1+\left|u_{2}\right|\right)^{2}  \tag{4.20}\\
x(0)=\xi
\end{array}\right.
$$

Clearly, for such particular strategy $\widetilde{\Phi}_{1}$ for the first Player, the optimal control for the second player is $u_{2}=0$; in this case the associated trajectory is $x(t)=\xi+t$. Hence we obtain

$$
\begin{align*}
V^{+}(0, \xi) & \geq \inf _{u_{2} \in \mathcal{U}_{2}(0)} \int_{0}^{\infty} f\left(t, x, \widetilde{\Phi}_{1}\left[u_{2}\right], u_{2}\right) \mathrm{d} t \quad \text { (we choose } \Phi_{1}=\widetilde{\Phi}_{1} \text { and, for every } u_{2}, x \text { solves 4.20) } \\
& \left.=\int_{0}^{\infty}\left(1-e^{-(\xi+t)}\right) e^{-t} \mathrm{~d} t \quad \text { (we choose } u_{2}=0\right) \\
& =1-\frac{e^{-\xi}}{2} \tag{4.21}
\end{align*}
$$

Hence, by 4.19) and 4.21, we obtain

$$
V^{+}(0, \xi) \geq 1-\frac{e^{-\xi}}{2}>1-e^{-\xi} \geq V^{-}(0, \xi), \quad \forall \xi \geq 0
$$

i.e. relation 4.17.

Definition 4.4. We say that the game (4.1) has value function $V:[0, T] \times \mathbb{R}^{n} \rightarrow \mathbb{R}$ when 4.16) is an equality, for every $(\tau, \boldsymbol{\xi})$, and in this case we set

$$
V(t, \mathbf{x})=V^{+}(t, \mathbf{x})=V^{-}(t, \mathbf{x})
$$

for every $(t, \mathbf{x}) \in[0, T] \times \mathbb{R}^{n}$. In this case, $V$ is the value function for the problem 4.1).
Clearly, the problem to guarantees that (4.1) has value function is very interesting and crucial: we will discuss this problem in subsection 4.2.4.

### 4.2.2 Isaacs' condition

In the next subsections we are interested on giving the main ideas of Isaacs theory. Let us start:
Definition 4.5. Let us define the upper Hamiltonian of Dynamic Programming $H_{D P}^{+}:[0, T] \times \mathbb{R}^{2 n} \rightarrow$ $\mathbb{R}$ defined by

$$
H_{D P}^{+}(t, \mathbf{x}, \boldsymbol{\lambda})=\min _{\mathbf{v}_{2} \in U_{2}} \max _{\mathbf{v}_{1} \in U_{1}}\left(f\left(t, \mathbf{x}, \mathbf{v}_{1}, \mathbf{v}_{2}\right)+\boldsymbol{\lambda} \cdot g\left(t, \mathbf{x}, \mathbf{v}_{1}, \mathbf{v}_{2}\right)\right)
$$

and the lower Hamiltonian of Dynamic Programming $H_{D P}^{-}:[0, T] \times \mathbb{R}^{2 n} \rightarrow \mathbb{R}$ defined by

$$
H_{D P}^{-}(t, \mathbf{x}, \boldsymbol{\lambda})=\max _{\mathbf{v}_{1} \in U_{1}} \min _{\mathbf{v}_{2} \in U_{2}}\left(f\left(t, \mathbf{x}, \mathbf{v}_{1}, \mathbf{v}_{2}\right)+\boldsymbol{\lambda} \cdot g\left(t, \mathbf{x}, \mathbf{v}_{1}, \mathbf{v}_{2}\right)\right)
$$

We note that in the definition of $V^{+}$we have a "sup-inf", while in the definition of $H_{D P}^{+}$we have a "minmax".

Remark 4.3. We have

$$
\begin{equation*}
H_{D P}^{-}(t, \mathbf{x}, \boldsymbol{\lambda}) \leq H_{D P}^{+}(t, \mathbf{x}, \boldsymbol{\lambda}) \tag{4.22}
\end{equation*}
$$

Proof. Let us fix $(t, \mathbf{x}, \boldsymbol{\lambda})$ and let us denote by $h$ the function $h\left(\mathbf{v}_{1}, \mathbf{v}_{2}\right)=f\left(t, \mathbf{x}, \mathbf{v}_{1}, \mathbf{v}_{2}\right)+\boldsymbol{\lambda} \cdot g\left(t, \mathbf{x}, \mathbf{v}_{1}, \mathbf{v}_{2}\right)$. Clearly

$$
\min _{\mathbf{v}_{2} \in U_{2}} h\left(\mathbf{v}_{1}, \mathbf{v}_{2}\right) \leq h\left(\mathbf{v}_{1}, \mathbf{v}_{2}\right), \quad \forall\left(\mathbf{v}_{1}, \mathbf{v}_{2}\right) \in U_{1} \times U_{2}
$$

This implies

$$
\max _{\mathbf{v}_{1} \in U_{1}} \min _{\mathbf{v}_{2} \in U_{2}} h\left(\mathbf{v}_{1}, \mathbf{v}_{2}\right) \leq \max _{\mathbf{v}_{1} \in U_{1}} h\left(\mathbf{v}_{1}, \mathbf{v}_{2}\right), \quad \forall \mathbf{v}_{2} \in U_{2}
$$

and hence the thesis.
The next example shows that inequality 4.22 can be strict.

Example 4.2.2. Let us consider the problem in Example 4.2.1. Clearly we have

& H_{D P}^{+}(t, x, \lambda)=\min _{\left|v_{2}\right| \leq 1} \max _{\left|v_{1}\right| \leq 1}\left(\operatorname{sgn}(x)\left(1-e^{-|x|}\right) e^{-t}+\lambda\left(v_{1}-v_{2}\right)^{2}\right)=\operatorname{sgn}(x)\left(1-e^{-|x|}\right) e^{-t}+\min _{\left|v_{2}\right| \leq 1} \max _{\left|v_{1}\right| \leq 1} \lambda\left(v_{1}-v_{2}\right)^{2} \\
& H_{D P}^{-}(t, x, \lambda)=\max _{\left|v_{1}\right| \leq 1} \min _{\left|v_{2}\right| \leq 1}\left(\operatorname{sgn}(x)\left(1-e^{-|x|}\right) e^{-t}+\lambda\left(v_{1}-v_{2}\right)^{2}\right)=\operatorname{sgn}(x)\left(1-e^{-|x|}\right) e^{-t}+\max _{\left|v_{1}\right| \leq 1\left|v_{2}\right| \leq 1} \min \lambda\left(v_{1}-v_{2}\right)^{2}
\end{aligned}
$$

First, let us fix $\lambda$ and $v_{2} \in[1,-1]$ : we have

$$
\max _{\left|v_{1}\right| \leq 1} \lambda\left(v_{1}-v_{2}\right)^{2}= \begin{cases}0 & \text { if } \lambda \leq 0 \\ \lambda\left(1+\left|v_{2}\right|\right)^{2} & \text { if } \lambda>0\end{cases}
$$

and hence

$$
\min _{\left|v_{2}\right| \leq 1} \max _{\left|v_{1}\right| \leq 1} \lambda\left(v_{1}-v_{2}\right)^{2}= \begin{cases}0 & \text { if } \lambda \leq 0  \tag{4.23}\\ \lambda & \text { if } \lambda>0\end{cases}
$$

Now, let us fix $\lambda$ and $v_{1} \in[1,-1]$ : we have

$$
\min _{\left|v_{2}\right| \leq 1} \lambda\left(v_{1}-v_{2}\right)^{2}= \begin{cases}\lambda\left(1+\left|v_{2}\right|\right)^{2} & \text { if } \lambda \leq 0 \\ 0 & \text { if } \lambda>0\end{cases}
$$

and hence

& \max _{\left|v_{1}\right| \leq 1} \min _{\left|v_{2}\right| \leq 1} \lambda\left(v_{1}-v_{2}\right)^{2}= \begin{cases}\lambda & \text { if } \lambda \leq 0 \\
0 & \text { if } \lambda>0\end{cases}  \tag{4.24}\\
& H_{D P}^{-}(t, x, \lambda)<H_{D P}^{+}(t, x, \lambda), \quad \forall \lambda \neq 0
\end{align*}

Inequalities 4.23) and 4.24) give that
The previous example suggests the following definition:
Definition 4.6. We say that the minimax condition, or Isaacs' condition, is satisfied if

At this point we are interested to study the two functions of $V^{+}$and $V^{-}$. Let us start with their regularity.

\leq & \widehat{C}\left(\left\|\boldsymbol{\xi}^{\prime}-\boldsymbol{\xi}\right\|+\left(\tau^{\prime}-\tau\right)\right)+2 \epsilon . \tag{4.33}

Moreover, it gives the possibility to $V^{-}$to be a viscosity solution, as we will see in definition 4.7.

We say that $V$ is a viscosity supersolution of the equation 4.38) if $v$ is a test function in $C^{\infty}\left((0, T) \times \mathbb{R}^{n}\right)$ such that $V-v$ has a local maximum in the point $\left(t_{0}, \mathbf{x}_{0}\right) \in(0, T) \times \mathbb{R}^{n}$ we have

A function that is both a viscosity subsolution and a viscosity supersolution is called viscosity solution.
The following Dynamic Programming optimality condition holds (see Theorem 3.1 in [9])

Also, for every $\boldsymbol{\eta} \in \mathbb{R}^{n}$, by definition of $V^{-}$

& \leq \sup _{\mathbf{u}_{1} \in \mathcal{U}_{1}(\tau)}\left\{\int_{\tau}^{T} f\left(t, \mathbf{x}, \mathbf{u}_{1}, \widehat{\Phi}_{2}\left[\mathbf{u}_{1}\right]\right) \mathrm{d} t+\psi(\mathbf{x}(T))\right\}+2 \epsilon \\
& \leq V^{-}(\tau, \boldsymbol{\xi})+3 \epsilon .
\end{aligned}

This last inequality and 4.43 conclude the proof.
And now we are in the position to give the main property for the two values functions $V^{-}$and $V^{+}$:

B'. $V^{+}$is the unique viscosity solution for (4.48).
The system in 4.48 is called upper Isaacs' equation, while (4.47) is called lower Isaacs' equation. The proof of $A^{\prime}$. is very similar to the proof of $A$. The proofs of $B$. and $B^{\prime}$. are similar but they require a comparison principle for BHJ equation: such very interesting argument is very difficult and long, and it requires another course.
Proof of $A$. It is obvious, by definition, that $V^{-}(T, \mathbf{x})=\psi(\mathbf{x})$, for every $\mathbf{x} \in \mathbb{R}^{n}$. So, let us fix $\left(t_{0}, \mathbf{x}_{0}\right) \in(0, T) \times \mathbb{R}^{n}$.
First part of the proof: $V^{-}$is a supersolution. Let $v \in C^{1}\left((0, T) \times \mathbb{R}^{n}\right)$ be a test function touching $V^{-}$from below at $\left(t_{0}, \mathbf{x}_{0}\right)$, i.e.

& =\inf _{\Phi_{2} \in \mathcal{S}_{2}\left(t_{0}\right)} \sup _{\mathbf{u}_{1} \in \mathcal{U}_{1}\left(t_{0}\right)} \int_{t_{0}}^{t_{0}+\tau}\left(f\left(s, \mathbf{x}, \mathbf{u}_{1}, \Phi_{2}\left[\mathbf{u}_{1}\right]\right)+\frac{\partial v}{\partial t}(s, \mathbf{x})+\nabla v(s, \mathbf{x}) \cdot g\left(s, \mathbf{x}, \mathbf{u}_{1}, \Phi_{2}\left[\mathbf{u}_{1}\right]\right)\right) \mathrm{d} s

Theorem 4.6. Let us consider the problem (4.1) with the assumptions 1. and 2. Let us suppose that the Isaacs' condition 4.25) holds. Then
a. the problem (4.1) has value function $V$, i.e. (4.16) is always an equality;
b. $V$ is the unique viscosity solution of (4.64);

Proof. The proof of $a$. and $b$. of this theorem is an easy consequence of Theorem 4.5 with the Isaacs's condition.

As we said at the beginning of this section, we have given the results of this section for open-loop strategies but they are also true for more general problems and feedback strategies. The main result is in the previous theorem: if the Isaacs' condition 4.25 holds, then the problem has value function and satisfies the Isaacs' equation (4.64).

### 4.3 Regular solutions of Isaacs' equation for general problems

In the previous section we discussed the details of the upper and lower value functions, their regularity and relations with respect to the upper e lower Isaacs' equation and with a particular type of open-loop strategies. In this section we are interested to study the case where the Isaacs' condition holds, the feedback strategies are considered and the value function exists and it is regular.
Definition 4.8. Let us consider the problem (4.1). The lower value function $V^{-}:[0, T] \times \mathbb{R}^{n} \rightarrow$ $[-\infty,+\infty]$ is defined by

Similarly, the upper value function $V^{+}:[0, T] \times \mathbb{R}^{n} \rightarrow[-\infty,+\infty]$ is defined by

Note that $V^{-}$and $V^{+}$admits the values $\pm \infty$ since now we have no particular assumptions on our problem (4.1).

As in the open-loop strategies case and for the same reasons (see (4.16)), for every $(\tau, \boldsymbol{\xi})$ we have $V^{-}(\tau, \boldsymbol{\xi}) \leq V^{+}(\tau, \boldsymbol{\xi})$. We say, as in Definition 4.4, that the problem (4.1) admits value function $V$ if

&=\min _{\mathbf{v}_{2} \in U_{2}} \max _{\mathbf{v}_{1} \in U_{1}}\left(f\left(t, \mathbf{x}, \mathbf{v}_{1}, \mathbf{v}_{2}\right)+\nabla_{\mathbf{x}} V(t, \mathbf{x}) \cdot g\left(t, \mathbf{x}, \mathbf{v}_{1}, \mathbf{v}_{2}\right)\right)  \tag{4.67}\\
&=\max _{\mathbf{v}_{1} \in U_{1}} \min _{\mathbf{v}} \in U_{2} \\
&\left(f\left(t, \mathbf{x}, \mathbf{v}_{1}, \mathbf{v}_{2}\right)+\nabla_{\mathbf{x}} V(t, \mathbf{x}) \cdot g\left(t, \mathbf{x}, \mathbf{v}_{1}, \mathbf{v}_{2}\right)\right)
\end{align*}

Then $\left(\mathbf{u}_{1}^{*}, \mathbf{u}_{2}^{*}\right)$ is a Nash equilibrium for the game 4.1) in the class of feedback strategy. In particular

J\left(\mathbf{u}_{1}^{*}, \mathbf{u}_{2}^{*}\right)=\int_{0}^{T} f\left(t, \mathbf{x}^{*}, \mathbf{u}_{1}^{*}, \mathbf{u}_{2}^{*}\right) \mathrm{d} t+\psi\left(\mathbf{x}^{*}(T)\right) \geq \int_{0}^{T} f\left(t, \mathbf{x}, \mathbf{u}_{1}, \mathbf{u}_{2}^{*}\right) \mathrm{d} t+\psi(\mathbf{x}(T))=J\left(\mathbf{u}_{1}, \mathbf{u}_{2}^{*}\right)
$$

for every $\left(\mathbf{u}_{1}, \mathbf{u}_{2}^{*}\right) \in \mathcal{A}_{F B}$. A similar argument proves that

$$
J\left(\mathbf{u}_{1}^{*}, \mathbf{u}_{2}^{*}\right) \leq J\left(\mathbf{u}_{1}^{*}, \mathbf{u}_{2}\right)
$$

for every $\left(\mathbf{u}_{1}^{*}, \mathbf{u}_{2}\right) \in \mathcal{A}_{F B}$. Hence we have that $\left(\mathbf{u}_{1}^{*}, \mathbf{u}_{2}^{*}\right)$ is a Nash equilibrium in the family of feedback strategies.

Now, it is obvious that,

$$
\sup _{\mathbf{u}_{1}} J\left(\mathbf{u}_{1}, \mathbf{u}_{2}\right) \geq J\left(\mathbf{u}_{1}^{*}, \mathbf{u}_{2}\right)
$$

for every $\mathbf{u}_{2}$; hence

$$
\inf _{\mathbf{u}_{2}} \sup _{\mathbf{u}_{1}} J\left(\mathbf{u}_{1}, \mathbf{u}_{2}\right) \geq \inf _{\mathbf{u}_{2}} J\left(\mathbf{u}_{1}^{*}, \mathbf{u}_{2}\right) .
$$

Now, the previous inequality, the definition of lower value function $V^{-}$in 4.65) and the fact that $\left(\mathbf{u}_{1}^{*}, \mathbf{u}_{2}^{*}\right)$ is a Nash equilibrium imply

$$
V^{-}(0, \boldsymbol{\alpha})=\inf _{\mathbf{u}_{2}} \sup _{\mathbf{u}_{1}} J\left(\mathbf{u}_{1}, \mathbf{u}_{2}\right) \geq \inf _{\mathbf{u}_{2}} J\left(\mathbf{u}_{1}^{*}, \mathbf{u}_{2}\right)=J\left(\mathbf{u}_{1}^{*}, \mathbf{u}_{2}^{*}\right)
$$

A similar argument gives $V^{+}(0, \boldsymbol{\alpha}) \leq J\left(\mathbf{u}_{1}^{*}, \mathbf{u}_{2}^{*}\right)$. Relation 4.16) gives 4.68).
Finally, if we replace the initial data $\mathbf{x}(0)=\boldsymbol{\alpha}$ in the game with the new initial data $\mathbf{x}(\tau)=\boldsymbol{\xi}$, then the same proof gives that the game has value function $V$.

In the assumption of Theorem 4.7 we have that

$$
\begin{equation*}
V(0, \boldsymbol{\alpha})=J\left(\mathbf{u}_{1}^{*}, \mathbf{u}_{2}^{*}\right) \tag{4.73}
\end{equation*}
$$

Lewin devotes the section 3.2 of his book [14] to the definitions of the optimal strategies and the value function of a differential game using, as a matter of fact, equality 4.73) to define the value function.

Clearly, in the assumptions of Theorem 4.1 and Theorem 4.7, we know that

$$
\begin{equation*}
\nabla_{\mathbf{x}} V\left(t, \mathbf{x}^{*}(t)\right)=\boldsymbol{\lambda}^{*}(t) \tag{4.74}
\end{equation*}
$$

for every $t \in[0, T]$.

## A geometric proof of Isaacs' equation as necessary condition

We are interested to give a very different proof of the Isaacs' equation 4.64, based on geometric ideas. In particular, let us consider a different version of the problem 4.1) with $f=0$ and $T$ free: more precisely let us consider

$$
\left\{\begin{array}{c}
\text { Player I: } \max _{\mathbf{u}_{1}} J\left(\mathbf{u}_{1}, \mathbf{u}_{2}\right), \quad \text { Player II: } \min _{\mathbf{u}_{2}} J\left(\mathbf{u}_{1}, \mathbf{u}_{2}\right)  \tag{4.75}\\
J\left(\mathbf{u}_{1}, \mathbf{u}_{2}\right)=\psi\left(T_{\mathbf{x}}, \mathbf{x}\left(T_{\mathbf{x}}\right)\right) \\
\dot{\mathbf{x}}=g\left(t, \mathbf{x}, \mathbf{u}_{1}, \mathbf{u}_{2}\right) \\
\mathbf{x}(0)=\boldsymbol{\alpha} \\
\left(T_{\mathbf{x}}, \mathbf{x}\left(T_{\mathbf{x}}\right)\right) \in \mathcal{T}
\end{array}\right.
$$

where the control sets $U_{i}$ are closed, $\mathcal{T} \subset[0, \infty) \times \mathbb{R}^{n}$ is a closed target set and $T_{\mathbf{x}}$ is the exit time of $\mathbf{x}$ defined as in (1.6), i.e.

$$
T_{\mathbf{x}}=\inf \{t \geq 0:(t, \mathbf{x}(t)) \in \mathcal{T}\}
$$

Let us recall that $\mathcal{G}$ is the game set, i.e. if $(\tau, \boldsymbol{\xi}) \in \mathcal{G}$ then there exists a trajectory $\mathbf{x}$ which transfers the initial point $(\tau, \boldsymbol{\xi})$ in a point $\left(T_{\mathbf{x}}, \mathbf{x}\left(T_{\mathbf{x}}\right)\right) \in \mathcal{T}$, and that $\mathcal{T} \subset \mathcal{G}$.

It is clear that the definition of the value functions $V^{-}$and $V^{+}$is a simple modification of Definition $4.8^{2}$

Theorem 4.8. Let us consider the problem 4.75) with $g$ and $\psi$ continuous, with a closed target set $\mathcal{T}$ and game set $\mathcal{G}$. Let $(0, \boldsymbol{\alpha}) \in \mathcal{G} \backslash \mathcal{T}$. Let us suppose that
i. the Isaacs' condition holds; in this case we have

$$
\begin{equation*}
H_{D P}(t, \mathbf{x}, \boldsymbol{\lambda})=\max _{\mathbf{u}_{1} \in U_{1}} \min _{\mathbf{u}_{2} \in U_{2}} \boldsymbol{\lambda} \cdot g\left(t, \mathbf{x}, \mathbf{u}_{1}, \mathbf{u}_{2}\right)=\min _{\mathbf{u}_{2} \in U_{2}} \max _{\mathbf{u}_{1} \in U_{1}} \boldsymbol{\lambda} \cdot g\left(t, \mathbf{x}, \mathbf{u}_{1}, \mathbf{u}_{2}\right) ; \tag{4.76}
\end{equation*}
$$

ii. the problem has value function $V$, with $V \in C^{1}(\mathcal{G} \backslash \mathcal{T})$ and $\nabla V(t, \mathbf{x})=\left(\frac{\partial V}{\partial t}(t, \mathbf{x}), \nabla_{\mathbf{x}} V(t, \mathbf{x})\right) \neq 0$ for $\operatorname{all}(t, \mathbf{x}) \in \mathcal{G} \backslash \mathcal{T}$.

Let us consider a Nash equilibrium $\left(\mathbf{u}_{1}^{*}, \mathbf{u}_{2}^{*}\right)$ for the problem 4.75) in the class of feedback strategy, i.e. $\mathbf{u}_{i}^{*}(t)=\boldsymbol{\nu}_{i}^{*}\left(t, \mathbf{x}^{*}(t)\right)$, where $\mathbf{x}^{*}$ is the corresponding trajectory with $\mathbf{x}^{*}(0)=\boldsymbol{\alpha}$ and exit time $T_{\mathbf{x}^{*}}=T^{*}$. Then $V$ satisfies the Isaacs's equation (4.64) along the optimal path; more precisely,

$$
\left\{\begin{array}{l}
\frac{\partial V}{\partial t}\left(t, \mathbf{x}^{*}(t)\right)+H_{D P}\left(t, \mathbf{x}^{*}(t), \nabla_{\mathbf{x}} V\left(t, \mathbf{x}^{*}(t)\right)\right)=0 \quad \forall t \in\left[0, T^{*}\right)  \tag{4.77}\\
V\left(T^{*}, \mathbf{x}\left(T^{*}\right)\right)=\psi\left(T^{*}, \mathbf{x}\left(T^{*}\right)\right)
\end{array}\right.
$$

Proof. Let us consider a Nash equilibrium $\left(\mathbf{u}_{1}^{*}, \mathbf{u}_{2}^{*}\right) \in \mathcal{A}_{F B}$ and its optimal trajectory $\mathbf{x}^{*}$ with exit time $T^{*}$ for the problem 4.75): clearly we have

$$
\mathbf{x}^{*}(0)=\boldsymbol{\alpha}, \quad\left(T^{*}, \mathbf{x}^{*}\left(T^{*}\right)\right) \in \partial \mathcal{T}
$$

[^7]The final condition in 4.77) is obvious. Moreover, for every $\tau \in\left[0, T^{*}\right]$ fixed, if we consider the new problem 4.75 with the new initial data

$$
\mathbf{x}(\tau)=\mathbf{x}^{*}(\tau)
$$

the new optimal trajectory coincides, by the Bellman's principle, with $\mathbf{x}^{*}$ (the idea of the proof coincides with the classical situation of an optimal control problem). Hence, for every $\tau \in\left[0, T^{*}\right]$,

V\left(\tau, \mathbf{x}^{*}(\tau)\right)=\psi\left(T^{*}, \mathbf{x}^{*}\left(T^{*}\right)\right)=c
$$

where $c$ is a constant. Clearly we obtain

$$
\begin{equation*}
\frac{\mathrm{d} V\left(t, \mathbf{x}^{*}(t)\right)}{\mathrm{d} t}=\frac{\partial V}{\partial t}\left(t, \mathbf{x}^{*}(t)\right)+\nabla_{\mathbf{x}} V\left(t, \mathbf{x}^{*}(t)\right) \cdot \mathbf{x}^{*}(t)=0, \quad \forall t \in\left[0, T^{*}\right) \tag{4.78}
\end{equation*}
$$

Let us consider the curve $\gamma:\left[0, T^{*}\right] \rightarrow \mathcal{G}$, defined by $\gamma(t)=$ $\left(t, \mathbf{x}^{*}(t)\right)$, i.e. the optimal path: clearly $V(\gamma(t))=c$ for every $t \in\left[0, T^{*}\right]$. Since $\nabla V(t, \mathbf{x}) \neq 0$, the Dini's theorem guarantees that locally the curve $\gamma$ divides the set $\mathcal{G} \backslash \mathcal{T}$ in two different regions where $V(t, \mathbf{x})>c$ and $V(t, \mathbf{x})<c$.
Now fix $t \in\left[0, T^{*}\right)$ and consider the point $P=\left(t, \mathbf{x}^{*}(t)\right)$. In such point $P$, the function $V$ has the maximum growth in the direction of the vector


$$
\nabla V(\gamma(t))=\left(\frac{\partial V}{\partial t}\left(t, \mathbf{x}^{*}(t)\right), \nabla_{\mathbf{x}} V\left(t, \mathbf{x}^{*}(t)\right)\right)
$$

Since the Player I wants to maximizes, he wishes to move $P$ in such direction; but he has some "constraints" for the movements of the point $P$, i.e. on the trajectory, given by the dynamics and the choice of the Player II. Hence, if the Player II choices $\mathbf{u}_{2}^{*}(t)=\boldsymbol{\nu}_{2}^{*}\left(t, \mathbf{x}^{*}(t)\right)$, then Player I considers its strategy such that

$$
\begin{equation*}
\mathbf{u}_{1}^{*}(t)=\boldsymbol{\nu}_{1}^{*}\left(t, \mathbf{x}^{*}(t)\right) \in \arg \max _{\mathbf{u}_{1} \in U_{1}}\left[\left(\frac{\partial V}{\partial t}\left(t, \mathbf{x}^{*}(t)\right), \nabla_{\mathbf{x}} V\left(t, \mathbf{x}^{*}(t)\right)\right) \cdot \mathbf{w}\right] \tag{4.79}
\end{equation*}
$$

where $\mathbf{w}$ is a vector which depends on $t, \mathbf{x}^{*}(t), \mathbf{u}_{1}$ and $\mathbf{u}_{2}^{*}(t)$. Since $\mathbf{x}^{*}$ is the optimal trajectory, we know that the "best" direction $\mathbf{w}$ in the problem 4.79 is $\mathbf{w}=\frac{\mathrm{d} P}{\mathrm{~d} t}=\left(1, \dot{\mathbf{x}}^{*}(t)\right)$ (in the points $t$ where $\dot{\mathbf{x}^{*}}(t)$ exists); using the dynamics we obtain

$$
\begin{align*}
\mathbf{u}_{1}^{*}(t) & \in \arg \max _{\mathbf{u}_{1} \in U_{1}}\left(\frac{\partial V}{\partial t}\left(t, \mathbf{x}^{*}(t)\right)+\nabla_{\mathbf{x}} V\left(t, \mathbf{x}^{*}(t)\right) \cdot g\left(t, \mathbf{x}^{*}(t), \mathbf{u}_{1}, \mathbf{u}_{2}^{*}(t)\right)\right) \\
& =\arg \max _{\mathbf{u}_{1} \in U_{1}}\left(\nabla_{\mathbf{x}} V\left(t, \mathbf{x}^{*}(t)\right) \cdot g\left(t, \mathbf{x}^{*}(t), \mathbf{u}_{1}, \mathbf{u}_{2}^{*}(t)\right)\right) \tag{4.80}
\end{align*}
$$

Since the Player II wants to minimize, with similar arguments we obtain

$$
\begin{equation*}
\mathbf{u}_{2}^{*}(t)=\boldsymbol{\nu}_{2}^{*}\left(t, \mathbf{x}^{*}(t)\right) \in \arg \min _{\mathbf{u}_{2} \in U_{2}}\left(\nabla_{\mathbf{x}} V\left(t, \mathbf{x}^{*}(t)\right) \cdot g\left(t, \mathbf{x}^{*}(t), \mathbf{u}_{1}^{*}(t), \mathbf{u}_{2}\right)\right) \tag{4.81}
\end{equation*}
$$

Now, by 4.78 and the dynamics, we have

$$
\begin{align*}
0 & =\frac{\partial V}{\partial t}\left(t, \mathbf{x}^{*}(t)\right)+\nabla_{\mathbf{x}} V\left(t, \mathbf{x}^{*}(t)\right) \cdot \mathbf{x}^{*}(t) \\
& =\frac{\partial V}{\partial t}\left(t, \mathbf{x}^{*}(t)\right)+\nabla_{\mathbf{x}} V\left(t, \mathbf{x}^{*}(t)\right) \cdot g\left(t, \mathbf{x}^{*}(t), \mathbf{u}_{1}^{*}(t), \mathbf{u}_{2}^{*}(t)\right)  \tag{4.82}\\
(\text { by 4.80) }) & =\frac{\partial V}{\partial t}\left(t, \mathbf{x}^{*}(t)\right)+\max _{\mathbf{u}_{1} \in U_{1}}\left(\nabla_{\mathbf{x}} V\left(t, \mathbf{x}^{*}(t)\right) \cdot g\left(t, \mathbf{x}^{*}(t), \mathbf{u}_{1}, \mathbf{u}_{2}^{*}(t)\right)\right)  \tag{4.83}\\
(\text { by 4.81) }) & =\frac{\partial V}{\partial t}\left(t, \mathbf{x}^{*}(t)\right)+\min _{\mathbf{u}_{2} \in U_{2}}\left(\nabla_{\mathbf{x}} V\left(t, \mathbf{x}^{*}(t)\right) \cdot g\left(t, \mathbf{x}^{*}(t), \mathbf{u}_{1}^{*}(t), \mathbf{u}_{2}\right)\right), \tag{4.84}
\end{align*}
$$

for a.e. $t \in\left[0, T^{*}\right)$. Let us conclude the proof using the Isaacs' condition; for every fixed $t$, let us introduce the function

$$
\begin{equation*}
\widetilde{h}_{t}\left(\mathbf{u}_{1}, \mathbf{u}_{2}\right)=\nabla_{\mathbf{x}} V\left(t, \mathbf{x}^{*}(t)\right) \cdot g\left(t, \mathbf{x}^{*}(t), \mathbf{u}_{1}, \mathbf{u}_{2}\right) \tag{4.85}
\end{equation*}
$$

The equalities (4.82)-4.84) give that

$$
\begin{equation*}
\widetilde{h}_{t}\left(\mathbf{u}_{1}^{*}(t), \mathbf{u}_{2}^{*}(t)\right)=\max _{\mathbf{u}_{1} \in U_{1}} \widetilde{h}_{t}\left(\mathbf{u}_{1}, \mathbf{u}_{2}^{*}(t)\right)=\min _{\mathbf{u}_{2} \in U_{2}} \widetilde{h}_{t}\left(\mathbf{u}_{1}^{*}(t), \mathbf{u}_{2}\right) . \tag{4.86}
\end{equation*}
$$

If we show that

$$
\begin{equation*}
\widetilde{h}_{t}\left(\mathbf{u}_{1}^{*}(t), \mathbf{u}_{2}^{*}(t)\right)=\max _{\mathbf{u}_{1} \in U_{1}} \min _{\mathbf{u}_{2} \in U_{2}} \widetilde{h}_{t}\left(\mathbf{u}_{1}, \mathbf{u}_{2}\right)=\min _{\mathbf{u}_{2} \in U_{2}} \max _{\mathbf{u}_{1} \in U_{1}} \widetilde{h}_{t}\left(\mathbf{u}_{1}, \mathbf{u}_{2}\right) \tag{4.87}
\end{equation*}
$$

we obtain $0=\frac{\partial V}{\partial t}\left(t, \mathbf{x}^{*}(t)\right)+H_{D P}\left(t, \mathbf{x}^{*}(t), \nabla_{\mathbf{x}} V\left(t, \mathbf{x}^{*}(t)\right)\right)$ and the proof is finished (note that in 4.87) the second equality is true by the Isaacs' condition). In order to do that, let us notice that

$$
\begin{aligned}
& \widetilde{h}_{t}\left(\mathbf{u}_{1}^{*}(t), \mathbf{u}_{2}^{*}(t)\right)=4 \max _{\mathbf{u}_{1} \in U_{1}} \widetilde{h}_{t}\left(\mathbf{u}_{1}, \mathbf{u}_{2}^{*}(t)\right) \\
& \geq \min _{\mathbf{u}_{2} \in U_{2}} \max _{\mathbf{u}_{1} \in U_{1}} \widetilde{h}_{t}\left(\mathbf{u}_{1}, \mathbf{u}_{2}\right) \\
&=4.76 \\
& \max _{\mathbf{u}_{1} \in U_{1}} \min _{\mathbf{u}_{2} \in U_{2}} \widetilde{h}_{t}\left(\mathbf{u}_{1}, \mathbf{u}_{2}\right) \\
& \geq \min _{\mathbf{u}_{2} \in U_{2}} \widetilde{h}_{t}\left(\mathbf{u}_{1}^{*}(t), \mathbf{u}_{2}\right) \\
&=4.86 \\
& T_{t}\left.\mathbf{u}_{1}^{*}(t), \mathbf{u}_{2}^{*}(t)\right),
\end{aligned}
$$

Hence, all the previous inequalities are equalities and the first equality in 4.87) holds.

### 4.3.1 Examples

Example 4.3.1. (see [2]) Let us consider the two-person zero-sum game

\text { Player I: } \max _{u_{1}} J\left(u_{1}, u_{2}\right), \quad \text { Player II: } \min _{u_{2}} J\left(u_{1}, u_{2}\right) \\
J\left(u_{1}, u_{2}\right)=\frac{1}{2} \int_{0}^{2}\left(u_{2}^{2}-u_{1}^{2}\right) \mathrm{d} t+\frac{1}{2} x(2)^{2} \\
\dot{x}=\sqrt{2} u_{2}-u_{1} \\
x(0)=x_{0}
\end{array}\right.
$$

First, it is easy to show that the Isaacs' condition holds:

$$
\begin{equation*}
H_{D P}^{-}(t, x, \lambda)=\max _{u_{1} \in \mathbb{R}}\left(-\frac{1}{2} u_{1}^{2}-\lambda u_{1}\right)+\min _{u_{2} \in \mathbb{R}}\left(\frac{1}{2} u_{2}^{2}+\sqrt{2} \lambda u_{2}\right)=H_{D P}^{+}(t, x, \lambda) . \tag{4.88}
\end{equation*}
$$

Hence we can define the Hamiltonian of Dynamic Programming $H_{D P}$ : in order to do that, note that

$$
\begin{equation*}
u_{1}^{*}=-\lambda^{*}, \quad u_{2}^{*}=-\sqrt{2} \lambda^{*} \tag{4.89}
\end{equation*}
$$

realize the max and min in respectively and hence $H_{D P}(t, x, \lambda)=-\frac{1}{2} \lambda^{2}$. Hence there exists the value function $V$ that solves the Isaacs' equation

$$
\begin{cases}\frac{\partial V}{\partial t}(t, x)-\frac{1}{2}\left(\frac{\partial V}{\partial x}(t, x)\right)^{2}=0 & \text { for }(t, x) \in[0,2] \times \mathbb{R}  \tag{4.90}\\ V(2, x)=\frac{1}{2} x^{2} & \text { for } x \in \mathbb{R}\end{cases}
$$

Since we are considering an Affine-Quadratic problem, we looking for a value function of the type 2.18), i.e. $V(t, x)=$ $\frac{1}{2} Z(t) x^{2}+W(t) x+Y(t):$ replacing such $V$ in 4.90 we obtain

$$
\begin{gather*}
\dot{Z} x^{2}+2 \dot{W} x+2 \dot{Y}-(Z x+W)^{2}=0, \quad \forall(t, x) \in[0,2] \times \mathbb{R} \\
\Rightarrow \dot{Z}=Z^{2}  \tag{4.91}\\
\dot{W}=Z W  \tag{4.92}\\
2 \dot{Y}=W^{2}  \tag{4.93}\\
V(2, x)=\frac{1}{2} Z(2) x^{2}+W(2) x+Y(2)=\frac{1}{2} x^{2}, \quad \forall x \in \mathbb{R} \\
\Rightarrow Z(2)=1, \quad W(2)=Y(2)=0 \tag{4.94}
\end{gather*}
$$

Easy computations give: by 4.91 and $4.94, Z(t)=\frac{1}{3-t}$; by 4.92 and $4.94, W(t)=0$; finally, by 4.93 and 4.94 ,
$Y(t)=0$, $Y(t)=0$. Hence we obtain the value function

$$
V(t, x)=\frac{1}{2(3-t)} x^{2} .
$$

Now, relation 4.74) gives $\lambda^{*}(t)=\frac{1}{3-t} x^{*}(t)$, where $x^{*}$ is the optimal trajectory; 4.89) gives

$$
\begin{equation*}
u_{1}^{*}(t)=-\frac{1}{3-t} x^{*}(t), \quad u_{2}^{*}(t)=-\frac{\sqrt{2}}{3-t} x^{*}(t) \tag{4.95}
\end{equation*}
$$

Hence we are in the position to find a feedback strategy. Using this expression for the control ( $u_{1}, u_{2}$ ), the dynamics gives

$$
\dot{x}^{*}=-\frac{x^{*}}{3-t}
$$

together with the initial condition $x(0)=x_{0}$, we obtain $x^{*}=x_{0} \frac{3-t}{3}$. This implies that $\left(u_{1}^{*}, u_{2}^{*}\right)$ in 4.95) is a feedback Nash equilibrium.

### 4.4 Pursuit-evasion games

Let

$$
\mathcal{T}=\mathbb{R}^{+} \times \mathcal{T}_{0} \subset \mathbb{R}^{+} \times \mathbb{R}^{n}
$$

be a target set, with $\mathcal{T}_{0}$ closed. Let as denote by $\mathcal{G} \subset \mathbb{R}^{+} \times \mathbb{R}^{n}$ the game set, i.e. the set where the trajectories lie, $(t, \mathbf{x}(t)) \in \mathcal{G}$.

We investigate a situation in which the first player tries to maintain the state of the system as long as possible outside to a target set $\mathcal{T}$ while the second player aims reaching $\mathcal{T}$ as soon as possible. For this reasons, in all this section, the first player, who chooses $\mathbf{u}_{1}$, is called Pursuer, which we shall abbreviate by $P$; the second player, who chooses $\mathbf{u}_{2}$, is called Evader, which we shall abbreviate by $E$.
We consider an autonomous problem, i.e. a situation where $f, g$ and $\psi$ do not depend directly on $t$, and we are looking for Nash equilibrium in the family of feedback strategies.. For every $\left(\mathbf{u}_{1}, \mathbf{u}_{2}\right) \in \mathcal{A}_{F B}$, where $\mathbf{u}_{i}(t)=\boldsymbol{\nu}_{i}(t, \mathbf{x}(t))$, with the corresponding $\mathbf{x}$ via

$$
\dot{\mathbf{x}}=g\left(\mathbf{x}, \boldsymbol{\nu}_{1}(t, \mathbf{x}), \boldsymbol{\nu}_{2}(t, \mathbf{x})\right), \quad \mathbf{x}(0)=\boldsymbol{\alpha}

such that $(0, \boldsymbol{\alpha}) \in \mathcal{G} \backslash \mathcal{T}$, the exit time in (1.6) is

if the initial data on the trajectory $\mathbf{x}$ is $\mathbf{x}(\tau)=\boldsymbol{\xi}$, with $(\tau, \boldsymbol{\xi}) \in \mathcal{G} \backslash \mathcal{T}$, then the definition of its exit time is $T_{\mathbf{x}}=\inf \left\{t \geq \tau: \mathbf{x}(t) \in \mathcal{T}_{0}\right\}$.


We are interested in the game

$$
\left\{\begin{array}{cc}
\text { Pursuer: } \min _{\mathbf{u}_{1}} J\left(\mathbf{u}_{1}, \mathbf{u}_{2}\right), & \text { Evader: } \max _{\mathbf{u}_{2}} J\left(\mathbf{u}_{1}, \mathbf{u}_{2}\right)  \tag{4.97}\\
\mathbf{u}_{1}(t) \in U_{1}, & \mathbf{u}_{2}(t) \in U_{2} \\
J\left(\mathbf{u}_{1}, \mathbf{u}_{2}\right)=\int_{0}^{T_{\mathbf{x}}} f\left(\mathbf{x}, \mathbf{u}_{1}, \mathbf{u}_{2}\right) \mathrm{d} t+\psi\left(\mathbf{x}\left(T_{\mathbf{x}}\right)\right) \\
\dot{\mathbf{x}}=g\left(\mathbf{x}, \mathbf{u}_{1}, \mathbf{u}_{2}\right) \\
\mathbf{x}(0)=\boldsymbol{\alpha}, \quad(0, \boldsymbol{\alpha}) \in \mathcal{G} \backslash \mathcal{T} \\
\mathbf{x}\left(T_{\mathbf{x}}\right) \in \mathcal{T}_{0} &
\end{array}\right.
$$

where the control sets $U_{i}$ are closed and $T_{\mathbf{x}}$ is the exit time of the trajectory $\mathbf{x}$. Note that in the PursuitEvasion games the first Player (P) would like to have a min, while (E) wishes to have a max; this notation is in honor of Isaacs and it is exactly as in his book [11 (see page 201). Clearly, all the results of the previous sections hold with easy modifications.

Here we have that $H_{D P}^{-}$and $H_{D P}^{+}$do not depend on $t$. For this type of problems we have the following properties:
Proposition 4.1. Let us consider the game 4.97) with $f, g$ and $\psi$ continuous, and with $\mathcal{T}_{0}$ closed. Then
i. the lower $V^{-}$value function does not depend explicitly on $t$ in the game set $\mathcal{G}$, i.e.

iii. if the lower value function $V^{-}$is in $C^{1}\left(\operatorname{int}\left(\mathcal{G}_{0} \backslash \mathcal{T}_{0}\right)\right)$, then the lower Isaacs' equation 4.47) becomes

Similar results in i. and iii. hold for $V^{+}$.

where in the previous line $\left(\mathbf{u}_{1}, \mathbf{u}_{2}\right) \in \mathcal{A}_{F B}$, with $\mathbf{u}_{i}(t)=\boldsymbol{\nu}_{i}(t, \mathbf{x}(t))$, and the corresponding $\mathbf{x}$ solution of of the ODE

For every such $\left(\mathbf{u}_{1}, \mathbf{u}_{2}\right) \in \mathcal{A}_{F B}$, let us consider $\widetilde{\boldsymbol{\nu}}_{i}(s, \mathbf{x})=\boldsymbol{\nu}_{i}(\tau+s, \mathbf{x})$ for every $\mathbf{x} \in \mathbb{R}^{n}$ and $s \geq 0$. Since $g$ does not depends on $t$, the unique solution $\widetilde{\mathbf{x}}$ of the ODE

is $\widetilde{\mathbf{x}}(s)=\mathbf{x}(\tau+s)$. Hence we consider $\left(\widetilde{\mathbf{u}}_{1}, \widetilde{\mathbf{u}}_{2}\right) \in \mathcal{A}_{F B}$, with $\widetilde{\mathbf{u}}_{i}(t)=\widetilde{\boldsymbol{\nu}}_{i}(t, \widetilde{\mathbf{x}}(t))$. Since $\mathcal{T}=\mathbb{R}^{+} \times \mathcal{T}_{0}$, it is easy to see that

for every $\left(\mathbf{u}_{1}, \mathbf{u}_{2}\right)$ as before. This implies $V^{-}(\tau, \boldsymbol{\xi})=V^{-}(0, \boldsymbol{\xi})$, for every $\tau>0$. This proves $i$. and the arguments of this proof imply easily $i i$.

The assumption $V^{-} \in C^{1}\left(\operatorname{int}\left(\mathcal{G}_{0} \backslash \mathcal{T}_{0}\right)\right)$ and relation 44.98) give $\frac{\partial V^{-}}{\partial t}(t, \mathbf{x})=0$. Now, since the problem is autonomous, $H_{D P}^{-}$does not depend explicitly by $t$ and we obtain, by the lower Isaacs' equation 4.47),

The final condition $V^{-}(\tau, \boldsymbol{\xi})=\psi(\boldsymbol{\xi})$, for every $(\tau, \boldsymbol{\xi}) \in \mathcal{T}$, follows by $i$..
The next result is an easy consequence of the previous proposition.

and the value function $V$ is in $C^{1}\left(\operatorname{int}\left(\mathcal{G}_{0} \backslash \mathcal{T}_{0}\right)\right)$, then $V$ does not depend explicitly on $t$. Moreover the Isaacs, equation 4.64) becomes

Theorem 4.7 for our pursuit-evasion game has a new statement:
Theorem 4.9. Let us consider the game (4.97) with $f, g$ and $\psi$ continuous, and with $\mathcal{T}_{0}$ closed. Let us suppose that the Isaacs' condition is satisfied. Let us suppose that there exists a function $V: \mathcal{G}_{0} \rightarrow \mathbb{R}$ in $C^{1}\left(\mathcal{G}_{0} \backslash \mathcal{T}_{0}\right)$ such that solves the Isaacs' equation (4.100).
$\operatorname{Let}\left(\mathbf{u}_{1}^{*}, \mathbf{u}_{2}^{*}\right) \in \mathcal{A}_{F B}$, where $\mathbf{u}_{i}^{*}(t)=\boldsymbol{\nu}_{i}^{*}\left(\mathbf{x}^{*}(t)\right)$, with the corresponding trajectory $\mathbf{x}^{*}$ with $\mathbf{x}^{*}(0)=\boldsymbol{\alpha}$ and exit time $T_{\mathbf{x}^{*}}$, be such that $\left(\boldsymbol{\nu}_{1}^{*}(\mathbf{x}), \boldsymbol{\nu}_{2}^{*}(\mathbf{x})\right)$ realizes, for every $\mathbf{x}$, the max-min in the Isaacs equation, i.e.

for every $\mathbf{x} \in \operatorname{int}\left(\mathcal{G}_{0} \backslash \mathcal{T}_{0}\right)$. Then $\left(\mathbf{u}_{1}^{*}, \mathbf{u}_{2}^{*}\right)$ is a Nash equilibrium.
We note that in our pursuit-evasion games 4.97), the feedback strategies $\left(\mathbf{u}_{1}, \mathbf{u}_{2}\right) \in \mathcal{A}_{F B}$ are such that $\mathbf{u}_{i}(t)=\boldsymbol{\nu}_{i}(\mathbf{x}(t))$ with $\boldsymbol{\nu}_{i}$ which depends only on $\mathbf{x}$, i.e. we looking for stationary feedback strategies. Finally, along the optimal trajectory 4.101) becomes

### 4.4.1 The lady in the lake

The following games is in [2]. A lady ( $E=$ Evader) is swimming in a circular lake (of radius $R$ ) with a velocity $\overrightarrow{v L}(t)$ such that $v_{L}(t)=v_{L}$ is constant and $v_{L}<1$; she can change the direction in which she swims instantaneously. Hence the lady controls the direction of its velocity, i.e. she controls the angular velocity $u_{L}$ with respect to the radius $\overline{C E}$, without any restriction.

A man ( $P=$ Pursuer $)$ is not a swimmer and he wishes to intercept the lady when she reaches the shore; he is in the beach of the lake and can run along the perimeter with velocity $\overrightarrow{u_{M}}(t)$ which is tangent to the circumference. He also can change his direction instantaneously; hence the man controls the signed modulo $u_{M}$, i.e. $\left|u_{M}(t)\right| \leq 1$, where $u_{M}>0\left(u_{M}<0\right)$ implies that the man runs clockwise (counter-clockwise) around the lake.
We assume that the lady and the man never get tired. $E$ doesn't stay in the lake forever and she wishes to come out without being caught by the man; in the land, $E$ can run faster than $P$. $E$ 's goal is to maximize the pay-off, which is the angular distance $\theta$ viewed from the center $C$ of the lake, at the time $E$ reaches to the store. $P$ obviously wants minimize such pay-off.
In order to describe the system, we introduce the angular distance $\theta=$ $\theta(t)$, i.e. the angle between $P$ and $E$ with respect to the center $C$ in a clockwise sense: we consider $-\pi \leq \theta(t) \leq \pi$ and the identification $\pi \simeq-\pi$. The $E$ 's distance with respect to the center of the lake is $r=r(t)$. The dynamics of the game (we left to the reader the details) is


$$
\begin{align*}
\dot{\theta} & =\frac{v_{L} \sin u_{L}}{r}-\frac{u_{M}}{R}  \tag{4.103}\\
\dot{r} & =v_{L} \cos u_{L} \tag{4.104}
\end{align*}
$$

The pay-off function is $|\theta(T)|$, where $T=T_{(\theta, r)}$ is the exit time of the trajectory $(\theta, r)$, as in 4.96), by

T=\inf \left\{t \geq 0:(\theta(t), r(t)) \in \mathcal{T}_{0}\right\}
$$

where $\mathcal{T}$ is the target set of the game, $\mathcal{T}=\mathbb{R}^{+} \times \mathcal{T}_{0}$ with $\mathcal{T}_{0}=$ $[-\pi, \pi] \times[R, \infty)($ and $\pi \simeq-\pi)$. We are in a pursuit-evasion game as in 4.97). Proposition 4.1 implies that the game set $\mathcal{G}$ for our problem is $\mathcal{G}=\mathbb{R}^{+} \times \mathcal{G}_{0}$ : let us note that for every $\left(r_{0}, \theta_{0}\right)$ with $r_{0} \geq 0$ and $\theta_{0} \in[-\pi, \pi]$ the pair $\left(u_{M}, u_{L}\right)=(0,0)$ in the dynamics implies the trajectory $r(t)=r_{0}+t v_{L}$ and $\theta(t)=\theta_{0}$ for every $t \geq 0$ : it is clear that for some $t$ the trajectory reaches in the target set: hence

Hence we have the pursuit-evasion game

with $T$ free. Let us looking for a Nash equilibrium $\left(u_{M}^{*}, u_{L}^{*}\right)$ for this game in the family of (stationary) feedback strategies, where

u_{M}^{*}(t)=\nu_{M}^{*}\left(\theta^{*}(t), r^{*}(t)\right), \quad u_{L}^{*}(t)=\nu_{L}^{*}\left(\theta^{*}(t), r^{*}(t)\right) \tag{4.105}

with the associated trajectory $\left(\theta^{*}, r^{*}\right)$ and the exit time $T^{*}$ given by $T^{*}=\inf \left\{t \geq 0:\left(\theta^{*}(t), r^{*}(t)\right) \in \mathcal{T}_{0}\right\}$. In order to do that, we apply Theorem 4.9. The Hamiltonian $H=H\left(\theta, r, u_{M}, u_{L}, \lambda_{1}, \lambda_{2}\right)$ is

For the upper and lower Hamiltonians of Dynamic Programming we have

& =\min _{\left|u_{M}\right| \leq 1}\left\{-\frac{\lambda_{1}}{R} u_{M}\right\}+\max _{u_{L}}\left\{\frac{v_{L} \sin u_{L}}{r} \lambda_{1}+\lambda_{2} v_{L} \cos u_{L}\right\} \\
& =\max _{u_{L}} \min _{\left|u_{M}\right| \leq 1} H\left(\theta, r, u_{M}, u_{L}, \lambda_{1}, \lambda_{2}\right) \\
& =H_{D P}^{-}\left(\theta, r, \lambda_{1}, \lambda_{2}\right)
\end{aligned}

Hence the Isaacs' condition is satisfied and, by Proposition 4.1, we are in the position to looking for a value function $V$ that does not depend on $t$, i.e. $V=V(\theta, r)$; let us notice that the existence and the regularity
of such $V$ is not guaranteed since the dynamics is not bounded and Lipschitz w.r.t. $r$ (see Theorem 4.6). The Isaacs' equation 4.100 is

We can apply the variational approach for the open-loop representation of the feedback Nash equilibrium $\left(u_{M}^{*}, u_{L}^{*}\right)$ (see Theorem 4.2). Taking into account that (see 4.74)) $\lambda_{1}^{*}=V_{\theta}^{*}$ and $\lambda_{2}^{*}=V_{r}^{*}$ along the optimal trajectory $t \mapsto\left(\theta^{*}(t), r^{*}(t)\right)$ and for the time $t$ such that $V$ is sufficiently regular in the point $\left(\theta^{*}(t), r^{*}(t)\right)$, the adjoint equation gives

& \dot{\lambda}_{2}^{*}=-\frac{\partial H}{\partial r} \quad \Rightarrow \quad \frac{\mathrm{~d}}{\mathrm{~d} t} V_{r}^{*}(t)=V_{\theta}^{*}(t) \frac{v_{L} \sin \left(u_{L}^{*}(t)\right)}{\left(r^{*}(t)\right)^{2}}=k \frac{v_{L} \sin \left(u_{L}^{*}(t)\right)}{\left(r^{*}(t)\right)^{2}} \tag{4.108}
\end{align*}
$$

where $k$ is a constant.
First, let us suppose that for some time $t$ on the optimal trajectory we have ${ }^{4}$

 has a strategy-decision $\nu_{L}^{*}$ such that $\left|\theta^{*}(t)\right|=\pi$, i.e she can always move herself into a position diametrically opposite from $P$. In fact, in this situation the Lady can achieve a large angular velocity $w_{L}$ (with respect to the center C) than the angular velocity $w_{M}$ of the Man; we note

Clearly inside the circumference of radius $v_{L} R$, for every strategy-decision $\nu_{M}^{*}$ of the Man, the Lady can consider a strategy-decision $\nu_{L}^{*}$ in order to stay in a situation where $\theta^{*}(t)= \pm \pi$; hence $\dot{\theta}^{*}=0$ and $w_{L}=w_{M}$. These last relations and (4.113) give the Nash equilibrium and its trajectory

At this point is clear that for every initial every initial data-position $\left(\theta_{0}, r_{0}\right)$, with $r_{0}<R v_{L}$, the Lady can choose first the strategy $u_{L}(t)=-\pi$ in order to move herself to the center of the lake, and after the strategy (4.114) to move herself into a position diametrically opposite from the Man, reaching the points ( $\pm \pi, R v_{L}$ ). This proves that the value function $V$ is constant in $r<R v_{L}$.

An example of the situation $r(t)<v_{L} R$ : Let us suppose that the Man starts at the North pole of the circumference and runs in the clockwise sense with maximal velocity, i.e. $u_{M}^{*}=1$. Let us denote by $M(t)$ the position of the Man at the time $t$, we have (see the blue curve in the picture)

Note that $|\dot{M}|=1$ and clearly $M$ describes an arc of circumference in a clockwise sense of amplitude $\pi / 2$. Let us denote by $L(t)$ the position of the Lady at time $t$ : 4.115 gives

It is easy to verify that the modulo of the velocity of the Lady is exactly $v_{L}$ and that $L$ describes an half circumference of center $\left(-r V_{L} / 2,0\right)$ and radius $r V_{L} / 2$ in a clockwise sense.
-๑ Let us study the situation $\mathbf{r}^{*}(\mathbf{t}) \geq \mathbf{v}_{\mathbf{L}} \mathbf{R}$. Since the lady doesn't stay in the lake forever, let us define $T_{0}$ as

& =-\frac{1}{v_{L}} \sqrt{1-v_{L}^{2}}+\arccos v_{L} .

comes from $\lim _{x \rightarrow 0^{+}} y(x)=-\infty, y(1)=\pi$ and $y^{\prime}=\frac{\sqrt{1-x^{2}}}{x^{2}} \geq 0$. Hence there exists a value $v_{L}^{*} \in(0,1)$ such that for $v_{L} \in\left(v_{L}^{*}, 1\right)$ relation 4.120 holds. In this case the Lady sure will not be caught by the Man.

** In the case $\operatorname{sgn}\left(\theta^{*}\left(T^{*}\right)\right)=0$, the Lady sure will be caught by the Man.
$\bullet \bullet$ Let us construct the trajectory related to the $\operatorname{Nash}$ equilibrium in $\mathbf{r}^{*}(\mathbf{t}) \geq \mathbf{v}_{\mathbf{L}} \mathbf{R}$.
THE CASE $v_{L}>v_{L}^{*}$. Let us suppose that $\theta^{*}\left(T_{0}\right)=\pi$ : hence $\theta^{*}(t)>0$ in $\left[T_{0}, T^{*}\right]$. Equation 4.117) gives

Since the Lady cannot stay for ever in the lake, she will arrive at some time $T^{*}$ in the land. Similar calculations hold for $\theta^{*}\left(T_{0}\right)=-\pi$ (note that $\left.u_{M}^{*}(t)=-1\right)$.

### 4.5 Pursuit-evasion game of kind

We consider a situation similar to section 4.4, but now the functional $J$ takes only a finite number of values: these type of pursuit-evasion games are called games of kind. The theory of these type of games is very wide and here we would like to give some ideas, in some particular situations (see for example [14] for more details).

Let us consider the problem in 4.97). Here we consider a closed target set $\mathcal{T}=\mathbb{R}^{+} \times \mathcal{T}_{0} \subset \mathcal{G}$, with $\operatorname{int}\left(\mathcal{T}_{0}\right) \neq \emptyset$, such that $\partial \mathcal{T}_{0}$ is a $(n-1)$-dimensional surface in $C^{1}$, i.e.

$$
\partial \mathcal{T}_{0}=\left\{\mathbf{x} \in \mathcal{G}_{0} \subset \mathbb{R}^{n}: h(\mathbf{x})=0\right\},
$$

where $h: \mathcal{G}_{0} \rightarrow \mathbb{R}$ is a function in $C^{1}$. For every $\mathbf{x} \in \partial \mathcal{T}_{0}$, let us denote by $\mathbf{n}(\mathbf{x}) \in \mathbb{R}^{n}$ the outward normal of $\mathcal{T}_{0}$ at $\mathbf{x}$; clearly $\mathbf{n}(\mathbf{x}) \| \nabla h(\mathbf{x})$.
In this game, the Evader $(E)$ tries to prevent the state-trajectory from reaching into the interior of $\mathcal{T}_{0}$, whereas the Pursuer $(P)$ seeks the opposite. We assign numerical values to the outcomes $J$ in 4.97) for the trajectory $\mathbf{x}$ associated to the strategy $\left(\mathbf{u}_{1}, \mathbf{u}_{2}\right) \in \mathcal{A}_{F B}$, where $\mathbf{u}_{i}(t)=\boldsymbol{\nu}_{i}(\mathbf{x}(t))$ :

- -1 for termination of the game or capture, i.e. the trajectory $\mathrm{x} \operatorname{arrives} \operatorname{in} \operatorname{int}\left(\mathcal{T}_{0}\right)$;
- +1 for no termination of the game or escape, i.e. the trajectory $\mathbf{x}$ never $\operatorname{arrives} \operatorname{in} \operatorname{int}\left(\mathcal{T}_{0}\right)$.

Hence we are interested in the game

$$
\left\{\begin{array}{cl}
\text { Pursuer: } \min _{\mathbf{u}_{1}} J\left(\mathbf{u}_{1}, \mathbf{u}_{2}\right), & \text { Evader: } \max _{\mathbf{u}_{2}} J\left(\mathbf{u}_{1}, \mathbf{u}_{2}\right)  \tag{4.123}\\
\mathbf{u}_{1} \in U_{1} & \mathbf{u}_{2} \in U_{2} \\
& J\left(\mathbf{u}_{1}, \mathbf{u}_{2}\right)= \begin{cases}-1 & \text { if } \exists t \geq 0 \text { s.t. } \mathbf{x}(t) \in \operatorname{int}\left(\mathcal{T}_{0}\right) \\
+1 & \text { otherwise } \\
\dot{\mathbf{x}}=g\left(\mathbf{x}, \mathbf{u}_{1}, \mathbf{u}_{2}\right) \\
& \mathbf{x}(0)=\boldsymbol{\alpha}\end{cases}
\end{array}\right.
$$

with $g$ continuous function and $(0, \boldsymbol{\alpha}) \in \mathcal{G}$ fixed. For our game the Hamiltonian is

Let us suppose for this problem that the Isaacs' condition is satisfied.
It is clear that the definition of the value functions $V^{-}$and $V^{+}$is a simple modification of Definition $4.8{ }^{6}{ }^{6}$ It is clear that in this problem the regularity assumption in 1 . does not hold and, despite the Isaacs' assumption holds, it is not possible to guarantee that there exists the value function $V$. However we can define $V^{-}$and $V^{+}$and, exactly as in $i .-i i$. of Proposition 4.1 we have
Remark 4.5. For the game (4.123) we have that:

[^11]Definition 4.10. Let us consider the problem 4.123). The lower value function $V^{-}:[0, \infty) \times \mathbb{R}^{n} \rightarrow[-\infty,+\infty]$ is defined by

where $T_{\mathbf{x}}=\inf \left\{t \geq \tau: \mathbf{x}(t) \in \operatorname{int}\left(\mathcal{T}_{0}\right)\right\}$ is the exit time. Similarly, the upper value function $V^{+}:[0, \infty) \times \mathbb{R}^{n} \rightarrow[-\infty,+\infty]$ is defined by

i. the lower value functions $V^{-}$and the upper value function $V^{+}$do not depend on $t$;
ii. the game set is $\mathcal{G}=\mathbb{R}^{+} \times \mathcal{G}_{0}$.

Since the "solution" of the game does not depend on the time, the most interesting question is to study which initial points of $\mathcal{G}_{0}$ lead to a termination of the game and which are not. In order to do that, let us classify the points of the set $\mathcal{G}_{0}$ :

States of capture, states of escape in $\mathcal{G}_{0} \backslash \operatorname{int}\left(\mathcal{T}_{0}\right)$.
Definition 4.11. Let us consider the game (4.123). Let $\mathbf{x}_{0} \in \mathcal{G}_{0} \backslash \operatorname{int}\left(\mathcal{T}_{0}\right)$. We say that

- $\mathbf{x}_{0}$ is a state of termination (or to capture) if the first Player $(P)$ has a strategy-control $\overline{\mathbf{u}}_{1}$, i.e. a decision rule $\overline{\boldsymbol{\nu}}_{1}=\overline{\boldsymbol{\nu}_{1}}(\mathbf{x})$, such that for every acts-strategy $\mathbf{u}_{2}$ of the second Player $(E)$, i.e. for every decision rule $\boldsymbol{\nu}_{2}=\boldsymbol{\nu}_{2}(\mathbf{x})$, the trajectory $]^{7}$ can be steered to the interior of the target set: we denote by $\mathcal{C}_{a p}$ the set of all the states of capture;
- $\mathbf{x}_{0}$ is a state of no-termination (or to escape) if $(E)$ has a strategy-control such that for every actsstrategy of $(P)$ the trajectory can be steered outside to int $\left(\mathcal{T}_{0}\right)$ forever: we denote by $\mathcal{E}_{\text {sc }}$ the set of all the states of escape.

Let us prove the following:
Remark 4.6. If is $\mathbf{x} \in \mathcal{C}_{a p}$, then $V^{-}(\mathbf{x})=V^{+}(\mathbf{x})=-1$. If is $\mathbf{x} \in \mathcal{E}_{s c}$, then $V^{-}(\mathbf{x})=V^{+}(\mathbf{x})=+1$.
Proof. Let $\boldsymbol{\xi}$ be a state of capture. Then there exists a control $\widetilde{\mathbf{u}}_{1}$ for the first Player such that for every $\mathbf{u}_{2}$ such that $\left(\widetilde{\mathbf{u}}_{1}, \mathbf{u}_{2}\right) \in \mathcal{A}_{F B}$, with trajectory $\mathbf{x}$ which starts from $\boldsymbol{\xi}$, we have $J\left(\widetilde{\mathbf{u}}_{1}, \mathbf{u}_{2}\right)=-1$. This implies that

J\left(\widetilde{\mathbf{u}}_{1}, \mathbf{u}_{2}\right)=-1, \quad \forall\left(\widetilde{\mathbf{u}}_{1}, \mathbf{u}_{2}\right) \in \mathcal{A}_{F B}

Now, let $\boldsymbol{\xi}$ be a state of escape. Then there exists a control $\widetilde{\mathbf{u}}_{2}$ such that for every $\mathbf{u}_{1}$ such that $\left(\mathbf{u}_{1}, \widetilde{\mathbf{u}}_{2}\right) \in \mathcal{A}_{F B}$, with trajectory $\mathbf{x}$ which starts from $\boldsymbol{\xi}$, we have $J\left(\mathbf{u}_{1}, \widetilde{\mathbf{u}}_{2}\right)=+1$. This implies that

J\left(\mathbf{u}_{1}, \widetilde{\mathbf{u}}_{2}\right)=1, \quad \forall\left(\mathbf{u}_{1}, \widetilde{\mathbf{u}}_{2}\right) \in \mathcal{A}_{F B}
$$

Hence, by 4.16 and by definition,

1 \geq V^{+}(\boldsymbol{\xi}) \geq V^{-}(\boldsymbol{\xi})=\inf _{\boldsymbol{\nu}_{1}} \sup _{\boldsymbol{\nu}_{2}} J\left(\boldsymbol{\nu}_{1}, \mathbf{u}_{1}\right) \geq \inf _{\boldsymbol{\nu}_{1}} J\left(\boldsymbol{\nu}_{1}, \widetilde{\mathbf{u}}_{2}\right)=1
$$

Now we are in the position to define, with an abuse of language, a sort of value function

$$
V: \mathcal{C}_{a p} \cup \mathcal{E}_{s c} \rightarrow\{-1,+1\}
$$

The most interesting situation, of course, is the one in which $\mathcal{G}_{0}$ contains both capture and escape states. It is clear that the value function $V$ is discontinuous and the theory of the previous sections is not useful.

[^12]and hence $\overline{\mathbf{u}}_{1}(t)=\overline{\boldsymbol{\nu}}_{1}(\mathbf{x}(t)), \mathbf{u}_{2}(t)=\boldsymbol{\nu}_{2}(\mathbf{x}(t))$.

## Usable part in $\partial \mathcal{T}_{0}$.

At this point a natural question is to investigate which points of the boundary of the target set are candidate to be a state of termination for the game. We have the following:
Definition 4.12. Let us consider the game (4.123) and let us assume that the Isaacs' condition is satisfied. We define the usable part, that we will denote by $\mathcal{U P}$, as

\begin{equation*}
\mathcal{U P}=\left\{\mathbf{x} \in \partial \mathcal{T}_{0}: \min _{\mathbf{u}_{1} \in U_{1}} \max _{\mathbf{u}_{2} \in U_{2}} \mathbf{n}(\mathbf{x}) \cdot g\left(\mathbf{x}, \mathbf{u}_{1}, \mathbf{u}_{2}\right)=\max _{\mathbf{u}_{2} \in U_{2}} \min _{\mathbf{u}_{1} \in U_{1}} \mathbf{n}(\mathbf{x}) \cdot g\left(\mathbf{x}, \mathbf{u}_{1}, \mathbf{u}_{2}\right) \leq 0\right\} \tag{4.125}
\end{equation*}
$$

The points of the usable part are candidate to be termination for the game. If strict inequality holds in 4.125 for some $\mathbf{x}$, then it is a state of termination, i.e. $\mathbf{x} \in \mathcal{C}_{a p}$, and it penetrates in $\mathcal{T}_{0}$; to be clear, if for some controls $\left(\mathbf{u}_{1}, \mathbf{u}_{2}\right)$ and for some time $t$, the trajectory $\mathbf{x}$ associated to such controls arrives at time $t$ in a point of this type, then $\dot{\mathbf{x}}(t)=g\left(\mathbf{x}(t), \mathbf{u}_{1}(t), \mathbf{u}_{2}(t)\right)$ gives the direction of the trajectory in the point $\mathbf{x}(t)$; since $\mathbf{n}(\mathbf{x}(t)) \cdot \dot{\mathbf{x}}(t)<0$, then the trajectory enters in $\operatorname{int}\left(\mathcal{T}_{0}\right)$.
The points x for which equality holds in 4.125 may be only touching points.

## The barrier and its construction.

We now are in the position to introduce the most important "object" that allows us to study our problem: the barrier. It is the set that separates the state of capture to the state of escape:

Definition 4.13. We define the barrier $\mathcal{B}_{a r}$ the set in $\mathcal{G}_{0} \backslash \operatorname{int}\left(\mathcal{T}_{0}\right)$ by

$$
\mathcal{B}_{a r}=\partial \mathcal{C}_{a p} \cap \partial \mathcal{E}_{s c}
$$

The boundary of the usable part, that we will denote by $\mathcal{B U P}$, is the set

$$
\mathcal{B U P}=\mathcal{U P} \cap \mathcal{B}_{a r}
$$

It is clear that the barrier can be a very irregular set. Let us introduce the following two assumptions:
Assumption. Let us assume that $\mathcal{B}_{\text {ar }}$ is non empty and

- (smoothness) the barrier is a $C^{2}$ surface, i.e. $\mathcal{B}_{a r}=\{\mathbf{x}: \quad b(\mathbf{x})=0\}$, with $b \in C^{2}$ such that

$$
\begin{equation*}
\mathbf{p}(\mathbf{x})=\nabla b(\mathbf{x}) \tag{4.126}
\end{equation*}
$$

is the outward normal of $\mathcal{C}_{a p}$ in the point $\mathbf{x}$; moreover we assume that

$$
\mathbf{x} \in \mathcal{B}_{a r} \quad \Longrightarrow \quad \mathbf{x} \notin \mathcal{C}_{a p} \cup \mathcal{E}_{s c}
$$

- (naturality) the curve from which the barrier starts is $\mathcal{B U \mathcal { P }}$, i.e. the boundary of the usable part.


A natural barrier: for every point $\mathbf{x}_{0}$ in $\mathcal{B U \mathcal { P }}$, we have $\mathbf{p}\left(\mathbf{x}_{0}\right)=\mathbf{n}\left(\mathbf{x}_{0}\right)$ (as we will see in 4.138).

If we are able to construct the barrier, then we would also have found $\mathcal{C}_{a p}$ and $\mathcal{E}_{s c}$ and, as a result, we solve the game.

A first result in the direction to construct $\mathcal{B}_{a r}$ requires this definition:
Definition 4.14. Let us consider the game (4.123) and let us assume that the Isaacs' condition is satisfied. Let $A \subset \mathcal{G}_{0}$ be a regular surface, i.e. with

$$
A=\left\{\mathbf{x} \in \mathcal{G}_{0} \subset \mathbb{R}^{n}: a(\mathbf{x})=0\right\}
$$

where $a: \mathcal{G}_{0} \rightarrow \mathbb{R}$ is a function in $C^{1}$, and such that $\mathbf{a}(\mathbf{x}) \in \mathbb{R}^{n}$ is the normal in the point $\mathbf{x}$ to $A$ (clearly $\mathbf{a}(\mathbf{x}) \| \nabla a(\mathbf{x}))$. We say that $A$ is a semipermeable surface if

\min _{\mathbf{u}_{1} \in U_{1}} \max _{\mathbf{u}_{2} \in U_{2}} \mathbf{a}(\mathbf{x}) \cdot g\left(\mathbf{x}, \mathbf{u}_{1}, \mathbf{u}_{2}\right)=\max _{\mathbf{u}_{2} \in U_{2}} \min _{\mathbf{u}_{1} \in U_{1}} \mathbf{a}(\mathbf{x}) \cdot g\left(\mathbf{x}, \mathbf{u}_{1}, \mathbf{u}_{2}\right)=0 .
$$

The property of the barrier is the following:
Proposition 4.2. Let us assume that, for the game 4.123), the Isaacs' condition is satisfied, $g$ is a continuous function with continuous derivative with respect to $\mathbf{x}$, and the barrier $\mathcal{B}_{\text {ar }}$ is non empty and smooth. Then the barrier is a semipermeable surface, i.e. for every $\mathbf{x} \in \mathcal{B}_{a r}$ we have

$$
\begin{equation*}
\min _{\mathbf{u}_{1} \in U_{1}} \max _{\mathbf{u}_{2} \in U_{2}} \mathbf{p}(\mathbf{x}) \cdot g\left(\mathbf{x}, \mathbf{u}_{1}, \mathbf{u}_{2}\right)=\max _{\mathbf{u}_{2} \in U_{2}} \min _{\mathbf{u}_{1} \in U_{1}} \mathbf{p}(\mathbf{x}) \cdot g\left(\mathbf{x}, \mathbf{u}_{1}, \mathbf{u}_{2}\right)=0 \tag{4.127}
\end{equation*}
$$

Proof. Let us consider $\mathbf{x}_{0} \in \mathcal{B}_{a r}$; let $\beta$ be the value of the previous max $-\min$ (equal to the $\min -\max$ ) in such point $\mathbf{x}_{0}$ : we have to prove that $\beta=0$.
Let us assume that $\beta<0$, i.e.

$$
\max _{\mathbf{u}_{2} \in U_{2}} \min _{\mathbf{u}_{1} \in U_{1}} \mathbf{p}\left(\mathbf{x}_{0}\right) \cdot g\left(\mathbf{x}_{0}, \mathbf{u}_{1}, \mathbf{u}_{2}\right)=\beta:
$$

this implies that for every point $\mathbf{u}_{2} \in U_{2}$ there exists a point $\mathbf{u}_{1}^{\mathbf{u}_{2}} \in U_{1}$ such that

$$
\begin{equation*}
\mathbf{p}\left(\mathbf{x}_{0}\right) \cdot g\left(\mathbf{x}_{0}, \mathbf{u}_{1}^{\mathbf{u}_{2}}, \mathbf{u}_{2}\right) \leq \beta . \tag{4.128}
\end{equation*}
$$

Now, for every point $\mathbf{x} \in \mathcal{C}_{a p}$, let us denote by $\widehat{\mathbf{u}}_{1}^{\mathbf{x}}$ the strategy of $(P)$ such that for every acts of $(E)$ the trajectory can be steered from $\mathbf{x}$ into $\operatorname{int}\left(\mathcal{T}_{0}\right)$.


In the point $\mathbf{x}_{0} \in \mathcal{B}_{\text {ar }}$. If for every point $\mathbf{u}_{2} \in U_{2}$ there exists a point $\mathbf{u}_{1}^{\mathbf{u}_{2}} \in U_{1}$ such that 4.128) holds, for every choice-strategy of the second Player $(E)$ then the first Player $(P)$ have a control-strategy to "force" the trajectory $\widetilde{\mathbf{x}}$ from $\mathcal{B}_{\text {ar }}$ into $\mathcal{C}_{\text {ap }}$ following (locally) the direction $\dot{\mathbf{x}}(0)=g\left(\widetilde{\mathbf{x}}_{0}(0), \mathbf{u}_{1}^{\mathbf{u}_{2}}, \mathbf{u}_{2}\right)$.

For every strategy $\mathbf{u}_{2}$ of the second Player $(E)$, i.e. a decision rule $\boldsymbol{\nu}_{2}=\boldsymbol{\nu}_{2}(\mathbf{x}): \mathbb{R}^{n} \rightarrow U_{2}$, let us consider the strategy $\mathbf{u}_{1}^{\mathbf{u}_{2}}$ for the first Player $(P)$ defined by the decision rule $\boldsymbol{\nu}_{1}^{\mathbf{u}_{2}}=\boldsymbol{\nu}_{1}^{\mathbf{u}_{2}}(\mathbf{x}): \mathbb{R}^{n} \rightarrow U_{1}$ with $\boldsymbol{\nu}_{1}^{\mathbf{u}_{2}}(\mathbf{x})=\mathbf{u}_{1}^{\nu_{2}\left(\mathbf{x}_{0}\right)}$, for every $\mathbf{x}$ (where $\mathbf{u}_{1}^{\nu_{2}\left(\mathbf{x}_{0}\right)}$ is as in 4.128). Let $\varepsilon=\varepsilon\left(\mathbf{u}_{2}\right)>0$ be such that there exists the unique solution $\widetilde{\mathbf{x}}$ of the ODE

$$
\left\{\begin{array}{l}
\dot{\tilde{\mathbf{x}}}(t)=g\left(\widetilde{\mathbf{x}}(t), \boldsymbol{\nu}_{1}^{\mathbf{u}_{2}}(\widetilde{\mathbf{x}}(t)), \boldsymbol{\nu}_{2}(\widetilde{\mathbf{x}}(t))\right) \quad \text { in }[0, \varepsilon) \\
\widetilde{\mathbf{x}}(0)=\mathbf{x}_{0}
\end{array}\right.
$$

Let us notice that $g$ in continuous with continuous derivative with respect to $\mathbf{x}$ (we are not interested to discuss the details in order to guarantee that such local solution $\widetilde{\mathbf{x}}$ there exists). Relation (4.128) implies $\widetilde{\mathbf{x}}(\epsilon) \in \mathcal{C}_{a p}$, for every strategy $\mathbf{u}_{2}$ of the second Player $(E)$. Now the first Player $(P)$ consider the strategy $\widehat{\mathbf{u}}_{1}^{\widetilde{\mathbf{x}}(\epsilon)}$ which transfers the point $\widetilde{\mathbf{x}}(\epsilon)$ into $\operatorname{int}\left(\mathcal{T}_{0}\right)$ : this implies that $\mathbf{x}_{0} \in \mathcal{C}_{a p}$, which contradicts the smoothness assumption on the barrier. Hence $\beta$ cannot be negative. A similar proof shows that $\beta$ cannot be positive.

The fact that $\mathcal{B}_{a r}$ gives the property that without ( $P$ )'s cooperation, $(E)$ cannot make the state cross $\mathcal{B}_{a r}$ passing from a region where $V=-1$ to a region where $V=1$; and viceversa, without ( $E$ )'s cooperation, $(P)$ cannot make the state cross $\mathcal{B}_{a r}$ passing from a region where $V=+1$ to a region where $V=-1$. However we have to remark that the semipermeability condition in (4.127) does not exclude a "tangential" penetration.

Let us emphasize that relation (4.127) does not imply that, for every fixed $\mathrm{x} \in \mathcal{B}_{a r}$, there exists a pair $\left(\mathbf{u}_{1}^{*}, \mathbf{u}_{2}^{*}\right) \in U_{1} \times U_{2}$, with $\mathbf{u}_{1}^{*}$ and $\mathbf{u}_{2}^{*}$ that depend on $\mathbf{x}$, such that realizes the min-max in 4.127). The following notion is a further requirement on the barrier:
Definition 4.15. Let us consider the game $\sqrt{(4.123)}$ and let us assume that the Isaacs' condition is satisfied. We say that a function $\left(\boldsymbol{\nu}_{1}^{*}, \boldsymbol{\nu}_{2}^{*}\right): \mathcal{B}_{a r} \rightarrow U_{1} \times U_{2}$ is a barrier control for $\mathcal{B}_{a r}$ if for every $\mathbf{x} \in \mathcal{B}_{a r}$ we have that

$$
\begin{array}{lc}
\mathbf{p}(\mathbf{x}) \cdot g\left(\mathbf{x}, \boldsymbol{\nu}_{1}^{*}(\mathbf{x}), \mathbf{u}_{2}\right) \leq 0, & \forall \mathbf{u}_{2} \in U_{2} \\
\mathbf{p}(\mathbf{x}) \cdot g\left(\mathbf{x}, \mathbf{u}_{1}, \boldsymbol{\nu}_{2}^{*}(\mathbf{x})\right) \geq 0, & \forall \mathbf{u}_{1} \in U_{1} . \tag{4.130}
\end{array}
$$

Let us notice that the barrier control, in general, is not unique. The following remark shows the role of the barrier contro ${ }^{8}$

Remark 4.7. $\left(\boldsymbol{\nu}_{1}^{*}, \boldsymbol{\nu}_{2}^{*}\right)$ is a barrier control for $\mathcal{B}_{\text {ar }}$ if and only if, for every $\mathbf{x} \in \mathcal{B}_{\text {ar }}$, the pair $\left(\boldsymbol{\nu}_{1}^{*}(\mathbf{x}), \boldsymbol{\nu}_{2}^{*}(\mathbf{x})\right)$ realizes the min-max in 4.127), i.e.

$$
\begin{equation*}
\mathbf{p}(\mathbf{x}) \cdot g\left(\mathbf{x}, \boldsymbol{\nu}_{1}^{*}(\mathbf{x}), \boldsymbol{\nu}_{2}^{*}(\mathbf{x})\right)=\min _{\mathbf{u}_{1} \in U_{1}} \max _{\mathbf{u}_{2} \in U_{2}} \mathbf{p}(\mathbf{x}) \cdot g\left(\mathbf{x}, \mathbf{u}_{1}, \mathbf{u}_{2}\right)=\max _{\mathbf{u}_{2} \in U_{2}} \min _{\mathbf{u}_{1} \in U_{1}} \mathbf{p}(\mathbf{x}) \cdot g\left(\mathbf{x}, \mathbf{u}_{1}, \mathbf{u}_{2}\right)=0 . \tag{4.131}
\end{equation*}
$$

Proof. Let $\left(\boldsymbol{\nu}_{1}^{*}, \boldsymbol{\nu}_{2}^{*}\right)$ be a barrier control for $\mathcal{B}_{a r}$ and fix $\mathbf{x} \in \mathcal{B}_{a r}$. Clearly 4.129) implies

while (4.130) implies

\mathbf{p}(\mathbf{x}) \cdot g\left(\mathbf{x}, \boldsymbol{\nu}_{1}^{*}(\mathbf{x}), \boldsymbol{\nu}_{2}^{*}(\mathbf{x})\right) \geq 0 .
$$

Hence $\mathbf{p}(\mathbf{x}) \cdot g\left(\mathbf{x}, \boldsymbol{\nu}_{1}^{*}(\mathbf{x}), \boldsymbol{\nu}_{2}^{*}(\mathbf{x})\right)=0$ and, using (4.127), we have that $\left(\boldsymbol{\nu}_{1}^{*}(\mathbf{x}), \boldsymbol{\nu}_{2}^{*}(\mathbf{x})\right)$ realizes the min-max in (4.127).

Now let us suppose that, for $\mathbf{x} \in \mathcal{B}_{a r}$ fixed, the pair $\left(\boldsymbol{\nu}_{1}^{*}(\mathbf{x}), \boldsymbol{\nu}_{2}^{*}(\mathbf{x})\right)$ realizes the min-max in 4.127). Moreover, let us suppose that 4.129) is false, i.e. there exists $\overline{\mathbf{u}}_{2} \in U_{2}$ such that

\mathbf{p}(\mathbf{x}) \cdot g\left(\mathbf{x}, \boldsymbol{\nu}_{1}^{*}(\mathbf{x}), \overline{\mathbf{u}}_{2}\right)>0

Since $\boldsymbol{\nu}_{1}^{*}(\mathbf{x})$ realizes the min, we obtain

0 & <\mathbf{p}(\mathbf{x}) \cdot g\left(\mathbf{x}, \boldsymbol{\nu}_{1}^{*}(\mathbf{x}), \overline{\mathbf{u}}_{2}\right) \\
& \leq \max _{\mathbf{u}_{2} \in U_{2}} \mathbf{p}(\mathbf{x}) \cdot g\left(\mathbf{x}, \boldsymbol{\nu}_{1}^{*}(\mathbf{x}), \mathbf{u}_{2}\right) \\
& =\min _{\mathbf{u}_{1} \in U_{1}} \max _{\mathbf{u}_{2} \in U_{2}} \mathbf{p}(\mathbf{x}) \cdot g\left(\mathbf{x}, \mathbf{u}_{1}, \mathbf{u}_{2}\right)
\end{aligned}
$$

which contradicts 4.127 . This gives that 4.129 is true. A similar proof gives 4.130.

[^13]Let $\left(\boldsymbol{\nu}_{1}^{*}, \boldsymbol{\nu}_{2}^{*}\right)$ be a barrier control for $\mathcal{B}_{a r}$ (sufficiently regular), let us consider a point $\mathbf{x}_{0} \in \mathcal{B}_{a r}$ and the curve $\mathbf{x}:\left[0, t_{0}\right] \rightarrow \mathbb{R}^{n}$, for some $t_{0}>0$, defined by

Let x be a point in $\mathcal{B}_{a r}$. By 4.131 we have

If we consider the derivative w.r.t. $x_{j}$ of 4.133), we obtain

& =\sum_{k=1}^{k_{1}} \frac{\partial}{\partial u_{1, k}}\left(\mathbf{p}(\mathbf{x}) \cdot g\left(\mathbf{x}, \boldsymbol{\nu}_{1}^{*}(\mathbf{x}), \boldsymbol{\nu}_{2}^{*}(\mathbf{x})\right)\right) \frac{\partial \nu_{1, k}^{*}}{\partial x_{j}}(\mathbf{x})

since for our game the Hamiltonian is as in 4.124). Hence we have that the curve $\mathbf{x}=\mathbf{x}(t) \in \mathcal{B}_{a r}$ satisfies

Proposition 4.3. Let us consider the game (4.123) and let us assume that the Isaacs' condition is satisfied. The barrier $\mathcal{B}_{a r}$ is described by the function $\mathbf{x}=\mathbf{x}(t)$ which solves the system

where $\left(\boldsymbol{\nu}_{1}^{*}, \boldsymbol{\nu}_{2}^{*}\right)$ is a control barrier, $\mathbf{p}(\mathbf{x}) \in \mathbb{R}^{n}$ is the outward normal of $\mathcal{C}_{\text {ap }}$ in the point $\mathbf{x} \in \mathcal{B}_{\text {ar }}$ as in (4.126). Clearly $b(\mathrm{x}(t))=0$.

### 4.5.1 Interception of a straight flying evader

When can an interceptor be successful against a faster attacking craft which travels a fixed straight course? This model is in the book of Isaacs (see section 8.6 in [11]).

Here P moves in the plane with a motion and unit speed, while E is bound to a line moves with speed $w(w>0$ fixed $)$, and merely can select for his strategy one of the two possible directions of travel. Capture occurs when $|P E|<l$, where $l>0$ fixed. In view of P's unquestioned ability to capture when $w<1$, this case is trivial (please, solve it !). Our interest is in the conditions which make possible the success of a slower pursuer with $w>1$.
Let us pass to the details. The Pursuer $P$ is free to move itself in the half-plane $y \geq 0$ : the velocity is $\vec{v}(t)$ with modulo $v=1$, the angle of the velocity w.r.t. the $y$-axis (in the negative direction) is $\psi$. The Evader $E$, constrained on the $x$-axis, can only controls the direction $\varphi \in\{ \pm 1\}$ of the velocity is $\vec{w}(t)$, with modulo $w>1$ fixed.


The dynamics is

$$

\dot{y}=-\cos \psi
\end{array}\right.
$$

and the target set $\mathcal{T}=[0, \infty) \times \mathcal{T}_{0}$ is such that

The boundary of $\mathcal{T}_{0}$ is smooth and

We are in a pursuit-evasion game as in 4.123).
The game set is $\mathcal{G}=[0, \infty) \times \mathcal{G}_{0}$. In order to describe $\mathcal{G}_{0}$, let us fix $\left(x_{0}, y_{0}\right) \in \mathbb{R} \times \mathbb{R}^{+}$: it is easy to see that, first, choosing in the dynamics $\psi=0$, for every $\varphi$, we move $\left(x_{0}, y_{0}\right)$ to the point $\left(x_{1}, 0\right)$, for some $x_{1}$; secondly, choosing $\psi= \pm \pi / 2$ and $\varphi= \pm 1$ depending on $\operatorname{sgn}\left(x_{1}\right)$, the dynamics moves the point $\left(x_{1}, 0\right)$ to the origin $(0,0) \in \operatorname{int}\left(\mathcal{T}_{0}\right)$. Hence

Now, by noticing that $\mathcal{B}_{a r}$ "separates" the escape states $\mathcal{E}_{s c}$ to the capture states $\mathcal{C}_{a p}$ and that $\mathcal{U P} \backslash \mathcal{B U P}$ is inside $\mathcal{C}_{a p}$, in 4.142 we have only to consider the cass ${ }^{9} t k>0$.

The outward normal of $\mathcal{C}_{a p}$ along $\mathcal{B}_{a r}$ in the point $\mathbf{x}(t)=(x(t), y(t))$ in 4.142) is ${ }^{10}$

\begin{equation*}
\mathbf{p}(\mathbf{x}(t))=\left(p_{1}(x(t), y(t)), p_{2}(x(t), y(t))\right)=\left(\sin \alpha^{+}, \cos \alpha^{+}\right) ; \tag{4.143}
\end{equation*}

hence (see 4.126)) $b(x, y)=x \sin \alpha^{+}+y \cos \alpha^{+}-l=0$. In 4.141) we obtain

\end{array}\right.
$$

where $t_{0}$ and $t_{1}$ are fixed.

i) (Pontryagin Maximum Principle) for all $\tau \in\left[t_{0}, t_{1}\right]$ we have

\mathbf{u}^{*}(\tau) \in \arg \max _{\mathbf{v} \in U} H\left(\tau, \mathbf{x}^{*}(\tau), \mathbf{v}, \lambda_{0}^{*}, \lambda^{*}(\tau)\right) ;
$$

ii) (adjoint equation) in $\left[t_{0}, t_{1}\right]$ we have $\dot{\boldsymbol{\lambda}}^{*}=-\nabla_{\mathbf{x}} H\left(t, \mathbf{x}^{*}, \mathbf{u}^{*}, \boldsymbol{\lambda}^{*}\right)$;
iii) (transversality condition) $\boldsymbol{\lambda}^{*}\left(t_{1}\right)=\nabla_{\mathbf{x}} \psi\left(\mathbf{x}\left(t_{1}\right)\right)$;

A first sufficient condition is the following
Theorem A. 2 (Mangasarian). Let us consider the maximum problem A.1) with $f \in C^{1}$ and $g \in C^{1}$. Let the control set $U$ be convex. Let $\mathbf{u}^{*}$ be a normal extremal control, $\mathbf{x}^{*}$ the associated trajectory and $\boldsymbol{\lambda}^{*}=\left(\lambda_{1}^{*}, \ldots, \lambda_{n}^{*}\right)$ the associated multiplier (as in theorem A.1).
Consider the Hamiltonian function $H$ and let us suppose that
v) the function $(\mathbf{x}, \mathbf{u}) \mapsto H\left(t, \mathbf{x}, \mathbf{u}, \boldsymbol{\lambda}^{*}(t)\right)$ is, for every $t \in\left[t_{0}, t_{1}\right]$, concave.

Then $\mathbf{u}^{*}$ is optimal.
Another and useful sufficient condition is due to Arrow.
Theorem A. 3 (Arrow). Let us consider the maximum problem (A.1) with $f \in C^{1}$ and $g \in C^{1}$. Let $\mathbf{u}^{*}$ be a normal extremal control, $\mathbf{x}^{*}$ be the associated trajectory and $\boldsymbol{\lambda}^{*}$ be the associated multiplier.
Let us suppose that exists the maximized Hamiltonian function $H^{0}:\left[t_{0}, t_{1}\right] \times \mathbb{R}^{n} \times \mathbb{R}^{n} \rightarrow \mathbb{R}$ by

where $\boldsymbol{\alpha}$ and $\boldsymbol{\beta}=\left(\beta_{1}, \ldots, \beta_{n}\right)$ are fixed in $\mathbb{R}^{n}$. We give a sufficient condition in the spirit of the theorem of Mangasarian:
Theorem A.4. Let us consider the infinite horizon maximum problem (A.3) with $f \in C^{1}$ and $g \in C^{1}$. Let the control set $U$ be convex. Let $\mathbf{u}^{*}$ be a normal extremal control, $\mathbf{x}^{*}$ the associated trajectory and $\boldsymbol{\lambda}^{*}=\left(\lambda_{1}^{*}, \ldots, \lambda_{n}^{*}\right)$ the associated multiplier, i.e. the tern $\left(\mathbf{x}^{*}, \mathbf{u}^{*}, \boldsymbol{\lambda}^{*}\right)$ satisfies the PMP and the adjoint equation.
Suppose that
v) the function $(\mathbf{x}, \mathbf{u}) \mapsto H\left(t, \mathbf{x}, \mathbf{u}, \boldsymbol{\lambda}^{*}\right)$ is, for every $t \in\left[t_{0}, \infty\right)$, concave,
vi) for all admissible trajectory $\mathbf{x}$,

$$
\begin{equation*}
\lim _{t \rightarrow \infty} \boldsymbol{\lambda}^{*}(t) \cdot\left(\mathbf{x}(t)-\mathbf{x}^{*}(t)\right) \geq 0 . \tag{A.4}
\end{equation*}

Then $\mathbf{u}^{*}$ is optimal.

Let us define the current Hamiltonian $H^{c}$ as

H^{c}\left(t, \mathbf{x}, \mathbf{u}, \boldsymbol{\lambda}_{c}\right)=f(t, \mathbf{x}, \mathbf{u})+\boldsymbol{\lambda}_{c} \cdot g(t, \mathbf{x}, \mathbf{u}),
$$

where $\boldsymbol{\lambda}_{c}$ is the current multiplier. Clearly we obtain

& H^{c}=e^{r t} H  \tag{A.7}\\
& \boldsymbol{\lambda}_{c}^{*}=e^{r t} \boldsymbol{\lambda}^{*} .

\dot{\mathbf{x}}=g(t, \mathbf{x}, \mathbf{u}) \\
\mathbf{x}\left(t_{0}\right)=\boldsymbol{\alpha} \\
(T, \mathbf{x}(T)) \in S \\
\max _{\mathbf{u} \in \mathcal{C}_{0}, \boldsymbol{\alpha}} J(\mathbf{u})
\end{array}\right.
$$

with a control set $U \subset \mathbb{R}^{k}$, with the target set $S \subset\left(t_{0}, \infty\right) \times \mathbb{R}^{n}$. Let us consider the reachable set for the target set S defined by

R(S)=\left\{(\tau, \boldsymbol{\xi}): \mathcal{C}_{\tau, \boldsymbol{\xi}} \neq \emptyset\right\}

for every $\in\left[t_{0}, T^{*}\right]$. Then $\mathbf{u}^{*}$ is the optimal control with exit time $T^{*}$.
