

# European Union Capacity Building Mission in Somalia

## **EUCAP Somalia**

#### Mandate 1.1.2019-31.12.2020

**EUCAP Somalia enhances the country's maritime civilian law enforcement capacity** by supporting federal and regional authorities in developing legislation, strengthening the criminal justice chain in the maritime domain and providing advice on policy to the Somali ministry of internal security and the Somali Police Force. The Mission supports the development of coast guard and maritime police functions in and around the main Somali ports, and implements additional assistance to broader police development.

The Mission (then EUCAP Nestor) was launched in July 2012 to support countries in the Horn of Africa to develop maritime security. In December 2016, the Council of the European Union decided that the Mission will focus on Somalia, including Somaliland. In December 2018, EUCAP Somalia's mandate was extended until the end of 2020 with a budget of 66,1 Million Euros.

EUCAP Somalia is based in Mogadishu with field offices in Hargeisa (Somaliland), Garowe (Puntland), Mogadishu and a back-office in Nairobi, Kenya.

# Three pillars of EUCAP Somalia

- 1. Support the maritime police units in and around the ports (Berbera, Bosasso, Mogadishu, Kismayo)
- 2. Contribution to the development of the Somali Coast Guard
  - 3. Support to broader police development





### Head of Mission, Maria-Cristina Stepanescu

Before joining the Mission, Ms Stepanescu worked extensively in crisis management operations and senior positions in the Romanian Ministry of Interior, the European Union Police Mission in Bosnia and Herzegovina, United Nations Mission in Kosovo and as a Seconded National Expert/Police Expert to the European External Action Service (EEAS) in the Civilian Planning and Conduct Capability (CPCC), Operations Division.
